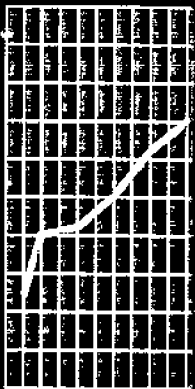

| ABOUT THIS PUBLICATION | The aim of this publication is to provide users with a range of the latest statistics available at the end of each month of issue. Consequently the dates and periods shown are not always the same for each table, but are in each case the latest figures available at that time. |
| SEASONAL ADJUSTMENT | Seasonal adjustment is a means of removing the estimated effects of normal seasonal variations from economic time series so the the effects of other influences are obvious. Seasonal variations are the systematic (though not necessarily regular) intra-year movements of economic time series. These are often the result of non-economic phenomena, such as climatic changes, and regular religious festivals e.g. Christmas and Easter. |
| TREND ESTIMATE | Smoothing seasonally adjusted series produces a measure of trend by removing the impact of the irregular component of the series. The trend estimates are derived by applying a 13-term Henderson weighted moving average to the respective seasonally adjusted series. Readers are reminded that trend estimates are subject to revision as subsequent months' data become available. |

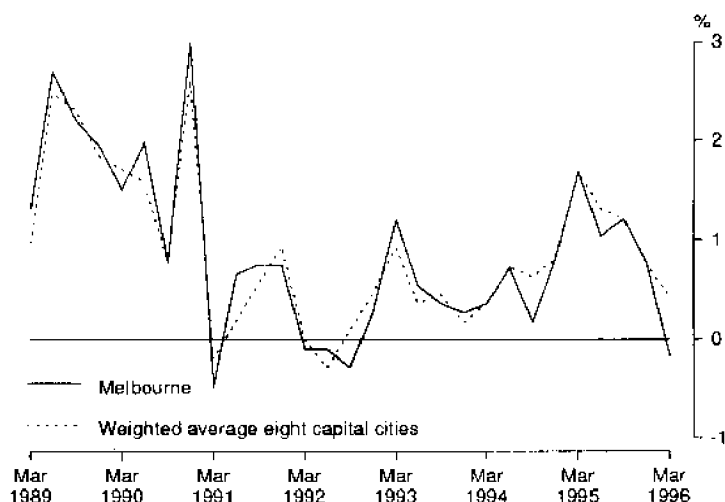
CONSUMER PRICE INDEX

The consumer price index for Victoria in the March quarter 1996 (118.3) decreased by 0.2% from the December quarter 1995 (118.5). It was 2.9% higher than in the March quarter of 1995.

For Australia the consumer price index in the March quarter 1996 (119.0) increased by 0.4% from the December quarter 1995 (118.5) but increased by 3.7% from the March quarter in 1995.

Change from previous quarter



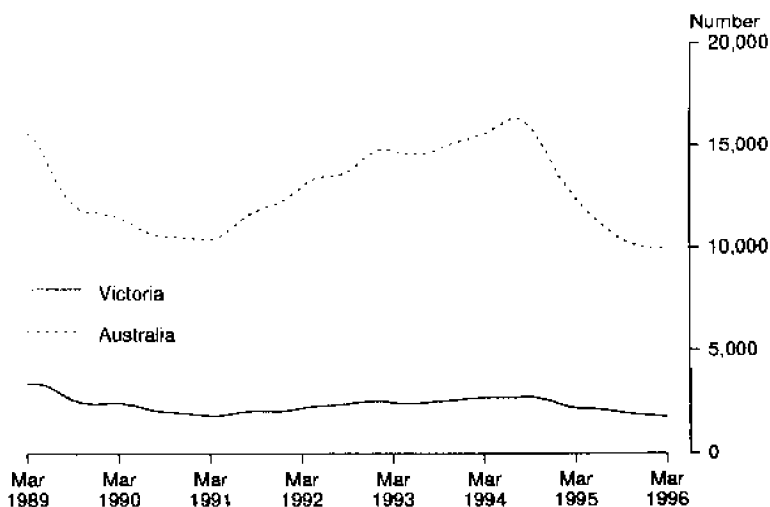
NEW DWELLING UNITS APPROVED

The trend estimate of new dwelling units approved in Victoria in March 1996 decreased by 1.5% from February 1996. The trend estimate showed a decrease of 19.6% from March 1995.

For Australia, the trend estimate of new dwelling units approved decreased slightly, by 0.2% from February to March 1996, however the decrease in the trend estimate from March 1995 to March 1996 is 20%.

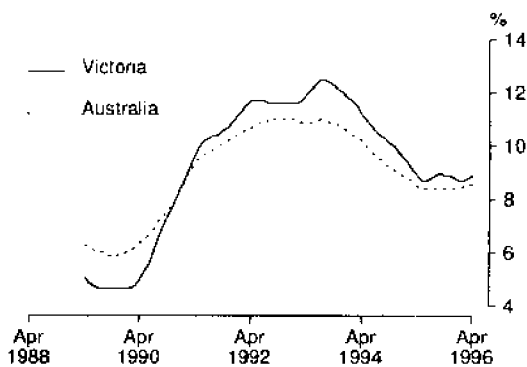

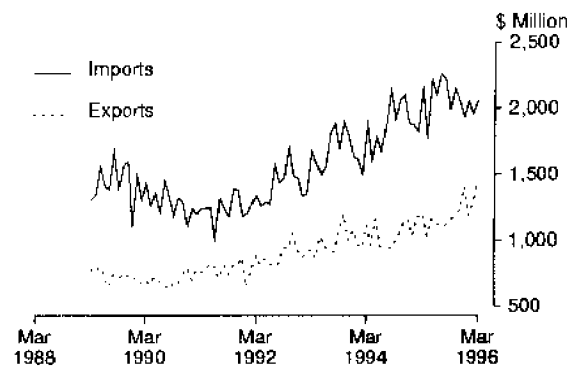

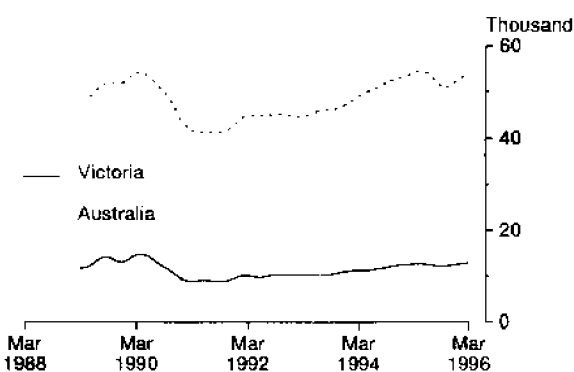
UNEMPLOYMENT RATE
Trend, monthly



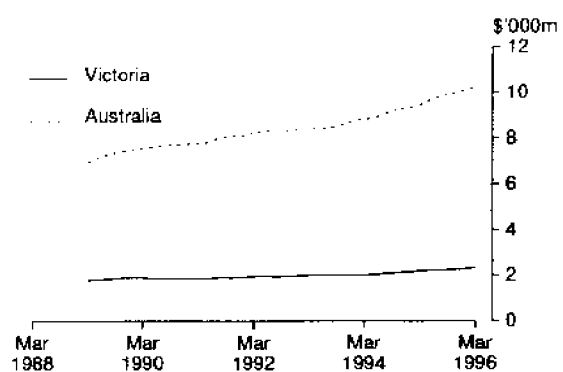
MERCHANDISE IMPORTS AND EXPORTS, VICTORIA

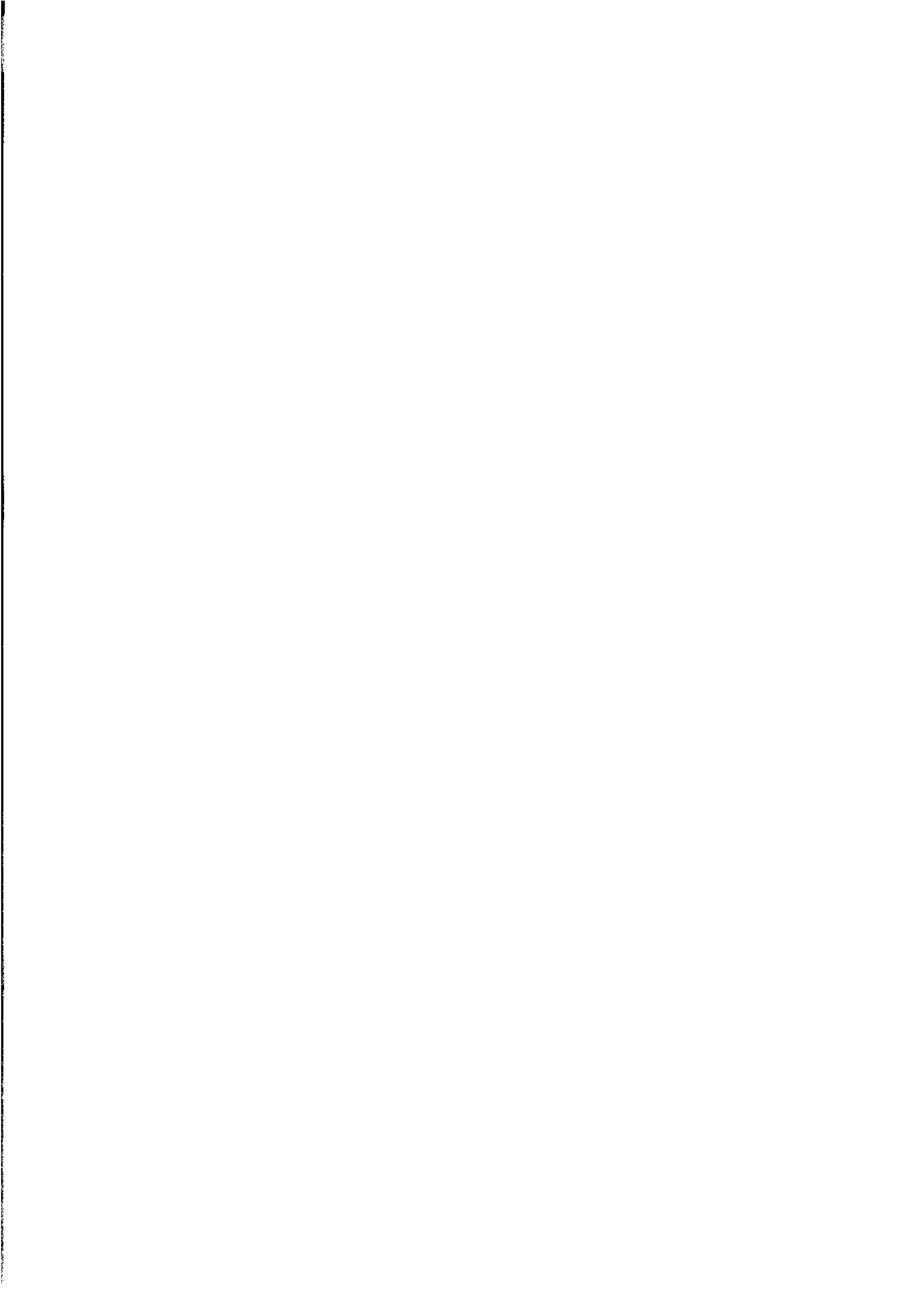

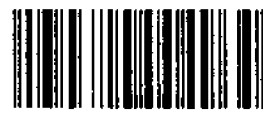
