In 1911, an area of 2,368 square kilometres was transferred to the Commonwealth of Australia by the State of New State Wales to become the Australian Capital Territory (ACT). The city of Canberra, Australia's national capital, is located in the northern part of this area, 300 km south-west of Sydney and 650 km north-east of Melbourne by road. On 11 May 1989 self-government for the Territory was proclaimed; and this year on 11 May 1999 the ACT celebrated ten years of self-government.

The ACT is the smallest of Australia's six States and two Territories but has the highest population density, and is the only State or Territory without a sea border.

CLIMATE OF THE ACT

The weather in the ACT in 1998 was wetter and warmer than the average. The first few months of the year were hot and dry (due to El Nino) and the winter was the wettest winter on record (influenced by La Nina).
