It is an initiative that addresses the Australian Bureau of Statistics (ABS) mission "to assist and encourage informéed decision making within governments and the community".

StatSearch will direct users with an interest in regional statistics to a wide range of ABS social, cultural and economic information. Over 200 references to ABS data sources have been listed under easy-to-understand headings in a total of 22 chapters. Every effort has been made to eliminate, or at least minimise, jargon, acronyms and abbreviations.

#### INTRODUCTION

StatSearch is a user friendly ready reference to sources of social and economic statistical information for Western Australia. Each chapter contains information that will either satisfy your statistical requirements or refer you to external organisations able to provide regional data. The information lists:

- main ABS sources of information relevant to the chapter topic
- related ABS sources
- external sources of information.

For each main ABS source, a brief description of some of the available data items is given together with information about:

- geographic coverage
- frequency of data collection
- historical data available
- products and services available

#### CONTENTS

The table of contents located at the front of this publication lists broad topics covered in the guide. If you cannot decide which of these topics covers your area of interest, please refer to the index.

#### INDEX

The index located at the rear of the publication is a comprehensive list of topics and data items. It is designed to direct you to specific areas of StatSearch that could contain information for your research topic.

# GEOGRAPHIC COVERAGE

Located at the front of the publication, this section gives you a clear and precise explanation of the terms used to describe geographic areas for which statistical information can be made available.

#### 'MAIN' AND 'RELATED' ABS SOURCES

Each StatSearch chapter deals with a specific economic or social subject. ABS information sources devoted to a particular topic are included as 'main' sources. Other ABS sources containing some information for that particular topic are shown separately as 'related' sources. These 'related' sources may be listed as 'main' sources in other chapters. For example, in the Transport chapter, 'related' sources include the Consumer Price Index (price indexes of private motoring costs and urban transport fares) which can be further researched in the Prices chapter. You could also consider referring to the Employment chapter for data relating to persons employed in the transport industry. It is important that you be aware that some information relating to your particular research may be contained in several chapters of the guide.

#### GENERAL ABS DATA SOURCES

There are two ABS products which could be referenced in all chapters of StatSearch. These are:

- Monthly Summary of Statistics provides the most recent data (monthly or quarterly) for a wide range of major economic indicator and social statistics.
- Western Australian Year Book presents a wide range of statistical information on the social, demographic and economic conditions prevailing in the State. Articles and commentary on topical issues are featured and contributions from State government departments, external organisations and agencies are included.

#### STANDARD GEOGRAPHIC AREAS

Regional data collected and disseminated by the ABS are classified to standard geographic areas using the Australian Standard Geographical Classification (ASGC). The publication *Statistical Geography: Volume 1 - Australian Standard Geographical Classification (ASGC)* (1216.0) details those standard geographic areas, shows how they relate to one another, and fully explains the terminology associated with the classification. The ABS can also provide maps for all standard geographic areas in either hardcopy or electronic form.

In addition to obtaining regional information for some or any of these standard geographic areas (depending on the geographic availability of the data source you wish to access), the areas can also be amalgamated to form a geographic area specific to your information needs. For example, your area of interest may be created by amalgamating two Statistical Local Areas and one Statistical Division.

The terminology, abbreviations and definitions of areas referred to in StatSearch follow.

#### STANDARD ASGC AREAS

Census Collection District (CD)

The CD is the smallest geographic area used for collection and dissemination of data. In urban areas, they are usually between 200 and 300 dwellings in size. Rural areas contain fewer dwellings per CD as population densities decrease. CDs are determined or reviewed in the planning stage of the Census of Population and Housing which is undertaken by the ABS every five years. CD boundaries do not cross SIA boundaries.

Statistical Local Area (SLA)

SLAs consist of one or more CDs and in aggregate cover the whole of Western Australia/Australia without gaps or overlaps. SLAs are identical to LGAs in Western Australia with the exception of Perth, Wanneroo, Fremantle and Stirling. SLA data can be aggregated to form a LGA.

Local Government Area (LGA)

LGAs represent the geographical areas of incorporated local government councils, such as cities (C), towns (T) and shires (S). In Western Australia there are currently 144 LGAs consisting of 19 cities, 13 towns and 112 shires. Some ABS collections exclude data relating to the external LGAs of Christmas Island and Cocos (Keeling) Islands.

Statistical Subdivision (SSD)

SSDs consist of one or more SLAs and are the smaller of two ASGC general purpose regional type geographic units. SSDs are used as an intermediate level, general purpose, regional type geographic unit.

Statistical Division (SD)

SDs consist of one or more SSDs and are the largest and most stable general purpose statistical area building blocks of States and Territories. *Note:* The term 'capital city' used in this guide refers to the Capital City Statistical Division (e.g. Perth Statistical Division) in each of the States and Territories.

Statistical Regions (SRs) or Labour Force Regions (LFRs)

SRs form part of the ASGC Statistical Region Structure and in aggregate cover the whole of Western Australia without gaps or overlaps. Statistical Regions are commonly called Labour Force Regions in the collection of data from the Labour Force Surveys.

Urban Centre/(Rural) Locality (UC/L)

An urban centre is a population cluster of 1,000 or more people. A rural locality is a population cluster of between 200 to 999 people. Each urban centre/locality is composed of one or more whole CDs.

# OTHER GEOGRAPHIC AREAS

#### Indigenous Geography

Indigenous geographical classification is hierarchical and built up from CDs. It consists of three levels which can be aggregated to cover the whole of Western Australia. From smallest to largest these classifications are:

- ◆ Indigenous Locations (ILOC)
- Indigenous Areas (IARE), and
- Aboriginal and Torres Strait Islander Commission (ATSIC) Regions (AREG). There are nine ATSIC regions in Western Australia, which are defined geographic areas, each represented by an ATSIC Regional Council or the Torres Strait Regional Authority.

#### Postcode

Postcode classification is used as a statistical output in a number of ABS products. Postcodes disregard statistical boundaries but, in some cases, may be aggregated to form SLAs, SSDs, SDs and LGAs. Care must be taken when aggregating data by postcode to ensure that clearly definable area output is achieved.

# GOVERNMENT FINANCE ESTIMATES (a) and GOVERNMENT FINANCE STATISTICS

Refers to statistics that measure the financial transactions of governments and reflect the impact of these transactions on other sectors of the economy. Government treasuries (or Department of Finance) produce financial information which reflects the expectations of the government in regard to expenditure and revenue for the budget year.

a. Government Finance Estimates are derived each quarter to provide general government and public trading enterprise sector data for input into the national accounts. Quarterly data are also used to produce the first annual figures of 'actual' data for a given financial year. (Government Finance Statistics)

b. Government Finance Statistics focuses on financial transactions such as governments' spending, lending, taxing and borrowing activities. The information is used extensively by Commonwealth and State treasuries and other analysts of public sector activity.

## SOCIO-ECONOMIC INDEXES FOR AREAS (SEIFA)

Socio-Economic Indexes for Areas are summary measures derived from the Population Census to measure different aspects of socio-economic conditions by geographic area. These indexes reveal where the affluent (as opposed to just high income earning) live; where the disadvantaged (as opposed to the unemployed) live and where the highly skilled and educated (as opposed to simply the degree-holding people) live.

If you are involved in targeting products or services, demographic profiling, strategic planning, allocation of funds, or social/economic research, SEIFA can help with analysis of consumer profiles, identify features unique to a target group, and assist in new business location.

There are five indexes which group Australians according to their social and economic conditions:

Urban Index of Advantage: an indicator of well-being, containing items such as high income, tertiary education, home ownership and skilled occupations.

Rural Index of Advantage: makes the distinction between being advantaged in the city and being advantaged in the country, looking at characteristics related specifically to rural areas.

Index of Disadvantage: focuses on low income earners, relatively lower educational attainment, high unemployment, rented dwellings and people lacking fluency in English.

Index of Economic Resources: highlights what could be called disposable income, focusing on economic resources of a household including family income, housing status and car ownership.

Index of Education and Occupation: provides specific rankings based on educational background and type of occupation.

SEIFA96 is available in 3 options:
