









**LOCAL GOVERNMENT AUTHORITY AMALGAMATIONS**

Amalgamations of Local Government Authorities commenced during the reference period (1 October 1992 to 30 September 1993) for this edition with the formation of the City of Greater Geelong on 18 May 1993. Statistics in this publication are collated from data collected on Victoria Grants Commission returns. For the year ended 30 September 1993 component municipalities of the City of Greater Geelong reported individually to the Victoria Grants Commission and are therefore presented individually in this edition. *Care should be taken when comparing statistics for component municipalities with statistics in previous editions. Boundary changes to municipalities occurring at the time of amalgamations are reflected in statistics in this edition.*

**SUMMARY OF FINDINGS**

**ALL SERVICES**

**Long-term debt**

- The level of long-term debt for all activities of Victorian Local Government decreased by 9.9 per cent from \$1,063m in 1991-92 to \$958m in 1992-93. Between 1990-91 and 1991-92 long-term debt decreased by only 3.8 per cent.
- New long-term debt raised for all activities decreased by 21.5 per cent during 1992-93. Between 1990-91 and 1991-92 there was an increase of 1.0 per cent.


**Debt redemption**

- For all activities debt redemption increased significantly from \$139m in 1991-92 to \$187m in 1992-93, an increase of 33.8 per cent. From 1990-91 to 1991-92 debt redemption increased by 4.5 per cent.

**Financial investments  
and bank balances**

- Financial investments by Local Government in 1992-93 were predominantly placed with banks. The proportion of investments with banks to total financial investments was 89.9 per cent at 30 September 1993 (\$882m).

### ALL SERVICES

#### Interest


- Interest received decreased from \$85m in 1991-92 to \$62m in 1992-93, a decrease of 27.2 per cent. Interest paid decreased by 13.4 per cent from \$148m to \$128m in the same period.

### ORDINARY SERVICES

#### Revenue and loan receipts

- Revenue and loan receipts increased by 7.9 per cent from \$2,716m in 1991-92 to \$3,031m in 1992-93. For comparison, the increase in the Consumer Price Index between September quarter 1992 and September quarter 1993 was 2.4.
- The predominant source of revenue for Local Government is rates income. In 1992-93 rates (\$1,421m) increased 2.8 per cent over 1991-92. This compares with an increase of 4.8 per cent between 1990-91 and 1991-92. While rates, as a proportion of total revenue and loan receipts, decreased by 2.3 per cent to 46.9 per cent.
- Revenue from charges, fees and fines decreased by 3.2 per cent to \$475m in 1992-93.
- Commonwealth and State Government grants to Local Government Authorities increased by 35.8 per cent to \$680m in 1992-93. This compares with an increase of 10.9 per cent between 1990-91 and 1991-92. The large increase for 1992-93 is due to the introduction of the 'Local Capital Works Program'. As a proportion of total revenue and loan receipts, grants increased to 17.8 per cent.

#### REVENUE AND LOAN RECEIPTS




- Revenue grants, issued for assistance with operating expenses or running costs of services, increased by 9.7 per cent from \$229m in 1991-92 to \$252m in 1992-93.
- Financial assistance and local roads funding from the Victoria Grants Commission increased by 32.6 per cent in 1992-93 to \$273m, compared with an increase of 13.3 per cent between 1990-91 and 1991-92.


### ORDINARY SERVICES (cont.)

#### COMMONWEALTH AND STATE GOVERNMENT GRANTS, 1992-93



- Interest received decreased by 30.4 per cent from \$82m in 1991-92 to \$57m in 1992-93.
- Loan receipts decreased by 31.0 per cent from \$91m in 1991-92 to \$63m in 1992-93. The decrease between previous years was less significant at 3.8 per cent.
- In dollar terms, transport and communications continued to constitute the largest proportion of total outlay at 20.2 per cent in 1992-93. This is followed by outlay on recreation and culture (16.5 per cent), and general public services (16.3 per cent). These have remained the major items of outlay since 1986-87.
- Most broad purpose categories reported an increase in expenditure in 1992-93. Outlays on health, and transport and communications decreased slightly.

#### ORDINARY SERVICES OUTLAY



- Ordinary services debt redemption increased significantly by 30.1 per cent to \$158m in 1992-93, compared with a decrease of 0.7 per cent to \$122m in 1991-92.

## **SUMMARY OF FINDINGS - *continued***

### **PUBLIC TRADING ACTIVITIES**

- The rate of growth in current trading income has been steady over the last few years. Income of \$551m in 1992-93 increased 2.2 per cent over 1991-92, whereas the increase from 1990-91 to 1991-92 was 1.1 per cent.
- Current trading working expenses increased by 7.9 per cent to \$508m compared to a decrease of 28.2 per cent in 1991-92.
- Capital expenditure on fixed assets increased by 14.6 per cent to \$26m compared to an decrease of 38.2 per cent in 1991-92.

### **SMALL AREA DATA**

#### **Total revenue per head of population**

- For 1992-93 the total revenue per head of population grew slightly more strongly in the Rest of Victoria Major Statistical Region (MSR) than in the Melbourne MSR. An increase of 7.9 per cent to \$809 was recorded in the Melbourne MSR compared to an increase of 14.8 per cent to \$814 in the Rest of Victoria MSR.

#### **Long term debt per head of population**

- Long term debt per head of population in the Melbourne MSR continued to decrease by 12.6 per cent to \$205 in 1992-93, compared to a decrease of only 4.5 per cent in 1991-92. For the Rest of Victoria MSR the decrease was 5.0 per cent to \$239 in 1992-93 compared to a decrease of 3.1 per cent in 1991-92.

#### **Rates - Net arrears**

- At 30 September 1993 net arrears in the Melbourne MSR had decreased by 7.0 per cent to \$47m from net arrears as at 30 September 1992. In the same period net arrears decreased by 7.7 per cent to \$17m in the Rest of Victoria MSR.



## EXPLANATORY NOTES

### Introduction

1. This publication contains statistics of the financial activities of Victorian municipalities for the year 1992-93 (i.e. the year ended 30 September 1993). To present uniform data for Municipalities in Victoria for 1992-93, statistics have been collated from data items collected on a revised Victoria Grants Commission form based on Financial Reporting by Local Governments (Australian Accounting Standard AAS 27). Data from 1989-90 to 1991-92 was collated using the Victorian Minimum Data Set.

### Scope

2. As at 30 September 1993, the whole of Victoria except for unincorporated areas was under the control of 205 municipalities which exercise powers and functions granted to them by statute, principally the Local Government Act. Although the City of Greater Geelong was formed on 18.5.1993, component municipalities reported on an individual basis to the Victoria Grants Commission for the year ended 30 September 1993. Therefore this edition continues to present data for 210 municipalities in Victoria. However care should be taken when comparing data for component municipalities of the City of Greater Geelong with data in previous editions as data reflect boundary changes occurring at the time of formation.

3. Data are derived from two sources, namely the Victoria Grants Commission return and the Consolidated Financial Statements for the year ended 30 September 1993. Reporting for both these documents are based on Financial Reporting by Local Governments (Australian Accounting Standard AAS 27). Victorian Local Government authorities are required to present data using accrual accounting.

4. Services provided by municipalities are partly financed by local taxes (rates) which are levied on the owners or occupiers of rateable property in each municipality. In previous years municipalities rated on the net annual value or site value of a rateable property, or on a combination of both. In 1992-93 five municipalities i.e. Broadford, Chiltern, Omeo, Tullaroop and Woorayl have rated on capital improved value. These valuations have been excluded in this edition.

### Definitions

5. Data presented in this edition for 1992-93 are typically aggregations of line items reported in the Victoria Grants Commission Returns for each

Municipality. The method of aggregation is based on the *Classifications Manual for Government Finance Statistics Australia, 1989* (1217.0) and uses Australian Accounting Standard (AAS) 27 "Financial Reporting by Local Government".

Terms for economic type transactions used in this bulletin are described here in brief. Fuller definitions of transactions are given in the *Classifications Manual for Government Finance Statistics Australia, 1989* (1217.0).

**Capital expenditure:** Expenditure on new or secondhand fixed assets.

**Current expenditure:** Represents purchases of goods and services. That is, cost of providing services, wages and salaries, repair and maintenance of roads, bridges, buildings, etc.

**Government general purpose grants:** Includes Commonwealth and State grants as tax revenue sharing grants, Local Government assistance grants and other untied grants.

**Government specific capital grants:** Commonwealth and State grants for the purchase or construction of new or existing fixed assets, such as roads, buildings, land and plant and equipment.

**Government specific current grants:** Grants allocated to assist with operating expenses or running costs of services, including repairs and maintenance of plant and equipment, and the purchase of consumable items.

**Charges:** Income from sales of goods or services or rent of properties.

**Financial Institutions:** Covers government and privately owned banks, finance companies, money market organisations, building societies and credit unions, life insurance offices, superannuation funds, fire, marine and general insurance, health and friendly societies, investment companies, unit trusts, and industry development corporations.

### Public Trading Enterprises (PTEs)

6. According to the ABS definition of Public Sector Enterprise units, legal entities which engage in both activities relevant to public trading enterprises and general government enterprises are split into separate enterprises where the legal entity is a local government authority with any of the following types of trading undertakings:

- (a) electricity undertakings;
- (b) gas undertakings;
- (c) abattoir undertakings;
- (d) market undertakings;

- (e) any other trading undertaking with annual revenue greater than \$500,000 measured in 1977-78 prices.

7. Sewerage and Water supply in Victoria falls under the authority of the Department of Conservation and Resources, with the exception of a few Municipalities which are granted power to supply under the Local Government Act.

8. Excluded are Public Enterprises mainly engaged in the production of goods and/or services for General Government Enterprises.

9. In Victoria, Councils engage in the following trading activities: electricity; gas; abattoirs; markets and 'other activities'. The major activity undertaken by Municipalities is the reticulation of electrical power. Twelve Municipalities, all except one being in the Melbourne Major Statistical Region, supply electricity under bulk supply arrangements with the SEC.

#### Australian Standard Geographical Classification (ASGC) (1216.0)

10. The ABS has prepared the ASGC for use in the collection, compilation and publication of its statistics. It is a system for the classification of statistical units by geographical areas. Three hierarchical structures in Edition 2.4 have been used in this publication:

- (i) The Detailed Main Structure;
- (ii) The Detailed Statistical Region Structure;
- (iii) The Legal LGA Structure.

Major Statistical Regions and Statistical Regions from the detailed Statistical Region structure have been used to represent the metropolitan area. Statistical Divisions from the detailed Main Structure and Statistical Regions from the detailed Statistical Region structure have been used to represent the ex-Metropolitan area. All Municipalities are represented using the Legal Local Government areas from the Legal LGA structure.

#### Reliability

11. Financial data collected for this publication are checked against the statement of accounts of each municipality. In some cases differences between local government accounting terminology and procedures on the one hand and economic or statistical requirements on the other may affect the comparability of the treatment of certain financial transactions. Overheads are not allocated on a standard basis in Victoria and for this reason functional expenditure data are not comparable between municipalities. For details of the concepts and special treatments required to generate the

statistics in this publication refer to *Classifications Manual for Government Finance Statistics Australia, 1989* (1217.0).

#### Acknowledgements

12. Local Government Finance Statistics for Victoria are collected jointly with the Victoria Grants Commission (VGC). The ABS acknowledges the assistance of the VGC in this collection.

## APPENDIX A:

The Government Purpose Classification (GPC) described below presents inclusions for summary data presented in Table 1 of this classification. The Classification was derived from a standard international system presented in the United Nations publication *Classification of the Function of Government*. The G.P.C. is available in the *Classifications Manual for Government Finance Statistics Australia, 1989* (1217.0)

### GENERAL PUBLIC SERVICES

**General public services** includes those expenses relating to council members, executive staff, and general office (including council chamber expenses) i.e. 'head office' type expenses including government superannuation benefits. The amounts shown are net of recoveries from separate trading activities and outside bodies. See also 'Other Purposes NEC' below.

### PUBLIC ORDER AND SAFETY

**Fire protection** includes contributions to volunteer fire brigades, payments to fire brigade boards, roadside cleaning operations (slashing, clearing, mowing verges, burning), and other fire prevention costs.

**Animal control** includes dog registration, pounds, straying cattle, and veterinary costs.

**Other public order and safety** includes beach inspectors, life-saving and beach patrols, and contributions to State emergency services for rescue operations during emergencies.

### EDUCATION

**Preschools** includes kindergartens, play centres, and other centres having qualified teachers.

**Other education** relates to the operation of school bus services, student hostels, the provision of scholarships, etc.

### HEALTH

**Infants and mothers** relates to the operation of baby health centres and the provision of mothercraft nursing services.

**Preventive services** includes health inspection and administration, immunisation and X-ray programs, school dental and health schemes, and the eradication of noxious insects and vermin such as mosquitoes, flies, and rodents.

**Other health** includes ambulance services, hospitals, and home nursing.

### SOCIAL SECURITY AND WELFARE

**Families and children** relates to creches, child minding centres and other play centres, and services provided to families such as emergency home help.

**Aged and disabled** includes senior citizens' centres, meals-on-wheels, and other services provided specifically for the aged or disabled, and includes outlays on residential institutions for the aged or disabled.

**Other welfare** includes women's refuge (crisis) centres, drop-in centres for the unemployed or youth, services to migrants, social workers' salaries, and overheads. Housing for Aboriginals is included under Housing.

### HOUSING AND COMMUNITY AMENITIES

**Housing** relates to the provision of housing for rental or use by employees and houses for sale to the public. Includes housing for aged persons and Aboriginals but excludes residential institutions.

**Sanitation - household garbage** relates specifically to the provision of household garbage services and includes the operation of rubbish tips.

**Sanitation - other** includes trade waste disposal, cleaning of streets, gutters, foreshores and recreation areas, special rubbish clean-ups, and anti-litter enforcement.

**Sewerage services** includes all methods of human waste disposal such as deep mains town systems, effluent drainage schemes, septic tank cleaning and inspection, and nightsoil disposal ('sanitary' service). Transactions relating to the first of these methods are shown as Trading Activities in the output data statements, and the remainder as ordinary services.

**Urban stormwater drainage** includes the lining or barrelling of creeks and the provision of open or deep drainage systems. Drainage associated with roadworks, flood mitigation, and agricultural drainage are excluded.

**Other protection of the environment** includes flood mitigation works (such as the construction and maintenance of levee banks, dredging of rivers and diversion channels), beach restoration and foreshore protection, and the removal of dead animals and derelict or abandoned vehicles.

**Street lighting** mainly comprises payments to an electricity authority for the maintenance of equipment and supply of current to street lights.

**Community and regional development** includes town planning, subdivisions, land clearing and reclamation, and urban and rural renewal programs.

**Other community amenities** includes women's rest centres, public conveniences, drinking fountains, cemeteries, street furniture, bus shelter sheds, and public clocks.

## RECREATION AND CULTURE

**Public halls, civic centres** includes those multi-purpose halls used for public functions such as town or shire halls or community centres but excludes indoor sporting complexes.

**Swimming pools and beaches** relates to the operation of swimming pools (both indoor and outdoor) and other recreational swimming areas on rivers and beaches including the provision of dressing sheds and diving platforms. Excludes life-saving, beach patrols, and beach inspection.

**Other recreation and sport** includes all indoor and outdoor sporting facilities such as football and cricket grounds, tennis courts and golf links, and other recreational areas such as parks, gardens, playgrounds, barbecue areas, and walking and cycling paths.

**Libraries** includes regional and local lending and reference libraries open to the public and the operation of bookmobiles. (The purchase of books, tapes and records is included as 'capital' together with new plant and equipment).

**Other culture** includes the operation and support of the performing arts, museums, art galleries, orchestras, the preservation of the national estate, and the presentation of festivals.

## AGRICULTURE, FORESTRY, FISHING AND HUNTING

**Agriculture and forestry** includes the destruction of noxious animals and weeds, contribution to pastoral protection boards, agriculture drainage, and forestry matters.

## MINING AND MINERAL RESOURCES, OTHER THAN FUELS; MANUFACTURING AND CONSTRUCTION

**Mining and manufacturing** includes administration, regulation, inspection, etc. of activities relating to mining and manufacturing. Includes the operation of quarries, pits, and hot mix operations.

**Building control** comprises salaries and expenses of staff engaged in the enforcement of building standards, including examination of building plans, and inspection of buildings and scaffoldings.

## TRANSPORT AND COMMUNICATION

**Construction and maintenance of roads and bridges** also includes works and services associated with roads and bridges other than street lighting which is shown separately.

For statistical purposes within the context of the output data statements, construction is treated as capital outlay and maintenance as current outlay.

**Parking** transactions cover a wide range of activities including both on and off-street facilities. To achieve comparability, all transactions related to parking have been classified as 'Ordinary Services', including those parking stations recorded as a trading activity in the accounts of some local authorities.

**Road plant purchases etc.**, includes purchases of plant intended to be used mainly on roadworks, road safety, bus operations (not school), and other road transport matters.

**Aerodromes** relates to the operation of airport facilities.

**Other transport** includes wharves, jetties, docking slips, ferries and marinas, and boat harbours and ramps.

## OTHER ECONOMIC AFFAIRS

**Tourism and area promotion** includes tourist bureaus, caravan parks and camping areas, and the advertising of the advantages of the area to attract tourists and development.

**Saleyards and markets** relates to council premises on which the sale of livestock, rural produce, and other goods is conducted.

**Other economic affairs n.e.c.** relates to economic services provided by councils which cannot be classified to a particular economic service category. Examples are activities relating to plant nurseries and storage. This item includes receipt of unemployment relief grants but not the corresponding expenditure.

## OTHER PURPOSES

**Other purposes** relates to engineering and employment overheads and residual items such as the cost of works on private land, purchases of plant which cannot be allocated to specific purposes, purchases of land and buildings which cannot be allocated to specific purpose categories, the rent of premises other than houses (e.g. shops), work depots, and current deficit or surplus of plant hire operations (excluding depreciation).

**Natural disaster relief** relates to assistance provided for victims of floods or bushfires. Rescue operations are included under Public Order and Safety. The reinstatement of capital assets is shown against the appropriate function.
