EXPLANATORY NOTES

Introduction

This publication contains estimates of the civilian labour force derived from the labour force survey part of the monthly population survey. Estimates of the labour force characteristics of family members and of family composition are also included.

2. Estimates of the civilian labour force are available for about fifty regions across Australia and are shown in various publications produced by State offices of the ABS. For details, see the list of related publications provided in paragraph 51.

3. Preliminary survey results are published in advance of this more detailed publication in *The Labour Force, Australia, Preliminary* (6202.0).

4. Although emphasis in the population survey is placed on the regular collection of specific data on demographic and labour force characteristics of the population, supplementary and special surveys of particular aspects of the labour force or of other subjects are carried out from time to time. Statistics from these surveys are published and are available on request. A list of survey publications on labour force and related topics is shown later in this publication.

The population survey

5. The population survey is based on a multi-stage area sample of private dwellings (about 31,000 houses, flats, etc.) and a list sample of non-private dwellings (hotels, motels, etc.), and covers about three-fifths of one per cent of the population of Australia. The information is obtained from the occupants of selected dwellings by carefully chosen and specially trained interviewers. The interviews are generally conducted during the two weeks beginning on the Monday between the 6th and 12th of each month. The information obtained relates to the week before the interview (i.e. the reference week).

Scope

6. The labour force survey includes all persons aged 15 and over except:

- (a) members of the permanent defence forces;
- (b) certain diplomatic personnel of overseas governments, customarily excluded from census and estimated populations;
- (c) overseas residents in Australia; and
- (d) members of non-Australian defence forces (and their dependents) stationed in Australia.

Coverage

7. In the labour force survey, coverage rules are applied which aim to ensure that each person is associated with only one dwelling, and hence has only one chance of

selection. The coverage rules are, necessarily, a balance between theoretical and operational considerations. Nevertheless, the chance of a person being enumerated at two separate dwellings in the one survey is considered to be negligible. See paragraph 42 for information about the effect of the coverage rules on family statistics.

8. Persons who are away from their usual residence for six weeks or less at the time of interview are enumerated at their usual residence (relevant information may be obtained from other usual residents present at the time of the survey).

Population benchmarks

9. Labour force survey estimates of persons employed, unemployed and not in the labour force are calculated in such a way as to add up to the independently estimated distribution of the usually resident population aged 15 and over by age and sex. This procedure compensates for under-enumeration in the survey, and leads to more reliable estimates. Persons who, at the time of interview, are overseas for more than six weeks but for less than twelve months are included in the independent population statistics (benchmarks) and are thus provided for in the calculation of the estimates. The benchmarks are the latest available estimates at the time the labour force survey is conducted, but they usually differ from the official population estimates subsequently published in *Australian Demographic Statistics* (3101.0) because they are derived from incomplete information about population changes.

Revision of series

10. Survey estimates are not revised for the usually small amendments of population benchmarks arising from new data on deaths and overseas and internal migration. Revisions are made, however, after each census of population and housing, and when population estimation bases are reviewed. These revisions affect unadjusted, seasonally adjusted and trend estimates. The last such revision was made in February 1989 to take account of the results of the 1986 Census of Population and Housing, which affected all the monthly estimates from January 1984 to January 1989. For details, see *Information Paper: Revised Labour Force Survey Estimates: January 1984 to January 1989* (6276.0).

11. Following the change in official population estimates to a place of usual residence basis after the 1981 census, the population benchmarks used in the estimation of labour force survey data are compiled according to place of usual residence. For an explanation of the conceptual basis of population estimates see *Information Paper: Population Estimates: An Outline of The New Conceptual Basis of ABS Population Estimates* (3216.0). To coordinate with the new benchmarks, the labour force survey questionnaire was changed in October 1982 to enable identification of each respondent's place of usual

residence. The estimates shown in this publication are based entirely on place of usual residence. Prior to October 1982, the estimates are based on a combination of place of enumeration and place of usual residence.

12. Until February 1978, surveys were conducted in February, May, August and November each year from 1964. From February 1978 the survey has been conducted on a monthly basis.

13. The questionnaire used in the survey for the collection of labour force data has been revised a number of times, the latest occasion being for the April 1986 survey. Details of these changes have been published in *Information Paper: Questionnaires Used in the Labour Force Survey* (6232.0) in March 1978, December 1981, August 1984, June 1986 and July 1991.

14. In April 1986, the questionnaire was revised following the extension of the definition of employed persons to include persons who worked without pay between 1 and 14 hours per week in a family business or on a farm (i.e. unpaid family helpers). This definition aligned the Australian labour force concepts with a set of changed international definitions adopted by the 13th International Conference of Labour Statisticians in October 1982.

15. Previously, such persons who worked 1 to 14 hours, or who had such a job but were not at work, were defined as either unemployed or not in the labour force, depending on whether they were actively looking for work. In order to assist users to assess the impact of the change, estimates for March 1986 based on the new definition were shown in footnotes to Tables 1 and 2 of the February, March and April 1987 issues of this publication.

16. A revised procedure for weighting families estimates, as presented in this publication, was also introduced in April 1986. Additional tables were included in the April 1986 issue of this publication to show the impact of this new procedure. Paragraph 44 contains more details.

Comparability of series

17. As noted in paragraph 10, estimates from January 1984 have been revised to conform to revised population estimates following the 1986 Census of Population and Housing, and are thus not strictly comparable with estimates for periods prior to January 1984 which have not been revised. An examination of the revised estimates between June 1981 and June 1986 showed that the effects on labour force survey estimates for the period before January 1984 were inconsequential, and that no meaningful purpose would be served by publishing revised estimates for that period.

18. A revision of estimates to take account of the new definition of marital status was applied back to February 1978. Consequently, estimates of marital status contained in this publication are not comparable with estimates published before the February 1984 issue which classified as

married all respondents who reported that they were married or separated. The revision to the marital status classification was undertaken in two parts. First, for all surveys from February 1978, persons who reported that they were separated, were reclassified as not married. Second, from June 1983 onwards, the not-married category was expanded to also include persons who, although reported as married, did not have a spouse who was a usual resident of the household at the time of the survey. See the Glossary for the definition of marital status now used in the labour force survey.

19. Comparability with estimates produced from the quarterly survey of employment and earnings is affected by the use of a different survey methodology and definitions. The labour force survey provides estimates of people in jobs whereas the survey of employment and earnings provides an estimate of the number of jobs held by wage and salary earners. A more detailed description of the differences between these two series is provided in *Information Paper: Comparison of Employment Estimates from the Labour Force Survey and the Survey of Employment and Earnings* (6263.0).

20. From December 1989 onwards, the category *other families* has been split into *one-parent families* and *other families*. Therefore estimates of *other families* are not strictly comparable with estimates in previous issues. However, in November 1989, 97 per cent of *other families* with dependents were *one-parent families*. For definitions of these terms refer to the Glossary.

Survey sample redesign

21. The LFS sample was redesigned and reselected using information collected in the 1986 Census of Population and Housing. The new sample was phased in over the period September to December 1987. For details, see *Information Paper: Labour Force Survey — Sample Design* (6269.0).

22. The sampling fraction differs for States and Territories. This enables estimates of reasonable accuracy to be produced for all States and Territories as well as for Australia. Sampling fractions for each State and Territory are as follows: New South Wales and Victoria, 1 in 230; Queensland, 1 in 160; Western Australia, South Australia, Northern Territory and Australian Capital Territory, 1 in 115; and Tasmania, 1 in 70.

Reliability of the estimates

23. Estimates in this publication are subject to two sources of error:

- (a) sampling error: since the estimates are based on information obtained from occupants of a sample of dwellings they, and the movements derived from them, may differ from the figures that would have been produced if all dwellings had been included in the survey. More information on this topic is given in the Technical Note; and

(b) non-sampling error: inaccuracies may occur because of imperfections in reporting by respondents and interviewers and errors made in coding and processing data. These inaccuracies may occur in any enumeration, whether it be a full count or a sample. Every effort is made to reduce the non-sampling error to a minimum by careful design of questionnaires, intensive training and supervision of interviewers and efficient operating procedures.

Differences between population census and population survey estimates

24. The results of the 1986 Census of Population and Housing show that labour force estimates derived from the census differ from those derived from the labour force surveys.

25. The broad concepts underlying the measures of the labour force and its components, employment and unemployment, are similar in the census and the surveys. However there are considerable differences in both the collection methodology adopted (including the detailed questions asked) and estimation procedures. Factors contributing to differences in estimates include under-enumeration in the population census for which census labour force estimates have not been adjusted, the use in the labour force survey of population benchmarks derived from incomplete information about population change (see paragraph 9), the inclusion of permanent defence forces in census estimates, the personal interview approach adopted in the survey as opposed to self-enumeration of census schedules, differing questions used to determine labour force characteristics (particularly the identification of unemployed persons) and differing methods of adjustment for non-response to the survey or census.

26. The labour force survey provides detailed and up-to-date estimates of employment and unemployment for Australia, States and regions, whereas the census of population and housing provides counts for small areas but in less detail than is available from the survey.

27. These considerations should be borne in mind when comparisons are made between population census and labour force survey estimates.

Seasonal adjustment

28. Seasonally adjusted series are published in Tables 2 and 8. Seasonal adjustment is a means of removing the estimated effects of normal seasonal variation from the series so that the effects of other influences on the series can be more clearly recognised. Seasonal adjustment does not remove the irregular or non-seasonal influences which may be present in any particular month. Influences that are volatile can still make it difficult to interpret the movement of the series even after adjustment for seasonal variation.

29. As happens with all seasonally adjusted series, the seasonal factors are reviewed annually to take account of each additional year's original data. The latest review, in February 1991, revised the Australian and State seasonally adjusted and trend monthly series back to February 1978. Information about the method of adjustment and revised seasonally adjusted and trend estimates for all months since January 1985 for Australia and the States were published in an Appendix to the February 1991 issue of this publication.

Trend estimation

30. Smoothing seasonally adjusted series produces a measure of trend by reducing the impact of the irregular component of the series. The trend estimates are derived by applying a 13-term Henderson-weighted moving average to the respective seasonally adjusted series. These trend series are used to analyse the underlying behaviour of the series over time. Tables 3 and 9 show trend estimates for the past 15 months, while the Appendix to the February 1991 issue shows estimates for the six States and Australia back to January 1985. Trend series graphs are shown on pages 1 to 4. Data from February 1978 are available on the ABS on-line data dissemination service, AUSSTATS. The trend series of the participation rate for married females are based on smoothed population estimates.

31. While this smoothing technique enables estimates to be produced which include the latest month, it does result in revisions to the most recent months as additional observations become available. Generally, subsequent revisions become smaller, and after three months have a negligible impact on the series. There will also be revisions as a result of the annual review of seasonal factors mentioned above in paragraph 29.

32. Users may wish to refer to the ABS Information Papers *A Guide to Smoothing Time Series — Estimates of 'Trend'* (1316.0), and *Time Series Decomposition — An Overview* (1317.0) for more detailed information on producing trend estimates by smoothing seasonally adjusted time series data.

Month-to-month movements

33. Care should be taken in the interpretation of month-to-month movements in these estimates. Survey estimates are subject to sampling and non-sampling variability as explained in paragraph 23. Particular care should be taken in the interpretation of the recent original and seasonally adjusted monthly movements as these may have been affected by the changed pattern of school holidays in some States. Trend estimates are expected to be relatively unaffected by these changes.

Gross flows

34. In order to minimise respondent load and at the same time maintain continuity within the population survey sample, one eighth of the dwellings in the sample (except the large non-private dwellings) are replaced after each

survey. Adoption of this rotation procedure, whereby about seven-eighths of the sample remains unchanged from one month to the next, enables more reliable measurements of changes in the labour force characteristics of the population to be made than would be possible if a new sample were introduced each month.

35. Because a high proportion of private dwellings selected in one survey remains in the sample for the following survey, it is possible to match the characteristics of most of the persons in those dwellings from one month to the next, to record any changes that occur, and hence to produce estimates of *flows* between the different categories of the population and labour force.

36. The procedures used to select persons in non-private dwellings preclude the possibility of matching any of them who may be included in successive surveys. For this and other reasons, including the mobility of the population and non-response in either or both surveys, about 10 per cent of persons in those dwellings which are included in the sample in successive months cannot be matched. Those who can be matched represent about 80 per cent of all persons in the survey.

37. Changes in the characteristics of this latter group are shown in the gross flows table. About one half of the remaining (unmatched) 20 per cent of persons in the survey are likely to have characteristics similar to those in the matched group, but the characteristics of the other half are likely to be somewhat different.

38. Gross flow estimates relate only to those persons in private dwellings for whom information was obtained in successive surveys. The expansion factors used in calculating the estimates were those applying to the second of each pair of months.

39. Although it is not possible to provide gross flow estimates for all persons in the survey it is considered that the estimates derived from matched records will be a useful guide to the magnitude of the movements between categories which underlie the changes in monthly levels. When comparing flows for different periods it is important to take into account the population represented by the matched sample, as shown in the last line of the table.

40. While every effort is made to reduce non-sampling errors to a minimum, any such errors affecting labour force status will tend to accumulate in the gross flow statistics rather than to cancel out. The estimates are also subject to sampling variability, as explained in the Technical Note. For these reasons the estimates of flows should be used with caution. The standard errors may be obtained from Table A of the Technical Note.

Labour force status and other characteristics of families

41. As a part of survey procedures, family relationships are determined each month, enabling both the estimation of persons cross-classified by their family status and the

estimation of families. This publication contains tables showing the labour force status and family status of individuals and families classified by family type, number of family members, the labour force status of persons within families, the number of children aged 0-14 present and, from the May 1986 issue onwards, the number of dependents present.

42. Because of the coverage rules, persons who usually live with other members of their family may, at the time of the survey, be enumerated as not living with all the usual members of their family. This situation is more likely for persons who are enumerated as visitors to other private dwellings or as persons staying in non-private dwellings (hotels, caravan parks, hospitals, etc.). The determination of family structure and family characteristics in such cases is most difficult. Thus for survey questions used to determine family relationships, scope was further restricted to usual residents of private dwellings and the following persons were excluded:

- (a) all persons enumerated in non-private dwellings (including hotels, motels, hospitals and other institutions); and
- (b) persons enumerated as visitors to (rather than usual residents of) private dwellings.

43. In addition, in those households where it was not possible to obtain information relating to all the usual residents, no family information was recorded. Thus persons living in households which include a member of the permanent defence forces, who is outside the scope of the population survey, are excluded from survey questions used to determine family relationships because family information could not be obtained from each usual resident. Similarly households which, at the time of the survey, have one or more of their usual residents away for more than six weeks, are excluded from the family survey. This also applies to households from which an incomplete or inadequate questionnaire was obtained for any usual resident in on scope and coverage. A summary of those persons for whom family information is obtained as well as those usual residents of private dwellings for whom complete family information cannot be obtained, and those persons specifically excluded from the family determination procedures is contained in the family tables. Generally, family status is determined for more than 90 per cent of all civilians aged 15 and over.

44. Estimates of the number of families in this publication differ from those in publications prior to the April 1986 issue. This is due to the adoption of a new weighting procedure where the weight for a family is determined using an average of the weights for all family members responding to the labour force survey. Previously, the weight used to derive estimates of the number of families was determined by nomination of a proxy 'head of household' as representative of the family.

45. Revised data for March 1986 using the new weighting procedure for families and the revised definition of employed persons were shown in the April 1986 issue of this publication. Revised data for March 1986 using the new weighting procedure for families and the old definition of employed persons as well as data using the old weighting procedure for families and the new definition for employed persons are available on request.

Birthplace

46. From April 1991, labour force birthplace data are aggregated according to major groups of the *Australian Standard Classification of Countries for Social Statistics (ASCCSS) 1990* (1269.0). The ASCCSS was developed by the ABS for use whenever demographic, labour and social statistics are classified by countries.

47. The ASCCSS major groups are based on the concept of geographic proximity. They differ from the country groups presented in this publication prior to April 1991. For example, African countries are now covered by "The Middle East and North Africa" and "Africa (excluding North Africa)", while Asia has been split into "Southeast Asia", "Northeast Asia" and "Southern Asia". Data for selected individual countries will continue to be available in this publication and comprehensively on microfiche.

TECHNICAL NOTE

The sample for the population survey was redesigned and reselected using information collected in the 1986 Population Census. The new sample was phased in over the period September 1987 to December 1987. For details, see *Information Paper — Labour Force Survey — Sample Design* (6269.0). For more information on sample design estimation procedures and reliability of the estimates for surveys prior to September 1987, reference should be made to the Technical Note in *The Labour Force, Australia, Historical Summary, 1966 to 1984* (6204.0).

Estimation procedure

2. The labour force estimates are derived from the population survey by use of a complex ratio estimation procedure, which ensures that the survey estimates conform to an independently estimated distribution of the population by age and sex, rather than to the age and sex distribution within the sample itself.

Reliability of the estimates

3. Two types of error are possible in an estimate based on a sample survey: sampling error and non-sampling error. The *sampling error* is a measure of the variability that occurs by chance because a sample, rather than the entire population, is surveyed. Since the estimates in this publication are based on information obtained from occupants of a sample of dwellings they, and the movements derived from them, are subject to sampling variability; that is, they may differ from the estimates that would have been produced if all dwellings had been included in the surveys. One measure of the likely difference is given by the *standard error*, which indicates the extent to which an estimate might have varied by chance because only a sample of dwellings was included. There are about two chances in three that a sample estimate will differ by less than one standard error from the estimate that would have been obtained if all dwellings had been included, and about nineteen chances in twenty that the difference will be less than two standard errors. Another measure of sampling variability is the *relative standard error* which is obtained by expressing the standard error as a percentage of the estimate to which it refers. The relative standard error is a useful measure in that it provides an immediate indication of the percentage errors likely to have occurred due to sampling, and thus avoids the need to refer also to the size of the estimate.

4. Space does not allow for the separate indication of the standard errors of all estimates in this publication. Standard errors of estimates for the latest month and of estimates of movements since the previous month are shown in Table 1. Standard errors of other estimates and other monthly movements should be determined by using Tables A and B.

5. The size of the standard error increases with the level of the estimate, so that the larger the estimate the larger is the standard error. However, it should be noted that the larger the sample estimate the smaller will be the

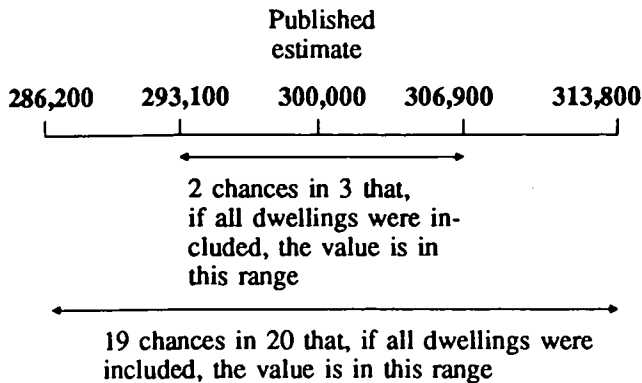
standard error in percentage terms. Thus, larger sample estimates will be relatively more reliable than smaller estimates.

6. As the standard errors in Table A show, *the smaller the estimate the higher is the relative standard error*. Very small estimates are subject to such high standard errors (relative to the size of the estimate) as to detract seriously from their value for most reasonable uses. In the tables in this publication, only estimates with relative standard errors of 25 per cent or less, and percentages based on such estimates, are considered sufficiently reliable for most purposes. However, estimates and percentages with larger relative standard errors have been included and are preceded by an asterisk (e.g. *3.4) to indicate they are subject to high standard errors and should be used with caution. See paragraph 9 concerning the derivation of relative standard errors for some estimates.

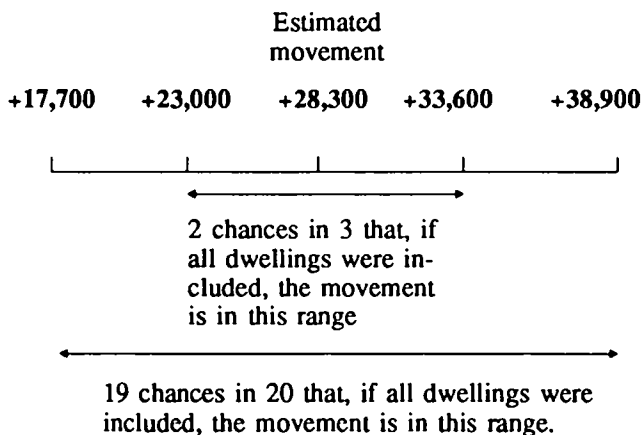
7. The movement in the level of an estimate is also subject to sampling variability. The standard error of the movement depends on the levels of the estimates from which the movement is obtained rather than the size of the movement. An indication of the magnitude of standard errors of monthly movements is given in Table B. The estimates of standard error of monthly movements apply only to estimates of movements between two consecutive months. Movements between corresponding months of consecutive quarters (quarterly movements), corresponding months of consecutive years (annual movements) and other non-consecutive months, will generally be subject to somewhat greater sampling variability than is indicated in Table B. Standard errors of *quarterly* movements can be obtained by multiplying the figures in Table A by 1.11. Standard errors of quarterly movements calculated this way will not necessarily agree with those obtained by multiplying the figures in Table B by 1.5, which was the method shown in the June 1985 and previous issues of this publication. This is because Tables A and B are derived independently of each other. Standard errors of all *annual* movements can be obtained by multiplying the figures in Table A by 1.3. When using Table A or Table B to calculate standard errors of movements, refer to the larger of the two estimates from which the movement is derived.

8. Examples of the calculation and use of standard errors are given below:

- (a) From Table A it will be seen that an estimate of 300,000 unemployed males looking for full-time work has a standard error of about 6,900. Therefore there are about two chances in three that the number that would have been obtained if all dwellings had been included in the survey would have been within the range 293,100 to 306,900 and about nineteen chances in twenty that it would have been within the range 286,200 to 313,800.



- (b) Suppose that there is an increase of 28,300 in the number of unemployed males looking for full-time work from one month to the next. Table B relates the standard error of the monthly movement to the larger of the two estimates from which the movement is derived. In this case, if the larger of the two estimates from which the movement is derived was 300,000, from Table B it will be seen that the standard error of the monthly movement is about 5,300. Therefore there are about two chances in three that if all dwellings had been included in the surveys the movement would have been within the range +23,000 to +33,600 and about nineteen chances in twenty that it would have been within the range +17,700 to +38,900



9. The relative standard errors of estimates of *aggregate hours worked*, *average hours worked*, *average duration of unemployment*, and *median duration of unemployment* are obtained by first finding the relative standard error of the estimate of the total number of persons contributing to the estimate (see Table A) and then multiplying the figure so obtained by the following relevant factors:

Aggregate hours worked: 1.2
Average hours worked: 0.7
Average duration of unemployment: 1.3
Median duration of unemployment: 2.0

The levels at which these and other labour force estimates have a relative standard error of 25 per cent are shown in Table C.

10. An example of the calculation of standard errors by the use of these factors is as follows:

If an estimate of median duration of unemployment for unemployed males is 19 weeks and the number unemployed is estimated as 300,000, from Table A it can be estimated that this figure (300,000) has a standard error of about 6,900 and therefore a relative standard error of about 2.3 per cent. The *relative standard error* of the estimate of median duration of unemployment is calculated by multiplying this figure (2.3) by the appropriate factor shown in the previous paragraph (in this case 2.0): $2.3 \times 2.0 = 4.6$ per cent. The *standard error* of this estimate of median duration of unemployment is therefore 4.6 per cent of 19, i.e. about 1. Therefore there are about two chances in three that the median duration of unemployment for unemployed males that would have been obtained if all dwellings had been included in the survey would have been within the range 18 to 20 weeks and about nineteen chances in twenty that it would have been within the range 17 to 21 weeks.

11. Proportions and percentages (for example, participation rates) formed from the ratio of two estimates are also subject to sampling error. The size of the error depends on the accuracy of both the numerator and denominator. The formula for the relative standard error (RSE) of a proportion or percentage is given below:

$$RSE (x/y) = \sqrt{[RSE (x)]^2 - [RSE (y)]^2}$$

12. Standard errors contained in Tables A and B are designed to provide an average standard error applicable for all monthly labour force survey estimates. Analysis of the standard errors applicable to particular survey estimates has shown that the standard errors of estimates of employment are generally equivalent to those shown in Tables A and B, while standard errors for unemployment and not in the labour force are approximately 3 per cent and 11 per cent respectively higher than those shown in the tables. Standard errors for capital cities are approximately the same as those for corresponding States. Standard errors of estimates of numbers of families are approximately the same as those for numbers of persons. Standard errors of estimates of persons born in Australia are approximately the same as those shown in Tables A and B. For aggregate estimates of persons born outside Australia the standard errors are about 15 per cent higher. The standard errors vary for individual countries of birth, but are generally less than 10 per cent higher.

13. The imprecision due to sampling variability, which is measured by the standard error, should not be confused with inaccuracies that may occur because of imperfections in reporting by respondents, errors made in collection such as in recording and coding data, and errors made in processing the data. Inaccuracies of this kind are referred to as the *non-sampling error* and they may occur in any enumeration, whether it be a full count or a sample. Every effort is made to reduce the non-sampling error to a minimum by careful design of questionnaires, intensive training and supervision of interviewers and efficient operating procedures.

GLOSSARY

Actively looking for work: Includes writing, telephoning or applying in person to an employer for work; answering a newspaper advertisement for a job; checking factory or Commonwealth Employment Service noticeboards; being registered with the Commonwealth Employment Service; checking or registering with any other employment agency; advertising or tendering for work; and contacting friends or relatives.

Aggregate hours worked: The total number of hours a group of employed persons has actually worked during the reference week, not necessarily hours paid for.

Attending school: Persons aged 15 to 19 who, during the reference week, were enrolled full time at secondary or high schools.

Attending tertiary educational institution full time: Persons aged 15 to 24 who, during the reference week, were enrolled full time at universities, colleges of advanced education, technical colleges, colleges of technical and further education and theological colleges.

Average hours worked: Aggregate hours worked by a group divided by the number of persons in that group.

Average duration of unemployment: For a group of unemployed persons, the aggregate duration of unemployment divided by the number of persons in the group.

Birthplace: From April 1991, classified according to the *Australian Standard Classification of Countries for Social Statistics (ASCCSS) 1990* (1269.0).

Dependents: All family members under 15 years of age; all family members aged 15 to 19 attending school or aged 15 to 24 attending a tertiary educational institution full time, except those classified as husbands, wives, sole parents or other family heads.

Duration of unemployment: The period from the time a person began looking for work or was stood down, to the end of the reference week. Thus the survey measures current (and continuing) periods of unemployment rather than completed spells. For persons who may have begun looking for work while still employed, the duration of unemployment is defined as the period from the time the person last worked full time for two weeks or more to the end of the reference week.

Employed: Persons aged 15 and over who, during the reference week:

- (a) worked for one hour or more for pay, profit, commission or payment in kind in a job or busi-

ness, or on a farm (comprising employees, employers and self-employed persons); or

- (b) worked for one hour or more without pay in a family business or on a farm (i.e. unpaid family helpers); or
- (c) were employees who had a job but were not at work and were: on paid leave; on leave without pay for less than four weeks up to the end of the reference week; stood down without pay because of bad weather or plant breakdown at their place of employment for less than four weeks up to the end of the reference week; on strike or locked out; on workers' compensation and expected to be returning to their job; or receiving wages or salary while undertaking full-time study; or
- (d) were employers, self-employed persons or unpaid family helpers who had a job, business or farm, but were not at work.

Employment/population ratio: For any group, the number of employed persons expressed as a percentage of the civilian population aged 15 and over in the same group.

Family: Two or more related persons (*relationship* includes relationships by blood, marriage or adoption) usually resident in the same household at the time of the survey. A family comprises a married couple or a family head as defined, together with any persons having any of the following relationships to them:

- (a) sons or daughters of any age, if not married and with no children of their own present;
- (b) other relatives if not accompanied by a spouse, sons or daughters, or parents of their own; or
- (c) any children under 15 years of age who do not have a parent present.

Family head: Any person without a spouse present, but with a son or daughter aged under 15 present. Persons without a spouse, son or daughter aged under 15 present, but with a son or daughter aged 15 or over present, provided that the son or daughter has no spouse, son or daughter of his/her own present. If a family has no person falling into either of these categories, the family head is generally defined to be the eldest person in the family. No family head is defined for a married-couple family.

Former workers: Unemployed persons who have previously worked full time for two weeks or more but not in the past two years.

Full-time workers: Employed persons who usually worked 35 hours or more a week (in all jobs) and others who,

although usually working less than 35 hours a week, worked 35 hours or more during the reference week.

Household: A group of one or more persons in a private dwelling who consider themselves to be separate from other persons (if any) in the dwelling, and who make regular provision to take meals separately from other persons, i.e. at different times or in different rooms. Lodgers who receive accommodation but not meals are treated as separate households. Boarders who receive both accommodation and meals are not treated as separate households. A household may consist of any number of families and non-family members.

Industry: Classified according to the *Australian Standard Industrial Classification (ASIC) 1983* (1201.0 and 1202.0).

Job leavers: Unemployed persons who have worked full time for two weeks or more in the past two years and *left that job voluntarily*, that is, because of unsatisfactory work arrangements/pay/hours; the job was seasonal, temporary or a holiday job and they left that job to return to studies; their last job was running their own business and they closed down or sold that business for reasons other than financial difficulties; or any other reasons.

Job losers: Unemployed persons who have worked full time for two weeks or more in the past two years and *left that job involuntarily*, that is: were laid off or retrenched from that job; left that job because of their own ill-health or injury; the job was seasonal, temporary or a holiday job and they did not leave that job to return to studies; or their last job was running their own business and the business closed down because of financial difficulties.

Labour force: For any group, persons who were employed or unemployed, as defined.

Labour force status: A classification of the civilian population aged 15 and over into employed, unemployed or not in the labour force, as defined. The definitions conform closely to the international standard definitions adopted by the International Conferences of Labour Statisticians.

Living alone: A person who is the sole member of a household.

Marital status: Persons are classified as married (husband and wife) if they are reported as being married (including de facto) and their spouse was a usual resident of the household at the time of the survey. The not-married category comprises persons who have never married, or are separated, widowed or divorced, as well as those who, although reported as being married, did not have a spouse who usually lived in the household.

Married-couple families: Families in which there are two married persons and these persons are husband and wife. See *Marital status*.

Median duration of unemployment: The duration which divides unemployed persons into two equal groups, one comprising persons whose duration of unemployment is above the median and the other, persons whose duration is below it.

Not a member of a family: A person who is not related to any other member of the household in which they are living.

Not in the labour force: Persons who were not in the categories employed or unemployed, as defined. They include persons who were keeping house (unpaid), retired, voluntarily inactive, permanently unable to work, persons in institutions (hospitals, gaols, sanatoriums, etc.), trainee teachers, members of contemplative religious orders, and persons whose only activity during the reference week was jury service or unpaid voluntary work for a charitable organisation.

Occupation: Classified according to the *Australian Standard Classification of Occupations (ASCO) 1986* (1222.0).

One-parent families: Families in which there is a family head together with at least one dependent son or daughter of his/her own.

Other families: Families which are not married-couple families or one-parent families, as defined. They include families in which there is a parent with only non-dependent children present, and families in which there is no parent, for example a family head living with a brother or sister.

Participation rate: For any group, the labour force expressed as a percentage of the civilian population aged 15 and over in the same group. Participation rates for persons classified by birthplace are calculated using population estimates which exclude those in institutions. Participation rates for persons classified by school or tertiary educational institution attendance are calculated using population estimates which include those in institutions.

Part-time workers: Employed persons who usually worked less than 35 hours a week and who did so during the reference week.

Seasonally adjusted series: A time series of estimates with the estimated effects of normal seasonal variation removed. See paragraphs 28 and 29 of the Explanatory Notes for more detail.

Sole parent: The head of a one-parent family.

State capital cities: The areas determining the six State capital cities are the Statistical Divisions for those capital cities defined in the *Australian Standard Geographical Classification (ASGC) Manual, Edition 3* (1216.0).

Status of worker: Employed persons classified by whether they were employers, self-employed persons, wage and salary earners (employees), or unpaid family helpers.

Trend series: A smoothed seasonally adjusted series of estimates. See paragraphs 30 to 32 of the Explanatory Notes for more detail.

Unemployed: Persons aged 15 and over who were not employed during the reference week, and:

- (a) had actively looked for full-time or part-time work at any time in the four weeks up to the end of the reference week and:
 - (i) were available for work in the reference week, or would have been available except for temporary illness (i.e. lasting for less than four weeks to the end of the reference week); or
 - (ii) were waiting to start a new job within four weeks from the end of the reference week and would have started in the reference week if the job had been available then; or
- (b) were waiting to be called back to a full-time or part-time job from which they had been stood

down without pay for less than four weeks up to the end of the reference week (including the whole of the reference week) for reasons other than bad weather or plant breakdown.

Unemployed persons classified by industry and occupation: Unemployed persons who had worked full time for two weeks or more in the last two years are classified according to the industry and occupation of their most recent full-time job.

Unemployed looking for first full-time job: Unemployed persons looking for full-time work who had never worked full time for two weeks or more.

Unemployed looking for first job: Unemployed persons who had never worked full time for two weeks or more.

Unemployed looking for full-time work: Unemployed persons who actively looked for full-time work or were to resume a full-time job, from which they had been stood down.

Unemployed looking for part-time work: Unemployed persons who had actively looked for part-time work only, or were to resume a part-time job, from which they had been stood down.

Unemployment rate: For any group, the number of unemployed persons expressed as a percentage of the labour force in the same group.

MEASURING EMPLOYMENT AND UNEMPLOYMENT

This recently released publication contains information about the Monthly Labour Force Survey and provides a discussion of the Australian Labour Force Framework. The publication also addresses the following issues relating to the measurement of employment, unemployment and underemployment:

- the reliability of CES registrations as a measure of unemployment;
- the use of data on the number of persons receiving a Jobsearch/Newstart Allowance as a measure of unemployment;
- the labour force status of unpaid workers;
- the "one hour criterion" as the basis of measuring employment;
- the effects of sample size on the accuracy of estimates;
- the labour force status of students.

EARLY RELEASE OF FINAL LABOUR FORCE ESTIMATES

New Service

- Final labour force estimates are now available on subscription as a special data service well before the release of *The Labour Force, Australia* (6203.0). As part of this new service, clients will be able to specify the data items they require and set out formats of tables to suit their personal needs. It will also be possible to specify the medium (hard copy, disk, electronic mail) of their choice.
- Subscription orders only will be catered for initially although it is envisaged that the service will be extended to include ad hoc requests at a later date.

Data detail

- All the data in the 6203.0 including status of worker, industry and occupation will be available. State and regional data not ordinarily available before the release of 6203.0 can also be ordered.

Timing

- Under this special new service, data are expected to be available within a week after the release of *The Labour Force, Australia, Preliminary* (6202.0) and up to two weeks ahead of the final publication. Data will be despatched when available, rather than on a fixed schedule.

Cost

- The cost of this service will vary according to the level of detail required. However, the charging will follow the normal schedule for ad hoc user requests with substantial discounts for subscriptions.
