

PREFACE

ABOUT THIS PUBLICATION

This publication presents information about the labour force status and other characteristics of persons who migrated to Australia, as adults, after 1970. These persons are likely to have received their education outside Australia and had a high probability of entering the labour force soon after arrival in Australia. The information provided enables an assessment of the labour market experience of this group of migrants.

Statistics in this publication were obtained from the Australian Bureau of Statistics (ABS) survey Labour Force Status and Other Characteristics of Migrants.

ABOUT THIS SURVEY

The Labour Force Status and Other Characteristics of Migrants survey was conducted throughout Australia in November 1996 as a supplement to the ABS monthly Labour Force Survey.

Data from the survey relate to persons who were not born in Australia, had arrived in Australia after 1970, were aged 18 years and over on arrival and had obtained permanent resident status.

Questions asked in the survey covered such topics as birthplace, employment, main source of income, educational attainment and proficiency in spoken English.

SUMMARY OF FINDINGS

OVERVIEW

In November 1996 the civilian population aged 15 years and over was 14,442,300 persons. Of these persons, 27% were born outside Australia. In this summary, that group of persons born outside Australia, had arrived after 1970, were aged 18 years and over on arrival, and had obtained permanent resident status are referred to simply as 'Migrants'.

There were 1,449,900 migrants, 10% of the civilian population aged 15 years and over in November 1996. Of these, 891,000 were employed, 95,500 were unemployed and 463,400 were not in the labour force.

MIGRATION CATEGORY


Migrants were classified according to whether they were the principal applicant, the partner of the principal applicant or had migrated from New Zealand. Further categories focused on whether the principal applicant was sponsored, unsponsored or a refugee.

In November 1996, 13% of migrants had arrived from New Zealand, 52% of migrants were principal applicants and 23% arrived as partners of principal applicants.

Of the 755,500 principal applicants, 5% were refugees, 48% were sponsored and 47% were unsponsored. Males made up 64% of principal applicants.

Most of the sponsored principal applicants (83%) were sponsored by family members. Employers sponsored 9% and other persons or organisations sponsored 8% of principal applicants.

BIRTHPLACE

Some 37% of migrants were born in Europe and the former USSR (39% in 1993), with more than half (58%) of that group being born in the United Kingdom and Ireland (down from 59% in 1993). The proportions of migrants born in Southeast Asia (18%), Northeast Asia (9%), Southern Asia (5%) and New Zealand (11%) was the same as in September 1993. Migrants from the Middle East and North Africa made up 7% of all migrants (up from 6% in 1993).

FAMILY OR FRIENDS IN AUSTRALIA BEFORE MIGRATION

There were 998,500 migrants who had family or friends in Australia just before migration. Some 451,400 migrants had neither family nor friends in Australia. Of those migrants with family only in Australia (736,600), 23% had husband/wife/partner and/or children in Australia and 35% had brothers/sisters(in-law) only in Australia.

UNEMPLOYMENT


The unemployment rate for migrants was 9.7%. This compared to 9.2% for all persons born outside Australia and 7.7% for those persons born in Australia. The rate for male and female migrants was 9.1% and 10.5% respectively. The unemployment rate for principal applicants was 9.6%, and 8.7% for partners of principal applicants. Migrants from New Zealand had an unemployment rate of 6.8%.

Persons from Northern America recorded the lowest unemployment rate at 5.9%. Migrants born in the Middle East and North Africa recorded the highest unemployment rate at 20.9%, followed by those who were born in Southern Asia (16.5%).

LABOUR FORCE PARTICIPATION

The labour force participation rate for migrants was 68.0%, compared to 58.0% for all persons born outside Australia and 65.1% for those persons born in Australia. The rates for male and female migrants were 81.2% and 55.4% respectively. The participation rate for principal applicants who were sponsored was 65.5% including 92.9% for those sponsored by an employer. Migrants from New Zealand recorded a participation rate of 70.8%.

UNEMPLOYMENT AND PARTICIPATION RATES BY BIRTHPLACE




Those migrants born in Northern America had the highest participation rate (86.3%) followed by those born in Africa (excluding North Africa) (79.2%). Migrants born in the Middle East and North Africa recorded the lowest participation rate (53.8%).

MAIN SOURCE OF INCOME

Some 39% of female migrants received a wage or salary as their main source of income. Government pensions or cash allowances was the main source of income for 29% of female migrants. Those who relied on their business or share in a partnership made up 6%.

An estimated 57% of male migrants received a wage or salary as their current main source of income. A government pension or cash allowance was the main source of income for 20% of male migrants. A further 15% relied primarily on their own business or share in partnership.

OCCUPATION

Almost three quarters (71%) of migrants who were employed in November 1996 had a job before they migrated. Of this group, 46% remained in the same occupation.

The most common occupations for employed migrants were:

- Professionals (19%);
- Tradespersons and related workers (16%);
- Intermediate clerical, sales and service workers (14%); and
- Intermediate production and transport workers (12%).

Some 47% of migrants who did not have a job before migration were employed.

EDUCATIONAL ATTAINMENT


The proportion of migrants who had arrived in Australia with post-school qualifications was 49%. Of these migrants, a skilled or basic vocational qualification (41%), and a bachelor degree or higher (37%) were the two most common types of qualification attained before migration.

A large proportion (44%) of migrants who arrived with a post-school qualification obtained that qualification in countries in Europe and the former USSR. Migrants who obtained their post-school qualifications in countries in Oceania (12%) and Southeast Asia (12%) made up the next largest groups.

The majority (55%) of migrants who had acquired post-school qualifications before arrival had those qualifications recognised in Australia. An estimated 80% of higher degrees and post-graduate diplomas held by migrants were recognised in Australia. Some 56% of bachelor degrees were recognised, while 52% of skilled and basic vocational qualifications were recognised.

Of 221,800 migrants who obtained post-school qualifications after arrival, 44% obtained a skilled or basic vocational qualification and 30% obtained a bachelor degree or higher.

PROFICIENCY IN SPOKEN ENGLISH

The majority (63%) of migrants were born in other than main English speaking countries. Of this group, 29% usually spoke only English at home.

Of those 647,800 persons who spoke a language other than English at home, 57% reported that they spoke English well or very well. Some 34% reported that they could not speak English well and 9% did not speak English at all.

- The highest proportion (93%) of migrants born in other than main English speaking countries reporting that they usually spoke only English at home or spoke English well or very well were from Africa (excluding North Africa). The lowest proportion (43%) was recorded for migrants from Northeast Asia.

EXPLANATORY NOTES

INTRODUCTION

- 1 This survey was conducted as a supplement to the monthly Labour Force Survey. Respondents to the Labour Force Survey (LFS) who fell within the scope of the supplementary survey were asked further questions.
- 2 For further information about the LFS, see Labour Force, Australia (Cat. No. 6203.0). This monthly publication contains information about survey design, sample redesign, scope, coverage and population benchmarks relevant to the monthly LFS, which also apply to supplementary surveys. It also contains definitions of demographic and labour force characteristics which are relevant to both the monthly LFS and supplementary surveys.

SCOPE

- 3 In addition to those already excluded from the monthly LFS, students at boarding schools, patients in hospitals, residents of homes (e.g. retirement homes, homes for the handicapped), and inmates of prisons are further excluded from all supplementary surveys.
- 4 This survey was restricted to persons who were not born in Australia and who arrived in Australia after 1970, were aged 18 years or more on arrival and had obtained permanent resident status.

RELIABILITY OF THE ESTIMATES

- **5** Estimates in this publication are subject to sampling and non-sampling errors.
- Sampling error is the difference between the published estimate and the value that would have been produced if all dwellings had been included in the survey. For further information on sampling error, refer to the Technical Notes on page 28.
- Non-sampling errors are inaccuracies that occur because of imperfections in reporting by respondents and interviewers and errors made in coding and processing data. These inaccuracies may occur in any enumeration, whether it be a full count or a sample. Every effort is made to reduce the non-sampling error to a minimum by careful design of questionnaires, intensive training and supervision of interviewers, and efficient processing procedures.

SEASONAL FACTORS

6 The estimates are based on information collected in the survey month and, due to seasonal factors, may not be representative of other months of the year.

CLASSIFICATIONS USED

7 From August 1996, occupation data are classified according to the second edition of the Australian Standard Classification of Occupations. For a more detailed explanation, see the *Information Paper: ASCO*—Australian Standard Classification of Occupations (Cat. No. 1221.0). A concordance between the new and the old versions of ASCO is not yet available.

- From April 1991, labour force birthplace data are aggregated according to major groups of the Australian Standard Classification of Countries for Social Statistics (ASCCSS) (Cat. No. 1269.0). The ASCCSS was developed by the ABS for use whenever demographic, labour and social statistics are classified by countries.
- The educational attainment data item in this survey has been classified according to the ABS Classification of Qualifications. For a more detailed explanation, see the Information Paper, Classification of Qualifications — ABSCQ (Cat. No. 1263.0).

CHANGES IN THIS SURVEY

10 The data item 'Field of qualification obtained before migration' which had been collected when this survey was conducted in the past is not available in this issue.

COMPARABILITY OF SERIES

- 11 Revisions are made to population benchmarks for the LFS after each five-yearly Census of Population and Housing. The last such revision was made in February 1994 to take account of the results of the 1991 Census of Population and Housing. Estimates from supplementary surveys conducted after February 1994 are therefore based on revised population benchmarks.
- 12 Until July 1994, supplementary surveys were conducted in all dwellings selected in the LFS. Since August 1994 the sample for supplementary surveys has been restricted to seven-eighths of the LFS sample. This reduction in sample size means that the standard errors for this survey differ from those applicable to previous surveys.
- 13 It is impracticable to obtain information relating to labour force status of persons before migration according to the strict definitions used in the monthly LFS. It is for this reason that 'Had a job' and 'Did not have a job' are used to describe pre-migration labour force status while employed, unemployed and not in the labour force are used to describe labour force status at November 1996.

COMPARABILITY WITH MONTHLY LFS STATISTICS

14 Due to differences in the scope and sample size of this supplementary survey and that of the monthly LFS, the estimation procedure may lead to some small variations between labour force estimates from this survey and those from the LFS.


TECHNICAL NOTES

INTRODUCTION

- Since the estimates in this publication are based on information obtained from occupants of a sample of dwellings, they are subject to sampling variability, that is, they may differ from those that would have been produced if all dwellings had been included in the survey. One measure of the likely difference is given by the standard error (SE), which indicates the extent to which an estimate might have varied by chance because only a sample of dwellings was included. There are about two chances in three that a sample estimate will differ by less than one SE from the number that would have been obtained if all dwellings had been included, and about 19 chances in 20 that the difference will be less than two SE's. Another measure of the likely difference is the relative standard error (RSE), which is obtained by expressing the SE as a percentage of the estimate.
- Space does not allow for the separate indication of the SE's of all estimates in this publication. A table of standard errors for general application is given on page 30. Since they are averages based on calculations for a limited number of past surveys over a wide range of labour force characteristics these numbers will not give a precise measure of the standard error of a particular estimate but they will provide an indication of its magnitude.

CALCULATION OF STANDARD ERROR

An example of the calculation and the use of SE's in relation to estimates of persons is as follows. Table 3 shows the estimated number of persons who arrived in Australia after 1970 aged 18 years and over was 1,449,900. Since this estimate is between 1,000,000 and 2,000,000 the table of standard errors shows that the SE for Australia will lie between 12,600 and 16,300 and can be approximated by interpolation as 14,300 (rounded to the nearest 100). Therefore, there are about two chances in three that the value that would have been produced if all dwellings had been included in the survey will fall in the range 1,435,600 to 1,464,200 and about 19 chances in 20 that the value will fall within the range 1,421,300 to 1,478,500. This example is illustrated in the diagram below.



As can be seen from the standard error table, the smaller the estimate, the higher is the RSE. Very small estimates are thus subject to such high SE's (relative to the size of the estimate) as to detract seriously from their value for most reasonable uses. In these tables, only estimates with RSE's less than 25% are considered sufficiently reliable for most purposes. However, estimates with larger RSE's have been included and are preceded by an asterisk (e.g. *3.4) to indicate they are subject to high SE's and should be used with caution.

PROPORTIONS AND PERCENTAGES

5 Proportions and percentages formed from the ratio of two estimates are also subject to sampling errors. The size of the error depends on the accuracy of both the numerator and the denominator. A formula to approximate the RSE of a proportion is given below:

RSE
$$(x/y) = \sqrt{[RSE (x)]^2 - [RSE (y)]^2}$$

- Considering the example from paragraph 3 above, of the 1,449,900 persons who arrived in Australia after 1970 aged 18 years and over, there was approximately 866,000 persons or 59.7% whose country of last residence was other than a main English-speaking country. The SE of 866,000 is approximately 11,800 so the RSE is 1.4%. The RSE for 1,449,900 is 1.0%. Applying the above formula, the RSE of the proportion is $\sqrt{(1.4)^2 (1.0)^2}$ or 1.0%, giving a SE for the proportion (59.7%) of 0.6 percentage points. Therefore, there are about two chances in three that the proportion of persons whose country of last residence was other than a main English-speaking country was between 59.1% and 60.3% and 19 chances in 20 that the proportion is within the range 58.5% to 60.9%.
- Published estimates may also be used to calculate the difference between two survey estimates (of numbers or percentages). Such an estimate is subject to sampling error. The sampling error of the difference between two estimates depends on their SE's and the relationship (correlation) between them. An approximate SE of the difference between two estimates (x-y) may be calculated by the following formula:

$$SE (x-y) = \sqrt{[SE (x)]^2 + [SE (y)]^2}$$

- 8 While this formula will only be exact for differences between separate and uncorrelated characteristics or subpopulations, it is expected to provide a good approximation for all differences likely to be of interest in this publication.
- 9 The imprecision due to sampling variability, which is measured by the SE, should not be confused with inaccuracies that may occur because of imperfections in reporting by interviewers and respondents and errors made in coding and processing data. Inaccuracies of this kind are referred to as the non-sampling error, and they may occur in any enumeration, whether it be a full count or a sample. Every effort is made to reduce the non-sampling error to a minimum by careful design of questionnaires, intensive training and supervision of interviewers and efficient operating procedures.

GLOSSARY

Birthplace

From April 1991, classified according to the Australian Standard Classification of Countries for Social Statistics (ASCCSS), (Cat. No. 1269.0).

Country of last residence

The country in which the person last lived; see Birthplace for country classification.

Educational attainment

Measures the highest qualification obtained by the respondent, classified according to the ABS Classification of Qualifications (ABSCQ), (Cat. No. 1262.0). The six categories for level of attainment are:

Bachelor degree or higher

Includes bachelor degrees, postgraduate diplomas, masters degrees and doctorates. The entry requirement for a bachelor degree is usually the satisfactory completion of Year 12 or its equivalent. The entry requirement for postgraduate diplomas is usually the successful completion of a bachelor degree or an undergraduate diploma. The minimum entry requirement for masters and doctorates are usually first class honours for a masters degree or a masters degree for a doctorate.

Undergraduate diploma

The entry requirement is usually the successful completion of Year 12 or its equivalent. The duration of study is three years full-time study or its equivalent. Certain other qualifications are classified to this level on the basis that their entry requirements, duration of study and theoretical orientation are regarded as being equivalent to those of undergraduate diplomas, for example, Certificate in Psychiatric Nursing.

Associate diploma

The entry requirement is usually the completion of Year 12 or the completion of Year 10 and a prerequisite certificate course. The duration of study ranges from one to two years full-time study or its equivalent. Advanced Certificates, Technician Certificates and Certificates of Technology are included in this level as they have broadly the same theoretical orientation as associate diplomas.

Skilled vocational qualifications

The entry requirement is usually the completion of Year 10 or its equivalent. In addition, some courses may require a student to be concurrently employed in that specific field. The duration of study is two to four years, and typically involves some on-the-job training.

Basic vocational qualifications Often require Year 10 completion, however many courses have no formal entry requirements. The duration of study ranges from one semester to one year of full-time study or equivalent.

Highest level of secondary school available

The highest level of secondary schooling (or equivalent) offered by the education system at the time the respondent left school.

Employed Persons aged 15 years and over who, during the reference week:

- worked for one hour or more for pay, profit, commission or payment in kind in a job or business, or on a farm (comprising employees, employers and own account workers); or
- worked for one hour or more without pay in a family business or farm (i.e. contributing family workers); or
- were employees who had a job but were: not at work and were on paid leave; on leave without pay for less than four weeks up to the end of the reference week; stood down without pay because of bad weather or plant breakdown at their place of employment for less than four weeks up to the end of the reference week; on strike or locked out; on workers' compensation and expected to be returning to their job; or receiving wages or salary while undertaking full-time study; or
- were employers, own account workers or contributing family workers who had a job, business or farm, but were not at work.

Family or friends in Australia just before migration

Classifies migrants according to whether they had relatives and/or friends in Australia before they arrived. Family includes any person who is related by blood, marriage or adoption. The following family categories are identified:

- sons or daughters of any age;
- husband, wife or partner;
- brothers/sisters (in law);
- parents (in law);
- fiance/fiancee;
- uncle/aunt; and
- other relatives.

Friends are persons, known to the migrant, who are not related by blood, marriage or adoption.

Government pension or cash allowance

Comprises the Family payment/Minimum family payment, Overseas pension or allowance, or any other Australian Government pension or cash allowance.

Labour force status

For any group, persons who were employed or unemployed, as defined.

Main English-speaking countries

Comprises the United Kingdom, Ireland, Canada, South Africa, United States of America and New Zealand.

Migrant

A person who was not born in Australia and who was a permanent resident of Australia at the time of the survey. The main focus of this publication is that group of the migrant population who arrived after 1970, were aged 18 years and over on arrival and had obtained permanent resident status.

Migration category

Classifies migrants according to whether they were:

- born in or a citizen of New Zealand; or
- the principal applicant; or
- the partner of a principal applicant.

Not in the labour force

Persons who were not in the categories employed or unemployed as defined.

Occupation

Classified according to the second edition (1996) of the *Information Paper: ASCO* — Australian Standard Classification of Occupations (Cat. No. 1221.0).

Principal applicant

The family member for whom the eligibility to migrate was determined when migration application was made. Principal applicants are classified by whether they were sponsored, unsponsored or refugees.

Proficiency in spoken English

The subjective response given by a respondent to the question 'How well would you say you speak English?'

Refugee

All persons for whom 'yes' was the response to the question 'When you came to Australia to live, did you come as a refugee'? A refugee is defined by the Department of Immigration as a person outside the country of their nationality who is in fear of being persecuted or at risk of serious harm for their civil or political status in that country and their own government cannot or will not protect them.

Sponsored

Migrants who were sponsored include those who had family already in Australia who sponsored them under the Family Reunion criteria, and those who were sponsored by an employer, or some other person or organisation (other than the Australian Government). Sponsorship is a commitment, signed on a government form by a permanent resident, Australian citizen or organisation, to assist an applicant after arrival in Australia.

Unemployed

Persons aged 15 years and over who were not employed during the reference week, and:

- had actively looked for full-time or part-time work at any time in the four weeks up to the end of reference week and:
- were available for work in the reference week, or would have been available except for temporary illness (i.e. lasting for less than four weeks to the end of the reference week); or

- were waiting to start a new job within four weeks from the end of the reference week and would have started in the reference week if the job had been available then; or
- were waiting to be called back to a full-time or part-time job from which they had been stood down without pay for less than four weeks up to the end of the reference week (including the whole of the reference week) for reasons other than bad weather or plant breakdown.

Unsponsored

Migrants who were unsponsored include those who came to Australia under special eligibility criteria.


