CHAPTER 1 INTRODUCTION

OVERVIEW

This Technical Manual provides information about the release of microdata from the 2005 National Crime and Safety Survey (NCSS) . The data are available through an expanded Confidentialised Unit Record File (CURF) released with the approval of the Australian Statistician. The 2005 National Crime and Safety Survey CURF is accessible through the ABS Remote Access Data Laboratory (RADL). This expanded CURF option provides access to more detailed information than would otherwise be available from a standard CURF product, which has not been produced.

The RADL is an on-line database query system, to which users submit programs to interrogate and analyse data, and access the results. Further information about this facility is available on the ABS website <www.abs.gov.au> (see Services We Provide, CURFS).

The CURF enables purchasers to tabulate, manipulate and analyse data to their own specifications.

About the survey

The 2005 NCSS is the fourth in the series of Australia-wide self-enumeration Crime and Safety Surveys conducted by the Australian Bureau of Statistics (ABS); previous surveys were conducted in 1993, 1998 and 2002. All of the surveys have required respondents to complete the questionnaires themselves and mail these back to the ABS.

The 2005 survey was conducted throughout Australia during April to July 2005 as a supplement to the ABS monthly Labour Force Survey (LFS). Information was sought from approximately 46,100 persons, of whom 36,500 (79%) responded. Data pertaining to households were sought from approximately 23,200 households, of which 18,600 (80%) responded. The estimation procedures employed were designed to reduce the effects of non-response.

Summary results from the 2005 survey were published in Crime and Safety, Australia, April 2005 (cat no 4509.0) released on 26 April 2006. A listing of all data items available from this survey (a selection of which is included on the CURF) are contained in this publication.

CHAPTER 2 SURVEY METHODOLOGY

SURVEY SCOPE

The survey was conducted for all persons aged 15 years and over who were usual residents of private dwellings, except:

- members of the permanent defence forces;
- certain diplomatic personnel of overseas governments, customarily excluded for Census and estimated resident population figures;
- overseas residents in Australia;
- members of non-Australian defence forces (and their dependants); and
- visitors to private dwellings.

Students at boarding schools, patients in hospitals, residents of homes (e.g. retirement homes, homes for persons with disabilities), and inmates of prisons are also excluded from all supplementary surveys.

The NCSS was conducted in both urban and rural areas in all states and territories, but excluded approximately 120,000 persons living in very remote areas of Australia who would otherwise have been within the scope of the survey. The exclusion of these persons will have only a minor impact on any aggregate estimates that are produced for individual states and territories, except for the Northern Territory where such persons account for around 23% of the population.

COVERAGE

The estimates in this publication relate to persons covered by the LFS in April 2005. In the LFS, coverage rules are applied which aim to ensure that each person is associated with only one dwelling, and hence has only one chance of selection in the survey. See Labour Force, Australia (cat. no. 6202.0) for more details.

At the end of the April LFS interview, NCSS questionnaires were mailed to LFS respondents. Each respondent in the household was asked to complete a questionnaire relating to their personal experience of crime, and return it to the ABS by mail. One questionnaire per household also contained questions relating to experiences of household crime, to be answered by one respondent on behalf of the household as a whole. All questionnaires also included additional questions about sexual assault, to be answered only by persons aged 18 years and over. Completion of the sexual assault questions was voluntary for all persons.

ESTIMATION

As the survey was conducted on a sample of households in Australia, it is important to take account of the method of sample selection when deriving estimates from the CURF. This is particularly important as a person's chance of selection in the survey varied depending on the state or territory in which they lived. Survey 'weights' are values which indicate how many population units are represented by the sample unit. Weights are shown as 12 digit numerical fields, which is the actual weight to 4 decimal places.

There is one weight shown on each record on this CURF: a person weight (FINPRSWT) for person level file and a household weight (FINHHWT) for household level file. These should be used when analysing data at the person and household level respectively.

Where estimates are derived from the CURF it is essential that they are calculated by adding the weights of persons or households, as appropriate, in each category, and not just by counting the number of records falling into each category. If each person's or household's 'weight' were to be ignored, then no account would be taken of a person's or household's chance of selection in the survey or of different response rates across

population groups, with the result that counts produced could be seriously biased. The application of weights ensures that:

- person estimates conform to an independently estimated distribution of the population by age, sex, state/territory and section of state, and
- household estimates conform to an independently estimated distribution of households by certain household characteristics (i.e. by number of adults and children, household type, state/territory and section of state), rather than to the distributions within the sample itself.

NON-RESPONSE BIAS ADJUSTMENTS Adjustments for non-response were carried out based on the demographic composition of the LFS sample, as well as on results of the analysis of the effect of reminder action on the responses obtained. Unlike most surveys where little information is available about non-respondents, in this survey demographic characteristics of most non-respondents were available from the LFS. Weighting adjustments were carried out using the distribution of the demographic characteristics from the LFS which were correlated with crime victimisation.

For this survey there were two separate reminder follow-ups (by mail for the first reminder, and mail or telephone for the second reminder). Indications of bias due to the difference between respondents and non-respondents were investigated using successive waves of responses. Any significant bias identified was adjusted for using data from later waves of responses.

SAMPLING ERROR

Since the information on this CURF was obtained from a sample of the population, estimates produced from that information are subject to sampling variability. That is, they may differ from estimates that might be produced if information about the entire population was used. One measure of the difference is the sampling error. Information about the calculation of standard errors, together with a table showing indicative standard errors on estimates from the survey are provided in Appendix 2. The values given in the table do not give a precise measure of the SE and RSE for a particular estimate, but will provide an indication of their magnitude.

Additional information about the calculation of standard errors is provided in the Technical Notes of *Crime and Safety, Australia* (cat. no. 4509.0), which can be accessed online from the ABS website <www.abs.gov.au>.

INTERPRETATION OF THE DATA

Factors which should be considered in interpreting data from the 2005 NCSS, and interpreting changes between results of the 2005 survey and those from previous surveys include:

Information recorded in this survey is essentially 'as reported' by respondents and hence may differ from that which might be obtained from other sources or via other methodology. How a respondent completed a questionnaire will depend on their circumstances, their interpretation of the questions, and how much they are willing to divulge. It should also be noted that the responses obtained in this survey are based on the respondent's perception of their having been the victim.

INTERPRETATION OF THE DATA continued

The terms used for the offences (such as robbery, assault) summarise the wording of the questions asked of the respondent, and may not necessarily correspond with the legal or police definitions which are used for each offence.

While the use of self-enumeration questionnaires may increase the chance of a person revealing personal information on issues such as assault and sexual assault, it may also introduce language and literacy problems which may effect response.

Information was collected on respondents' perceptions of problems in their neighbourhood. Perceptions are influenced by a number of factors and can change quickly.

The survey looked at victimisation as discrete incidents, whereas for some victims of violence this is an ongoing situation.

Significant definitional changes relating to robbery and assault occurred between the 1993 and later surveys. There have been no definitional changes in the household crimes covered by the survey, but changes over time in respondents' attitudes towards crime may affect comparability.

The survey covers only people living in private dwellings: excluded are people such as the homeless or people living in special accommodation, sections of the community which may be heavily victimised.

SEXUAL ASSAULT DATA

Completion of the sexual assault questions was voluntary. Of those respondents aged 18 years and over who completed the main survey form, 75.4% of females and 71.5% of males completed the sexual assault questions.

Response rates for sexual assault in 2005 are lower than in previous years. The decreased response rates are most likely due to changes made to the survey methodology, which included combining the sexual assault questions with the main survey form, and some changes to the structure and wording of the screening questions. Due to the low response rates for sexual assault only limited data is available for 2005. A victimisation value for the non-responding persons has been imputed in the same proportion as those who responded to the questions. No other information was imputed for these non-responding records. Imputation classes were defined using sex by age group by labour force status by state and territory.

For further information about the conceptual and methodological issues which may effect the interpretation and use of data from this CURF, see the Explanatory Notes contained in *Crime and Safety, Australia* (cat no 4509.0).

CHAPTER 3 USING THE CURF DATA

USING THE CURF DATA

The 2005 NCSS Expanded CURF contains two separate SAS files and there is no direct link between these two files. As such, it is not possible to associate particular person records with a household record. The CURF enables users to manipulate the data, produce tabulations and undertake statistical analyses to individual specifications.

The 2005 NCSS microdata are released under the Census and Statistics Act 1905, which has provision for the release of data in the form of unit records where the information is not likely to enable the identification of a particular person or organisation. Accordingly, there are no names or addresses of survey respondents on the CURF, and other steps have been taken to protect the confidentiality of respondents. These include removing some items from the CURF, reducing the level of detail shown on the CURF for some other items, changing some characteristics such as area or age for some records. Data on the 2005 NCSS Expanded CURF will therefore not exactly match the data published in Crime and Safety, Australia (cat no 4509.0). The nature of the changes made, and the relatively small number of records involved, ensure that the differences for analysis purposes are negligible.

Intending purchasers should ensure that the data they require, at the level of detail they require are available on the CURF; data obtained in the survey but not contained on the CURF may be available as statistics in tabulated form on request. A full list of all the data items on the CURF is provided in Appendix 2.

Due to the lower response rates to the sexual assault questions, there is an imputation flag (IMPC) in personal level file attached to the imputed records that allows users to include or exclude these records in their analyses.

CHAPTER 5 CONDITIONS OF RELEASE

CONDITIONS OF RELEASE

The 2005 NCSS CURF is released in accordance with a Ministerial determination (Clause 7, Statutory Rules 1983, No. 19) in pursuance of section 13 of the Census and Statistics Act 1905. As required by the Determination, the CURF has been designed so that the information on the file is not likely to enable the identification of the particular person to which the data relates

The Australian Statistician's approval is required for each release of the CURF. In addition, all organisations, and individuals within organisations, who request access to the CURF will, prior to being granted access to the CURF, be required to sign an undertaking to abide by the legislative restrictions on use. Organisations and individuals who purchase or access the 2005 NCSS CURF are required to give an undertaking which includes, among other conditions, that in using the data they will:

- use the information only for statistical purposes specified in the Schedule to the Undertaking;
- not attempt to identify particular persons or organisations;
- not disclose, either directly or indirectly, the information to any other person or organisation other than members of their organisation who have been approved by the ABS to have individual access to the information;
- not attempt to match, with or without using identifiers, the information with any other unit level list of persons;
- comply with any other direction or requirement specified in the ABS Responsible Access to ABS CURFs Training Manual; and,
- not attempt to access the information after the term of their authorisation expires, or after their authorisation is rescinded by the organisation which provided it, or after they cease to be a member of that organisation.

Use of the data for statistical purposes means use, by persons who have signed the Undertaking, of the information contained in the CURF to produce information of a statistical nature, i.e. the arrangement and classification of numerical facts or data, including statistical analyses or statistical aggregates. Examples of statistical purposes are:

- manipulation of the data to produce means, correlations or other descriptive or summary measures;
- estimation of population characteristics;
- use of data as input to mathematical models or for other types of analysis (e.g. factor analysis); and,
- providing graphical or pictorial representations of the characteristics of the population or subsets of the population.

All CURF users are required to read and abide by the "Responsible Access to ABS Confidentialised Unit Record Files (CURFs) Training Manual" available on the ABS web site http://www.abs.gov.au (see Services We Provide, CURFs). Use of the data for unauthorised purposes may render the purchaser liable to severe penalties. GLOSSARY

Assault An incident, other than a robbery, where the respondent was physically attacked or threatened with force or violence.

Attempted break-in An incident where an attempt was made to break into the respondent's home, garage or

shed.

Incident

Break-in An incident where the respondent's home was broken into. The respondent's home was

defined to include their garage or shed. Break-in offences relating to their car or garden

were excluded.

Household A group of persons resident in a private dwelling who share common facilities and meals

who consider themselves to be a household. It is possible for a dwelling to contain more than one household, for example, where regular provision is made for groups to take

meals separately and where persons consider their households to be separate.

Incidence rate The total number of incidents of an offence that occurred in the reference period expressed as a percentage of the relevant population.

A single occurrence of a crime event, such as a break-in, an attempted break-in, the theft of a motor vehicle, or an act of robbery, assault or sexual assault.

Labour force status The situation of respondents in relation to the labour force at the time of the survey. Categories include:

 Employed — had a job or business, or undertook work without pay in a family business in the week prior to the survey, including being absent from a job or business they had

■ Unemployed — not employed and actively looked for work in the four weeks prior to the survey and available to start work in the week prior to the survey

Not in the labour force — persons who were neither employed nor unemployed, e.g. retired persons, persons keeping house (unpaid), and persons who are voluntarily inactive and permanently unable to work.

Motor vehicle theft

An incident where a motor vehicle was stolen from any member of the household. It includes privately owned motor vehicles as well as business/company vehicles used

exclusively by members of the household.

Neighbourhood The definition of this term was left to the interpretation of the respondent.

Offence A crime committed against either a persons or a household.

Personal crime Specifically, a robbery, assault or sexual assault, in which an individual is considered to

be the victim of the crime.

Reporting rate The total number of victims of an offence who reported the most recent incident to

police, expressed as a percentage of the total victims of that offence.

Robbery An incident where someone stole (or tried to steal) property from a respondent by

physically attacking them or threatening them with force or violence.

Sexual assault An incident of a sexual nature involving physical contact, including rape, attempted rape,

indecent assault, and assault with the intent to sexually assault. Sexual harassment (that did not lead to sexual assault) was excluded. Only persons aged 18 years and over were

asked questions about sexual assault.

Victim A household or person reporting at least one of the offences surveyed. Victims were

counted once only for each type of offence, regardless of the number of incidents of that

type.

Victimisation prevalence rate The total number of victims of an offence in a given population expressed as a

percentage of that population.
