## KEY POINTS

## TREND ESTIMATES

- The provisional trend estimate of the balance on goods and services was a deficit of $\$ 2,181 \mathrm{~m}$ in September 2003, a decrease of $\$ 3 \mathrm{~m}$ on the deficit in August.
- Goods and services credits rose $\$ 54 \mathrm{~m}$ to $\$ 11,402 \mathrm{~m}$. Goods and services debits rose $\$ 51 \mathrm{~m}$ to $\$ 13,583 \mathrm{~m}$.


## SEASONALLY ADJUSTED ESTIMATES

- In seasonally adjusted terms, the balance on goods and services was a deficit of $\$ 2,278 \mathrm{~m}$ in September, an increase of $\$ 310 \mathrm{~m}$ (16\%) on the deficit in August.
- Goods and services credits rose $\$ 74 \mathrm{~m}$ (1\%) to $\$ 11,648 \mathrm{~m}$. Rural goods rose $\$ 188 \mathrm{~m}$ (11\%) and non-rural and other goods fell $\$ 253 \mathrm{~m}(4 \%)$. Services credits rose $\$ 139 \mathrm{~m}$ (5\%).
- Goods and services debits rose $\$ 384 \mathrm{~m}(3 \%)$ to $\$ 13,926 \mathrm{~m}$, with goods debits up $\$ 310 \mathrm{~m}$ (3\%) and services debits up $\$ 74 \mathrm{~m}(3 \%)$. Consumption goods rose $\$ 273 \mathrm{~m}$ (8\%), capital goods rose $\$ 39 \mathrm{~m}(2 \%)$, and intermediate and other goods fell $\$ 2 \mathrm{~m}$.


## ORIGINAL ESTIMATES

- In original terms, the September balance on goods and services was a deficit of $\$ 3,270 \mathrm{~m}$, an increase of $\$ 1,523 \mathrm{~m}(87 \%)$ on the deficit in August. The increased deficit was the result of a $\$ 1,278 \mathrm{~m}(9 \%)$ increase in imports of goods and services, and a $\$ 245 \mathrm{~m}(2 \%)$ decrease in exports of goods and services.

## Revisions to Historical Data

In original terms, revisions since the previous issue have:

- increased the deficit on goods and services for the two months to August 2003 by \$167m
- decreased the deficit on goods and services for 2002-03 by $\$ 15 \mathrm{~m}$.

The revisions are the result of incorporating the latest available data relating to merchandise trade and the quarterly Survey of International Trade in Services.

Seasonally adjusted and trend estimates of the balance on goods and services will be revised in the October 2003 issue of this publication as a result of the annual seasonal re-analysis. The revised forward seasonal factors are released as part of the electronic versions of approriate publications (see 5368.0, Table 19, for monthly seasonal factors, and 5302.0, Table 95, for quarterly seasonal factors).

Feature articles on Australia's international trade in services by partner country, and international trade in services by state, for the financial year 2002-03, will be released on the ABS web site [http://www.abs.gov.au](http://www.abs.gov.au) on 30 October 2003. Comparable data for calendar year 2002 was released on 29 May 2003.

The tables in this publication are presented on two bases. Tables 1-6 contain estimates of Australia's international trade in goods and services which have been adjusted for coverage, valuation and timing to a balance of payments basis. Tables 7-10 contain estimates of merchandise exports and imports based on Australian Customs Service records. Paragraph 5 of the Explanatory Notes provides an explanation of the difference between these bases.

## ANALYSIS AND COMMENTS

BALANCE ON GOODS AND SERVICES

The trend estimate of the balance on goods and services in September 2003 was a deficit of $\$ 2,181 \mathrm{~m}$, a decrease of $\$ 3 \mathrm{~m}$ on the deficit in August.

In seasonally adjusted terms, the balance on goods and services in September 2003 was a deficit of $\$ 2,278 \mathrm{~m}$, an increase of $\$ 310 \mathrm{~m}(16 \%)$ on the deficit in August.

The sum of the seasonally adjusted balances for the three months to September 2003 was a deficit of $\$ 6,576 \mathrm{~m}$, a decrease of $\$ 351 \mathrm{~m}$ on the deficit of $\$ 6,927 \mathrm{~m}$ for the three months to June 2003. However, if the more detailed seasonal factors used in compiling quarterly Balance of Payments are applied, the September quarter 2003 deficit was $\$ 5,971 \mathrm{~m}$, a decrease of $\$ 882 \mathrm{~m}$ on the revised June quarter 2003 deficit of $\$ 6,853 \mathrm{~m}$.

EXPORTS OF GOODS AND SERVICES

The trend estimate of goods and services credits rose $\$ 54 \mathrm{~m}(1 \%)$ in September to \$11,402m.

In seasonally adjusted terms, goods and services credits rose $\$ 74 \mathrm{~m}(1 \%)$ in September to $\$ 11,648 \mathrm{~m}$. Rural goods rose $\$ 188 \mathrm{~m}$ (11\%), while non-rural and other goods fell $\$ 253 \mathrm{~m}$ (4\%). Services credits rose $\$ 139 \mathrm{~m}$ (5\%).

The trend estimate of rural goods rose $\$ 5 \mathrm{~m}$ to $\$ 1,765 \mathrm{~m}$.
In seasonally adjusted terms, rural goods rose $\$ 188 \mathrm{~m}$ (11\%) to $\$ 1,900 \mathrm{~m}$. While seasonally adjusted exports of rural goods have improved this month, the level of these exports remain significantly lower than the corresponding period last year. Rural goods exports for September 2003 were $\$ 460 \mathrm{~m}(19 \%)$ lower than in September 2002.

Rural goods, in original terms, rose $\$ 127 \mathrm{~m}(7 \%)$ to $\$ 1,849 \mathrm{~m}$. Three of the four components of rural goods increased.

Rural goods continued

Non-rural and other goods

Contributing to the rise in the seasonally adjusted series were:

- other rural, down $\$ 18 \mathrm{~m}(2 \%)$, compared with an average August to September fall of $8 \%$ over the previous three years
- wool and sheepskins, up $\$ 76 \mathrm{~m}$ ( $44 \%$ ), compared with an average August to September rise of $14 \%$ over the previous three years. Exports of greasy wool rose $\$ 76 \mathrm{~m}(83 \%)$, driven by an increase in volumes shipped of $80 \%$.
- meat and meat preparations, up $\$ 51 \mathrm{~m}(13 \%)$, compared with an average August to September rise of $4 \%$ over the previous three years. Exports of beef and veal were up $\$ 29 \mathrm{~m}(11 \%)$, with a $6 \%$ increase in volumes shipped and a $5 \%$ increase in prices. Mutton and lamb also recorded an increase, up $\$ 11 \mathrm{~m}$ ( $18 \%$ ), due to an $18 \%$ increase in volumes shipped. Prices were unchanged.
- cereal grains and cereal preparations, up $\$ 18 \mathrm{~m}(8 \%)$, in contrast to an average August to September fall of $3 \%$ over the previous three years.

The trend estimate of non-rural and other goods exports fell $\$ 8 \mathrm{~m}$ to $\$ 6,929 \mathrm{~m}$.
Seasonally adjusted, non-rural and other goods fell $\$ 253 \mathrm{~m}$ (4\%) to $\$ 6,968 \mathrm{~m}$.
In original terms, non-rural goods fell $\$ 115 \mathrm{~m}(2 \%)$ to $\$ 6,573 \mathrm{~m}$.
Contributing to the decrease in the seasonally adjusted series were:

- transport equipment, down $\$ 147 \mathrm{~m}(24 \%)$, compared with an average August to September fall of $1 \%$ over the previous three years. Other transport equipment decreased $\$ 208 \mathrm{~m}$ ( $91 \%$ ), while road vehicles increased $\$ 53 \mathrm{~m}$ (14\%)
- other mineral fuels, down $\$ 14 \mathrm{~m}(2 \%)$, in contrast to an average August to September rise of $8 \%$ over the previous three years. Exports of gas, natural and manufactured, were down $\$ 10 \mathrm{~m}(4 \%)$, and exports of petroleum and petroleum products fell $\$ 4 \mathrm{~m}$ (1\%).
- machinery, down $\$ 11 \mathrm{~m}(2 \%)$, in contrast to an average August to September rise of 4\% over the previous three years. Exports of machinery specialised for particular industries were down $\$ 12 \mathrm{~m}(12 \%)$.
- other manufactures, up $\$ 67 \mathrm{~m}(6 \%)$, compared with an average August to September rise of $8 \%$ over the previous three years.

Partly offsetting these decreases was a rise in other non-rural goods, up $\$ 32 \mathrm{~m}(4 \%)$, in contrast to an average August to September fall of $3 \%$ over the previous three years.

In original terms, other goods fell $\$ 166 \mathrm{~m}(20 \%)$ to $\$ 657 \mathrm{~m}$, driven by a decrease in gold exports, down $\$ 271 \mathrm{~m}$ (41\%).

## ANALYSIS AND COMMENTS continued

IMPORTS OF GOODS AND SERVICES

The trend estimate of goods and services debits rose $\$ 51 \mathrm{~m}$ in September to $\$ 13,583 \mathrm{~m}$.
In seasonally adjusted terms, goods and services debits rose $\$ 384 \mathrm{~m}(3 \%)$ to $\$ 13,926 \mathrm{~m}$. Goods debits rose $\$ 310 \mathrm{~m}$ (3\%), and services debits rose $\$ 74 \mathrm{~m}$ (3\%).

## GOODS DEBITS

## SERVICES DEBITS



The trend estimate of imports of consumption goods rose $\$ 16 \mathrm{~m}$ to $\$ 3,451$.
In seasonally adjusted terms, imports of consumption goods rose $\$ 273 \mathrm{~m}(8 \%)$ to \$3,623m.

Consumption goods, in original terms, rose $\$ 538 \mathrm{~m}(16 \%)$ to $\$ 3,983 \mathrm{~m}$. This rise was in contrast to the average August to September fall of $4 \%$ over the previous three years.

Contributing to the rise in the seasonally adjusted series were:

- non-industrial transport equipment, up $\$ 263 \mathrm{~m}$ (30\%), compared with an average rise of $5 \%$ over the previous three years. This rise was mostly due to a $\$ 240 \mathrm{~m}$ increase in passenger motor vehicles, following lower imports in August 2003.
- consumption goods n.e.s., up $\$ 110 \mathrm{~m}(10 \%)$, in contrast to an average fall of $6 \%$ over the previous three years. This increase was mainly due to medicaments, up $\$ 34 \mathrm{~m}$ (9\%).
- food and beverages, up $\$ 74 \mathrm{~m}$ (19\%), in contrast to an average fall of $4 \%$ over the previous three years. This increase was mainly due to other food, up $\$ 33 \mathrm{~m}(21 \%)$.
- textiles, clothing and footwear, which was steady with imports of $\$ 467 \mathrm{~m}$, compared with an average fall of $19 \%$ over the previous three years.


## ANALYSIS AND COMMENTS continued

## Capital goods

The trend estimate of imports of capital goods rose $\$ 18 \mathrm{~m}(1 \%)$ to $\$ 2,630 \mathrm{~m}$.
Seasonally adjusted, capital goods imports rose $\$ 39 \mathrm{~m}(2 \%)$ to $\$ 2,621 \mathrm{~m}$.
Imports of capital goods, in original terms, rose $\$ 237 \mathrm{~m}(9 \%)$ to $\$ 2,737 \mathrm{~m}$. This rise was in contrast to the average August to September fall of $5 \%$ over the previous three years.

Contributing to the rise in the seasonally adjusted series were:

- machinery and industrial equipment, down $\$ 15 \mathrm{~m}(2 \%)$, compared with an average fall of $14 \%$ over the previous three years
- industrial transport equipment, up $\$ 97 \mathrm{~m}(33 \%)$, in contrast to an average fall of $2 \%$ over the previous three years
- ADP equipment, up $\$ 49 \mathrm{~m}(13 \%)$, in contrast to an average fall of $3 \%$ over the previous three years
- civil aircraft, up $\$ 91 \mathrm{~m}$ (47\%).

Intermediate and other goods

The trend estimate of imports of intermediate and other goods fell $\$ 37 \mathrm{~m}(1 \%)$ to $\$ 4,720 \mathrm{~m}$.

Seasonally adjusted, intermediate and other goods imports fell $\$ 2 \mathrm{~m}$ to $\$ 4,827 \mathrm{~m}$.
Imports of intermediate and other goods, in original terms, rose $\$ 267 \mathrm{~m}(6 \%)$ to $\$ 5,022 \mathrm{~m}$.

Contributing to the fall in the seasonally adjusted series were:

- organic and inorganic chemicals, down $\$ 62 \mathrm{~m}(23 \%)$, in contrast to an average rise of $20 \%$ over the previous three years
- non-monetary gold, up $\$ 1 \mathrm{~m}$ (2\%), compared with a much stronger increase over the previous three years.

Offsetting these effects were:

- fuels and lubricants, up $\$ 91 \mathrm{~m}(12 \%)$, in contrast to an average fall of $16 \%$ over the previous three years
- goods for processing, up $\$ 110 \mathrm{~m}(42 \%)$, in contrast to an average fall of $7 \%$ over the previous three years
- other merchandise goods, up $\$ 49 \mathrm{~m}$ (43\%), in contrast to an average fall of $29 \%$ over the previous three years.

INTRODUCTION

CONCEPTS, SOURCES AND METHODS

SEASONAL ADJUSTMENT

TREND ESTIMATES

1 This publication presents preliminary estimates of Australia's international trade in goods and services on a balance of payments basis and merchandise import and export statistics on a recorded trade basis.

2 Merchandise trade statistics on a recorded trade basis are compiled from information submitted by exporters and importers or their agents to the Australian Customs Service (ACS). Adjustments for coverage, timing and valuation are made to recorded trade data to convert them to a balance of payments basis. The main source for services data is the quarterly Survey of International Trade in Services.

3 More comprehensive quarterly estimates of Australia's trade in goods and services, together with comprehensive details of Australia's balance of payments are included in the quarterly publication, Balance of Payments and International Investment Position, Australia (cat.no.5302.0). Detailed monthly statistics on merchandise trade are available on AusStats or by subscription to tailored services.

4 The conceptual framework used in compiling Australia's merchandise trade statistics can be found in International Merchandise Trade, Australia: Concepts, Sources and Methods, 2001 (cat.no.5489.0).

5 The conceptual framework used in compiling Australia's balance of payments statistics is based on the Fifth Edition of the International Monetary Fund's Balance of Payments Manual (BPM5,1993). Descriptions of the underlying concepts and structure of the balance of payments and the sources, methods and terms used in compiling the estimates are presented in Balance of Payments and International Investment Position, Australia: Concepts, Sources and Methods, 1998 (cat.no.5331.0). To bring merchandise trade statistics on a recorded trade basis to a balance of payment basis, timing adjustments are made to ensure that the transaction is recorded in the period in which ownership changed, rather than in the period in which the transaction was recorded by ACS. Adjustments are also made to imports to take account of distortions which arise when significant changes occur in the volume of import entries lodged but not yet processed by ACS in a given month. Chapter 6 of cat. no. 5331.0 provides more detail on the relationship between statistics on international merchandise trade on a recorded trade basis and on a balance of payments basis.

7 Monthly original estimates are volatile, being subject to calendar-related and large irregular influences. Seasonally adjusted estimates are derived by estimating and removing systematic calendar related effects, such as seasonal and trading day influences, from the original series. Seasonal adjustment does not aim to remove the irregular or non-seasonal influences which may be present in any particular month. These irregular influences may reflect both random economic events and difficulties of statistical recording. The international trade in goods and services on a balance of payments basis estimates are seasonally adjusted. The merchansdise exports and imports statistics on a recorded trade basis are not.

8 The month-to-month movements of the seasonally adjusted estimates may not be reliable indicators of trend behaviour because they include irregular or non-seasonal movements. Trend estimates are derived by applying a 13 -term Henderson moving average to the seasonally adjusted series. The use of a 13 -term Henderson average can result in revisions to the estimates for the most recent six months as additional observations become available. Revisions can also occur because of changes in the original data and as a result of the annual re-estimation of the seasonal factors.

9 In keeping with balance of payments conventions, where statistics are on a balance of payments basis, credit entries (exports) are shown without sign and debit items (imports) are shown as negative entries. For statistics on a recored trade basis, both imports and exports are shown without sign. The calculation of percentage changes on balance of payments debit items are made without regard to sign. References to balance of payments debit items in Key Figures, Key Points, and Analysis and Comments are also made without regard to sign.

10 For details of the classification used for goods exports on a balance of payments basis (credits), see table 6.6 in Balance of Payments and International Investment Position, Australia: Concepts, Sources and Methods, 1998 (cat.no.5331.0).

11 Details of the classification of goods imports on a balance of payments basis (debits) are provided in table 6.7 in cat. no. 5331.0. Most of the commodity groups shown in table 4 for goods debits are available for more detailed sub-groups from AusStats.

12 The recorded trade statistics shown in tables 7 and 8 are classified by the Standard International Trade Classification 2 (SITC). The first section of tables 7 and 8 show the most significant commodities (by value) at the SITC 3 digit level.

13 The quarterly detailed services data published in Table 6 are consistent with the monthly aggregates shown in Table 5. Services trade data by major partner countries and by Australian state of production/consumption are published on a financial year basis and a calendar year basis.
14 Monthly indicators for many of the services components that are only surveyed quarterly are not available. In particular, the Freight and Other transportation components of Total services credits are not available for publication on a monthly basis. The estimates for these items shown in table 5 are therefore derived by dividing the quarterly estimate by three.

15 More detailed balance of payments and recorded merchandise trade data, including forward seasonal factors, are available from AusStats. Very detailed merchandise trade data by commodity, country and state are available by contacting the National Information and Referral Service, as shown on the back of this publication.
