PREFACE

The Australian Bureau of Statistics has developed the Local Government Purpose Classification (LGPC) for use in the collection, analysis and dissemination of local government finance statistics in Australia.

The ABS has produced this classification in line with its commitment to develop and promote the use of standard definitions, classifications and coding procedures to help ensure the comparability of data derived from a range of statistical, administrative and services delivery systems.

There has been extensive consultation with external users during the development of the LGPC to ensure that the classification reflects the functions of local government in Australia and meets the data requirements of users of local government finance statistics.

In developing the LGPC, a principle aim has been to ensure alignment with international standards, namely the Classification of Functions of Government (COFOG) which is included in the System of National Accounts 1993 (SNA93), and the Classification of Environmental Protection Expenditure and Activities (CEPA). This will improve the international comparability of Australian local government finance statistics.

Emphasis has also been placed on aligning the classification with the existing national standard for all levels of government, the General Purpose Classification (GPC). This will ensure continuity of local government financial statistics, as well as comparability between levels of government.

INTRODUCTION

BACKGROUND	In 2000, the ABS conducted a review of local government finance statistics. Findings from this review identified a number of shortcomings in the collection and identification of key local government functions using the existing Government Purpose Classification (GPC). In particular, there were problems identifying transactions relating to environmental protection, recreation and cultural activities. While the GPC provides a national standard for transactions at all levels of government, a lack of detail on key local government functions resulted in inconsistent coding of data and subsequently, inconsistent output. In response to these findings, the ABS developed the Local Government Purpose Classification (LGPC) as a national standard for the collection, analysis and dissemination of local government finance transactions by purpose.
PURPOSE AND ROLE OF CLASSIFICATION	The purpose of any classification is to arrange specific data into ordered categories or groups useful for statistical analysis. Such categories or groups should be readily understood by users of the data.
	The LGPC provides a structure to classify a range of financial transactions, including outlays on final consumption expenditure, intermediate consumption, gross capital formation and capital and current transfers by local government. Data collected according to the LGPC will provide information about the programs and facilities on which local governments are spending their money, and this could feed into further analysis aimed at assessing the socio-economic effects of this expenditure.
	The data will also be useful in establishing trends in local government outlays on particular purposes over time. The units of classification are, in principle, individual transactions. This means that each purchase, wage payment, transfer, loan disbursement or other outlay should be assigned an LGPC code according to the function that the transaction serves.
	The role of the LGPC, therefore, is to provide a framework which affords local government authorities the ability to classify a range of financial transactions relevant to local government, making reporting easier and providing the consistent data required by the local government administrative bodies in state and territory governments. The classification will also be used to disseminate broad level aggregated data, mainly used by the ABS for the preparation of Government Finance Statistics (GFS) and the National Accounts.
STRUCTURE OF LGPC	The LGPC has a structure comprising categories at three levels, based on the international standard Classification of Functions of Government (COFOG).
	The first and most general level of the classification consists of nine broad divisions, each identified by a two-digit code. These broad divisions align with the corresponding divisions of the COFOG, with the exception of COFOG Division 02 Defence which is not relevant to local government. Division 02 is therefore omitted in the LGPC to maintain consistency with the COFOG in the numbering of divisions. At the division level, the

The second level of the classification consists of 41 groups, each represented by a 3 digit code.

The third and most detailed level of the classification consists of 86 classes, each represented by a four digit code. No group contains more than nine classes. In 26 instances, purpose groups consist of a single class, which is represented by the group code followed by zero. A nine appearing in the fourth digit position indicates a residual class. There are 11 residual classes. These classes do not constitute homogeneous purpose reporting, but rather diverse purposes which are not sufficiently significant to justify as a separate class. For the purposes of the classification they are grouped together and treated as a separate class to retain the homogeneity of the other items within the group.

The structure of the classification is demonstrated below with respect to the division General Public Services:

01 GENERAL PUBLIC SERVICES

011 Executive and legislative functions, financial and fiscal affairs

This group includes outlays on administration, operation and support of executive and legislative functions, and financial and fiscal affairs.

0111 Executive and legislative functions

This class involves outlays on the administration, operation and support of executive and legislative functions and all elements associated with corporate governance.

Exclusions / References

Public libraries, classified to LGPC 0824

- Office of the Mayor, chairperson and elected members of council.
- Libraries and other reference services serving mainly the Mayor, chairperson and elected members.
- Physical amenities provided to the head of council, the elected members and their aides.

CORRESPONDENCES	Correspondences (or concordances) between classifications demonstrate the relationship between the various categories within them, and subsequently, the degree of comparability in data classified to them.
	Correspondences at the class level between the LGPC and the COFOG, the LGPC and the CEPA and the LGPC and the GPC are shown in the Correspondences (page 46-58).
COFOG	The COFOG is an international classification of the functions of government, suitable for all levels of government. It was developed in conjunction with the 1993 revision to United Nations System of National Accounts (SNA93) and was revised in 1999. The structure and outline of the LGPC was developed from the COFOG so as to enable international comparability of data collected. Concepts, principles and definitions outlined in the COFOG for Divisions, Groups and Classes are paralleled by those used by the LGPC. However, the LGPC has been developed with respect to Australian local government authorities and characteristics of these are reflected in the classification.
CEPA	Division 5 of the LGPC, Environmental Protection, is closely aligned to the Classification of Environmental Protection Activities and Expenditure (CEPA) to achieve a comprehensive and internationally comparable picture of expenditure by governments on the environment. The CEPA is a generic multipurpose, functional classification for environmental protection used to classify actual outlays (expenditure) and other transactions. Some expenditure items will be transfers, such as subsidies or investment grants, whereas others will be inputs into an environmental protection activity, e.g. wages and salaries.

For example, overall planning and statistical services not connected to a specific function, development and implementation of Human Resource practices and policies, repairs and maintenance, motor pools, and archives not connected with libraries.

This group includes the administration of services to and operation of the agriculture and forestry industries.

0421 Agricultural water resources management

This class involves the administration regulation, planning, support and management of agricultural water resources.

Exclusions / References

Water supply, distribution, regulation and administration services, classified to LGPC 0630.

Primary Function

- Provision of land irrigation, rural drainage and flood mitigation systems
- Grants, loans and subsidies to farmers in connection with agricultural water resource management.

0422 Agriculture n.e.c.

This class involves the administration of services to and management of the agriculture industry.

Exclusions / References

- Multipurpose development projects, classified to LGPC 0465
- Subsidies for agricultural and grazing practices aimed at reducing harm to soils and water bodies, classified to LGPC 055
- Control of stray cattle and associated veterinary costs, classified to LGPC 0320.

Primary Function

- Administration of agricultural services
- Reclamation or expansion of arable land
- Land management, agrarian reform and land settlement
- Supervision and regulation of the agricultural industry; operation of flood control and irrigation systems
- Operation of support services to farmers including; veterinary services, pest control services, crop inspection and crop grading services
- Agricultural research
- Compensation, grants, loans and subsidies to farmers in connection with agricultural activities
- Veterinary medicine and animal husbandry costs connected to agricultural research
- Agrarian reform and land resettlement.

0423 Forestry

This class involves the administration of services to and management of the forestry industry.

Exclusions / References

Protection of biodiversity, e.g. schemes to protect flora, classified to LGPC 0540.

Primary Function

- Administration, regulation and operation of forestry affairs and services
- Operation and support of reforestation work, pest and disease control
- Forestry research
- Forest fire protection services.

043 Fuel and energy

This group includes the administration and operation of fuel and energy services.

0431 Gas

This class involves natural gas, liquefied petroleum gases and refinery gases, and the distribution of town gas regardless of its composition.

Exclusions / References

Transportation of gas, classified to the appropriate class within LGPC 044 or 045.

Primary Function

- Administration and operation of gas services
- Supervision and regulation of the distribution and use of gas
- Grants, loans and subsidies to support the gas industry.

0432 Electricity

This class involves both traditional sources of electricity such as thermal and hydro supplies and more recently developed sources such as wind and solar heat.

Exclusions / References

• Operation of non-electric energy services such as utilisation and distribution of heat in the form of solar heat, steam, hot water or hot air, classified to LGPC 0439.

Primary Function

- Conservation, development of electricity supplies
- Supervision and regulation of generation, transmission and distribution of electricity
- Construction and operation of non-enterprise-type electricity supply systems
- Grants, loans and subsidies to support electricity supply.

0439 Fuel and energy n.e.c.

This class involves operation of energy services such as coal, wood, alcohol and petroleum.

Exclusions / References

- Transportation of other fuel, classified to the appropriate class within LGPC 044 or 045
- Electric energy produced by wind or solar heat, classified to LGPC 0432.

Primary Function

- Operation of solid mineral fuel services including extraction, processing, distribution and use of solid mineral fuels
- Operation of services involving fuels such as coal, geothermal resources, petroleum, alcohol, wood and wood wastes, bagasse and other non-commercial fuels
- Operation of non-electric energy services such as utilisation and distribution of heat in the form of solar heat, steam, hot water or hot air
- Construction and operation of non-enterprise-type systems supplying non-electric energy
- Grants, loans and subsidies to provide industry or service support.

044 Road transport

This group includes all aspects of servicing and operating the road system, including maintenance, construction, rehabilitation and transport services.

0441 Road maintenance

This class involves all aspects of servicing and operating the road system, including road, shoulder and bridge maintenance.

Exclusions / References

- Reinstating failed road pavements to existing standards, classified to LGPC 0442
- Administration, regulation, installation, operation and maintenance of street lighting, classified to LGPC 0640
- Street sweeping and litter collection from roadsides and median strips, classified to LGPC 0519
- Maintenance of off-road recreation walkways or cycle paths, classified to LGPC 0814
- Establishment and maintenance of vegetation on roadsides, rest areas, median strips and other green roadside areas, classified to LGPC 0444.

Primary Function

- Operation, monitoring and servicing of the road system, including maintenance, repairs and operating costs of traffic lights, roadside furniture (e.g. signage) and drains, repainting of pavement markings, pavement condition monitoring and recording, etc
- Administration, supervision and operation of road pavement and shoulder maintenance, including pot hole repairs and minor patching, crack sealing, edge repairing, shoulder grading, resheeting of unsealed roads and thin asphalt overlays of sealed roads
- Administration, supervision and operation of bridge maintenance and repairs, including repainting and replacement of railings and decking.

0442 Road rehabilitation

This class involves reinstating failed road pavements to existing standards.

Exclusions / References

- Minor maintenance, such as patching and thin asphalt overlays, classified to LGPC 0441
- Operation and administration of improvements to standard design, classified to LGPC 0443
- Rehabilitation of off-road recreation walkways or cycle paths, classified to LGPC 0814.

Primary Function

 Administration, supervision and operation for reinstating failed road pavements to existing standards to improve the ride quality without improving the design standard, e.g. resheeting of sealed roads, reconstruction of failed pavements and major patching.

0443 Road construction

This class involves all aspects improving the design standard of existing roads and bridges, building new roads and bridges, installation of traffic lights and other extensions and improvements to road systems.

0443 Road construction continued

Exclusions / References

- Administration, regulation, installation, operation and maintenance of street lighting, classified to LGPC 0640
- Noise abatement works, classified to LGPC 0590
- Construction of off-road recreation walkways or cycle paths, classified to LGPC 0814
- Establishment and maintenance of vegetation on roadsides, rest areas, median strips and other green roadside areas, classified to LGPC 0444.

Primary Function

- Administration, supervision and operation for improving the design standard of existing roadways or providing new roadways, including road realignments, new auxiliary lances, road duplications, sealing of unsealed roads and new routes
- Administration, supervision and operation of improving existing bridges and culverts or providing new bridges and culverts, including construction of new of replacement bridges, and bridge duplications and widening
- Administration, supervision, maintenance and repairs of land acquisitions and earthworks associated with road improvements, including land acquisition costs associated with future road improvement projects, maintenance costs of acquired land and plant hire, depreciation, maintenance and repairs
- Administration and operation of other extensions and improvements to road systems, including project planning and design, surveying and project site establishment; provision of drainage facilities, road furniture and pedestrian facilities; and installation of new traffic lighting.

0444 Roadside vegetation

This class involves establishing and maintaining roadside vegetation, including roadsides, rest areas and median strips.

Exclusions / References

Establishment and maintenance of recreation parks and gardens, classified to LGPC 0814.

Primary Function

- Establishment and maintenance of roadside vegetation, including roadsides, rest areas, median strips and other green roadside areas
- Administration and supervision of activities relating to roadside vegetation.

0445 Bus transportation

This class involves administration and operation of bus services and bus transport systems and related infrastructure.

Exclusions / References

Bus transport for education purposes, classified to LGPC 0920.

- Administration and operation of services relating to use, construction and maintenance of bus services and bus transport systems
- Bus transport connected with the tourism industry

0445 Bus transportation continued

- Cleaning and maintenance of bus shelters and buildings
- Cleaning of bus transportation.

0446 Parking services

This class involves administration and operation of on and off street parking.

Exclusions / References

 Dedicated car parking facilities provided to the head of council, the elected members and their aides, classified to LGPC 0111.

Primary Function

- Construction, maintenance, administration and operation of on and off street parking facilities
- Research into design and efficiency of parking facilities
- Parking attendants and inspectors and the collection of fees and fines associated with parking.

0449 Road transport n.e.c.

This class involves all transport affairs and services not elsewhere classified to LGPC 044.

Exclusions / References

- Bus transportation for education services, classified to LGPC 0920
- Installation, operation, repair and maintenance of street lighting, classified to LGPC 0640
- Transport of waste products, classified to the appropriate class in LGPC 05
- Dedicated car parking facilities provided to the head of council, the elected members and their aides, classified to LGPC 0111.

Primary Function

 Administration, support and operation of general safety or traffic improvements and miscellaneous road transport activities.

045 Other transport services

This group includes administration, operation and supervision of transport services other than road transport.

0451 Water transport

This class involves administration, construction, regulation and operation of water transport facilities and services.

Exclusions / References

 Construction and maintenance of jetties, piers and wharves for use in recreational activities such as fishing and boating, classified to LGPC 0815.

Primary Function

 Administration, operation, use, construction and maintenance of inland, coastal and ocean water transport systems and facilities (harbours, docks, canals, bridges, tunnels, channels, breakwaters, piers, wharves, terminals) used for commercial enterprises

0451 Water transport continued

- Supervision and regulation of water transport users, including registration, licensing and inspection of vessels and crews, regulations concerning passenger safety and freight security
- Construction and operation of non-enterprise-type water transport systems and facilities (such as ferries)
- Grants, loans and subsidies to support the operation, construction, maintenance and upgrading of water transport systems and facilities.

0452 Air transport

This class involves administration, construction, regulation and operation of air transport facilities and services.

Exclusions / References

• Establishment and regulation of pollution standards, classified to relevant class in LGPC 05.

Primary Function

- Administration, operation, use, construction and maintenance of air transport systems and facilities, including airports, aerodromes, runways, terminals, hangars, navigation aids and equipment, air control amenities
- Inspection of aircraft, pilots, crews, ground crews, passenger safety, allocation of routes, approval of freight tariffs, passenger fares and frequency and level of service
- Construction and operation of non-enterprise-type public air transport services and facilities
- Grants, loans and subsidies to support the operation, construction, maintenance and upgrading of air transport systems and facilities
- Regulation and control of flying by private individuals.

0459 Transport systems n.e.c.

This class involves all transport affairs and services not elsewhere classified to LGPC 045.

Exclusions / References

Bus transport for education purposes, classified to LGPC 0920.

- Administration, operation, use, construction and maintenance of transport systems not elsewhere classified in LGPC 04, e.g. trams and tramways, monorail, light rail, etc
- Administration of services concerning operation, use, construction and maintenance of multi mode urban transit systems where individual elements (e.g. road transport, ferry transport) cannot be separately accounted for
- Supervision and regulation of users of multi-mode and other transport systems (registration, licensing, inspection of equipment, operator training, safety standards etc)
- Administration of affairs and services relating to the operation, use, construction and maintenance of pipeline systems
- Grants, loans and subsidies to support the operation, construction, maintenance and upgrading of multi-mode and other transport systems not classified in LGPC 045.

046 Other industries

This group includes administration, operation and supervision of all industries not elsewhere classified to LGPC 04.

0461 Mining of mineral resources (other than mineral fuels) and quarrying This class involves extracting metal-bearing minerals, sand, clay, stone, quarried materials, chemical and fertiliser minerals, salts, gemstones, asbestos, gypsum etc.

Exclusions / References

- Operation of energy services such as Coal, wood, alcohol and petroleum, classified to LGPC 0439
- Administration and operation of Gas services, classified to LGPC 0431.

Primary Function

- Administration and operation of mining, mineral resource and quarrying services
- Supervision, regulation of operations and marketing of output
- Inspections of operations and installations for safety regulations.

0462 Construction

This class involves administration, supervision, development and regulation of the construction industry.

Exclusions / References

 Grants, loans and subsidies for the construction of housing, industrial buildings, streets, public utilities, cultural facilities, etc., classified according to function, e.g. road construction classified to LGPC 0442.

Primary Function

- Supervision of the construction industry, building inspection and certification
- Issuance of certificates permitting occupancy, inspection of construction sites for safety regulations, e.g. certificates permitting driveways, house extensions, water bores etc.

0463 Distributive trades, storage and saleyards

This class involves administration, supervision and regulation of affairs and services concerning the distributive trades and the storage and warehouse industry. These include distribution and storage of agricultural produce, stock saleyards and related facilities.

Exclusions / References

Distribution of town gas, classified to LGPC 0431.

- Administration and operation of services concerning distributive trades, storage and warehousing industry, including storage of agricultural produce, stock saleyards and related facilities
- Production and dissemination of information to the trade and to the public relevant to these activities.

0464 Tourism

This class involves administration and operation of tourism services and promotion of tourism including liaison with transport, hotel and restaurant industries and other industries benefiting from the presence of tourists.

Exclusions / References

- Bus transport connected with tourism, classified to LGPC 0445.
- Administration, management, operation and support of caravan and camping grounds, classified to LGPC 0890.

Primary Function

- Operation of tourist offices.
- Advertising campaigns including production of promotional literature and signage.

0465 Multipurpose development projects

This class involves administration and operation of services concerning multipurpose development projects. Multipurpose development projects typically consist of integrated facilities for generation of power, flood control, irrigation and navigation.

Exclusions / References

 Construction of community centres and halls mainly used for recreation and cultural pursuits, classified to LGPC 0840.

Primary Function

- Administration of affairs and services concerning construction, extension, improvement, operation and maintenance of multipurpose developments
- Grants, loans and subsidies to support the construction, operation, maintenance or upgrading of multipurpose development projects.

0469 Other industries n.e.c.

This class involves administration and operation of services and regulation of other industries not elsewhere classified in LGPC 046.

Exclusions / References

General public services not connected with a specific function, classified to LGPC 0190.

- Administration and operation of services to and regulation of manufacturing industry.
- Administration and operation of services to and regulation of the communications industry.

053 Emissions and air pollution abatement and management

This group includes activities relating to the measurement and control of emissions and air pollution to protect air quality and climate.

0530 Emissions and air pollution abatement and management

This class involves activities aimed at reducing, treating and monitoring air pollutants and greenhouse gas emissions.

Exclusions / References

 Noise and vibration abatement, including all measures to monitor and control noise and vibration pollution, classified to LGPC 0590

Primary Function

- Administration, supervision, inspection, operation and support of activities relating to the protection of air quality and climate. Activities may include prevention of pollution through use of cleaner technologies or cleaner products, treatment of exhaust gases, or monitoring and control of the concentration of pollutants and air quality

Primary Function

0552 Decontamination of soil

This class involves measures and activities aimed at reducing the quantity of polluting materials in soil.

0552 Decontamination of soil continued

Prevention of pollutant infiltration, classified to LGPC 0551.

Primary Function

- Administration, supervision, inspection, operation and support of activities and measures to reduce the quantity of polluting materials in soil, either in situ or in installations, including separating, containing and recovering pollutant deposits; extracting buried casks and containers; and removing and treating polluted soil
- Grants, loans and subsidies to support the operation, construction, maintenance or upgrading of systems relating to the cleaning up of soil and water bodies.

0553 Restoration of water bodies

This class involves measures and activities aimed at reducing the quantity of polluting materials in groundwater and surface water such as rivers and lakes.

Primary Function

- Administration, supervision, inspection, operation and support of activities and measures to reduce the quantity of polluting materials in groundwater and surface water, either in situ or in installations, including decontaminating and cleaning up surface water following accidental pollution
- Grants, loans and subsidies to support the operation, construction, maintenance or upgrading of systems relating to the cleaning up of water bodies.

0554 Protection of soil from erosion, salinity and other physical degradation This class involves activities and measures aimed at the protection of soil from erosion, salinity and other physical degradation.

Exclusions / References

• Activities carried out for economic reasons, e.g. improved agricultural production, classified to LGPC 0421 or 0422.

Primary Function

- Administration, supervision, inspection, operation and support of activities and measures to protect soil from erosion, salinity and other degradation (compacting, encrusting). Activities may include programs intended to restore the protective vegetal covers of soil, construction of anti-erosion walls, actions to lower groundwater tables through revegetation, etc
