INTRODUCTION

This publication contains index numbers for copper materials used in the manufacture of three types of electrical equipment: Industrial electric motors, Distribution transformers, and Power transformers.

INDEX NUMBERS

Index numbers for financial years are simple averages of the quarterly index numbers. In cases where more complete information is obtained after index numbers for a period have been published, or it is discovered that incorrect prices have been used in compiling the indexes, revisions to index numbers may occur in subsequent issues of this publication. Each index is presented on a reference base of 1983-84 = 100.0.

IMPACT OF THE NEW TAX SYSTEM

The Goods and Services Tax (GST) will be excluded from all prices used in compiling the *Price Indexes of Copper Materials* from September quarter 2000. The introduction of the new tax system is not expected to have any first round impact on the indexes; however some downward influence is expected from second round effects.

EXPLANATORY NOTES

ITEMS AND WEIGHTS

1 These indexes are fixed weights indexes. The items included in the indexes were allocated weights in accordance with the estimated average values of copper material used in the manufacture of each type of equipment in 1982–83. The weights do not necessarily reflect the relative values of materials used by particular manufacturers.

PRICES

- **2** Prices are those charged by major manufacturers or distributors of copper materials to electrical equipment manufacturers for materials delivered into store. The prices used relate to materials of fixed specifications. For the manufacturing industry, both intermediate and capital inputs directly used in the manufacturing processes are exempt of wholesale sales tax.
- **3** The index for Industrial electric motors is intended to measure price movements of copper materials used in electric motors for industrial applications only. This index does not necessarily reflect the price movements of copper used in the manufacture of other smaller types of electric motors, such as those used as components in white goods or other domestic appliances.

ANALYSIS OF INDEX CHANGES

- **4** Care should be exercised when interpreting quarter-to-quarter movements in the indexes as short-term movements do not necessarily indicate changes in trend.
- **5** Movements in indexes from one period to another can be expressed either as changes in 'index points' or as percentage changes. The following example illustrates the method of calculating index points changes and percentage changes between any two periods:

Industrial electric motors index numbers -

June Qtr 2000	167.4	(see Table 1)
less June Qtr 1999	150.2	(see Table 1)
Change in index points	17.2	
Percentage change	17.2 150.2	x 100 = 11.5
