





# TREND ESTIMATES

- The trend estimate of turnover for the Australian Retail and Hospitality/Services series increased by 0.2% in March 2008. This follows an increase of 0.2% in February 2008 and a revised increase of 0.2% in January 2008.
- In March 2008, industries that had an increase in the trend estimate were Food retailing (+0.3%), Department stores (+0.2%), Recreational good retailing (+1.1%) and Other retailing (+0.6%). Household good retailing (-0.2%) and Hospitality and services (-0.3%)had a decline in the trend estimate.

### SEASONALLY ADJUSTED ESTIMATES

- The seasonally adjusted estimate of turnover for the Australian Retail and Hospitality/Services series increased by 0.5% in March 2008. This follows a decrease of 0.1% in February 2008 and a revised no change in January 2008.
- All industries, except Food retailing and Household good retailing (both +1.7%), had a decrease in the seasonally adjusted estimate in March 2008.

### **ORIGINAL ESTIMATES**

- In original terms, Australian turnover increased by 6.1% in March 2008 compared with February 2008. Chains and other large retailers (which are completely enumerated) increased by 8.9%, while the estimate for 'smaller' retailers (the sampled units) increased by 2.4%.
- Australian turnover increased by 3.0% in March 2008 compared with March 2007. Chains and other large retailers increased by 6.3%, while 'smaller' retailers decreased by 1.4%.

### **VOLUME MEASURES**

The trend volume measure of turnover increased by 0.9% in the March quarter 2008. This follows a 1.0% increase in the December quarter 2007. In seasonally adjusted terms, the volume measure decreased by 0.1% in the March quarter 2008.




TOTAL RETAIL

There has been weak trend growth for four months. Food retailing (five months) and Department stores (two months) have had weak growth. Household good retailing (four months) and Hospitality and services (three months) have had a decline in the trend estimate, while Recreational good retailing has had nine months of strong growth.




### FOOD RETAILING

There have been five months of weak trend growth. New South Wales and Tasmania have had a decline in the trend estimate for four months. Western Australia has had four months of weak trend growth. Victoria (four months), Queensland (six months), South Australia (three months) and Northern Territory (five months) have had moderate growth.




### DEPARTMENT STORES

There have been two months of weak trend growth. New South Wales, Victoria, Queensland and South Australia have had at least one month of weak trend growth. Western Australia has had a decline in the trend estimate for five months.




CLOTHING AND SOFT GOOD RETAILING There has been no change in the trend estimate for five months. Queensland (nine months) and Western Australia (four months) have had a decline in the trend estimate. Victoria and the Australian Capital Territory had no change in March 2008. South Australia (four months) and Tasmania (three months) have had moderate trend growth.




### HOUSEHOLD GOOD RETAILING

There has been a decline in the trend estimate for four months. Queensland (five months), Western Australia (11 months) and the Australian Capital Territory (16 months) have had a decline in the trend estimate. Victoria (two months) and the Northern Territory (four months) have had no change in the trend estimate. New South Wales has had weak trend growth for two months.




### RECREATIONAL GOOD RETAILING

There has been strong trend growth for nine months. Queensland (11 months), South Australia (three months), Western Australia (ten months) and the Northern Territory (six months) have had strong trend growth. After eight months of strong growth, New South Wales had moderate growth in March 2008.




### OTHER RETAILING

After eight months of strong trend growth, there have been two months of moderate growth. Queensland (12 months) and South Australia (ten months) have had strong growth. New South Wales (one month) and Victoria (three months) have had weak growth.




### TOTAL RETAIL (EXCLUDING HOSPITALITY AND SERVICES)

Over the last three months, the trend growth for Total retail (excluding Hospitality and services) has been slightly higher than that for Total industries (including Hospitality and services).



# SERVICES



# HOSPITALITY AND


NEW SOUTH WALES

There have been four months of weak trend growth. Food retailing has had a decline in the trend estimate for four months. All other industries, except Recreational good retailing which had moderate growth in March 2008, have had at least one month of weak trend growth.




#### VICTORIA

There have been three months of weak trend growth. Recreational good retailing and Hospitality and services have had a decline in the trend estimate for two months. Clothing and soft good retailing (one month) and Household good retailing (two months) have had no change. Department stores and Other retailing have had at least two months of weak trend growth.




### QUEENSLAND

There have been two months of weak trend growth. Clothing and soft good retailing (nine months), Household good retailing (five months) and Hospitality and services (six months) have had a decline in the trend estimate. Food retailing has had six months of moderate trend growth.




### SOUTH AUSTRALIA

There have been eight months of strong trend growth. Recreational good retailing (three months) and Other retailing (ten months) have had strong growth. After 13 months of strong growth, the Hospitality and services industry had moderate growth in March 2008. Food retailing (three months), Clothing and soft good retailing (four months) and Household good retailing (three months) have had moderate trend growth.




### WESTERN AUSTRALIA

There has been a decline in the trend estimate for four months. Department stores (five months), Clothing and soft good retailing (four months), Household good retailing (11 months) and Hospitality and services (five months) have had a decline in the trend estimate. Food retailing has had four months of weak trend growth.



#### TASMANIA

There have been four months of weak trend growth. Food retailing has had a decline in the trend estimate for four months. Recreational good retailing had no change in March 2008 after a decline in the trend estimate for nine months. Household good retailing (five months) and Hospitality and services (one month) have had strong trend growth.

## EXPLANATORY NOTES

INTRODUCTION	<b>1</b> This publication presents monthly estimates of the value of turnover of retail businesses classified by industry, and by state and territory. The principal objective of the series is to show month to month movement of turnover.
	<b>2</b> Estimates of turnover contained in this publication are compiled from the Retail Business survey. Following a new sample design introduced in the July 2007 reference month, the survey includes about 4,200 retail and selected service businesses. All 'large' businesses are included in the survey, while a sample of about 3,200 'smaller' businesses is selected. The 'large' business' contribution of approximately 57% of the total estimate ensures a highly reliable Australian total turnover estimate.
SCOPE AND COVERAGE	<b>3</b> The scope of the Retail Business survey is all employing businesses with at least one retail outlet. Like most Australian Bureau of Statistics (ABS) economic surveys, the frame used for the Retail Business survey is taken from the ABS Business Register which includes registrations to the Australian Taxation Office's (ATO) pay-as-you-go withholding (PAYGW) scheme. Each statistical unit (as defined below) included on the ABS Business Register is classified to the Australian and New Zealand Standard Industrial Classification (ANZSIC) industry in which it mainly operates. The frame is supplemented with information about businesses which are classified as non-retail but which have significant retail activity.
	<b>4</b> The frame is updated quarterly to take account of new businesses, businesses which have ceased employing, changes in industry and other general business changes. The estimates include an allowance for the time it takes a newly registered business to get on to the survey frame. Businesses which have ceased employing are identified when the ATO cancels their Australian Business Number (ABN) and/or PAYGW registration. In addition, businesses with less than 50 employees, and which do not remit under the PAYGW scheme in each of the previous five quarters are removed from the frame.

STATISTICAL UNITS DEFINED ON THE ABS BUSINESS REGISTER	<b>6</b> The ABS uses an economic statistics units model on the ABS Business Register to describe the characteristics of businesses, and the structural relationships between related businesses. The units model is also used to break groups of related businesses into relatively homogeneous components that can provide data to the ABS.
	7 In mid-2002, to better use the information available as a result of The New Tax System, the ABS changed its economic statistics units model. The new units model allocates businesses to one of two sub-populations. The vast majority of businesses are in what is called the ATO Maintained Population, while the remaining businesses are in the ABS Maintained Population. Together, these two sub-populations make up the ABS Business Register population.
ATO Maintained Population	<b>8</b> Most businesses and organisations in Australia need to obtain an ABN, and are then included on the ATO Australian Business Register. Most of these businesses have simple structures; therefore the unit registered for an ABN will satisfy ABS statistical requirements. For these businesses, the ABS has aligned its statistical units structure with the ABN unit. The businesses with simple structures constitute the ATO Maintained Population, and the ABN unit is used as the statistical unit for all economic collections.
ABS Maintained Population	9 For the population of businesses where the ABN unit is not suitable for ABS statistical requirements, the ABS maintains its own units structure through direct contact with each business. These businesses constitute the ABS Maintained Population. This population consists typically of large, complex and diverse businesses. The new statistical units model described below has been introduced to cover such businesses. Enterprise Group: This is a unit covering all the operations in Australia of one or more legal entities under common ownership and/or control. It covers all the operations in Australia of legal entities which are related in terms of the current Corporations Law (as amended by the <i>Corporations Legislation Amendment Act 1991</i> ), including legal entities such as companies, trusts, and partnerships. Majority ownership is not required for control to be exercised.

ABS Maintained Population Enterprise: The enterprise is an institutional unit comprising (i) a single legal entity or business continued entity, or (ii) more than one legal entity or business entity within the same Enterprise Group and in the same institutional subsector (i.e. they are all classified to a single Standard Institutional Sector Classification of Australia subsector). Type of Activity Unit (TAU): The TAU is comprised of one or more business entities, sub-entities or branches of a business entity within an Enterprise Group that can report production and employment data for similar economic activities. When a minimum set of data items are available, a TAU is created which covers all the operations within an industry subdivision (and the TAU is classified to the relevant subdivision of the ANZSIC). Where a business cannot supply adequate data for each industry, a TAU is formed which contains activity in more than one industry subdivision. **10** For more information on the impacts of the introduction of the new economic statistics units model, refer to Information Paper: Improvements in ABS Economic Statistics [Arising from the New Tax System] (cat. no. 1372.0). **11** Prior to the July 2002 reference month, the Retail Business survey used the management unit as the statistical unit. From the July 2002 reference month onwards, the statistical unit is the ABN unit for businesses with simple structures, and the TAU for businesses with complex structures. In most cases, ABN/TAU units concord with the management units previously used. SURVEY METHODOLOGY **12** The survey is conducted monthly by both telephone interview and a questionnaire mailed to businesses. The businesses included in the survey are selected by random sample from a frame stratified by state, industry and business size. Following the new sample design introduced in the July 2004 issue, the survey uses annualised turnover as the measure of business size. For the ATO Maintained Population, the annualised turnover is based on the ATO's Business Activity Statement item Total sales and for the ABS Maintained Population a modelled annualised turnover is used. For stratification purposes the annualised turnover allocated to each business is not updated each quarter as to do so would result in increased volatility in the estimates. **13** The July 2004 issue also saw the introduction of the generalised regression estimation methodology which replaced ratio estimation. For estimation purposes the annualised turnover allocated to each business is updated each quarter. The introduction of the new sample design and new estimation methodology resulted in changes to the level of the Retail Trade series. However, to facilitate comparisons over time, the historical series were revised to make the time series of estimates as continuous as possible. For more information about the changes introduced in the July 2004 issue refer to Information Paper: Changes to the Retail Trade Series (cat. no. 8501.0.55.002) which is available from the ABS web site <http://www.abs.gov.au>. **14** In the first month of each quarter, some businesses in the sample are replaced, at random, by other businesses so that the reporting load can be spread across smaller retailers. **15** Most businesses can provide turnover on a calendar month basis and this is how the data are presented. When businesses cannot provide turnover on a calendar month basis, the reported data and the period they relate to are used to estimate turnover for the calendar month. **16** Most retailers operate in a single state/territory. For this reason, estimates of turnover by state/territory are only collected from the larger retailers which are included in the survey each month. These retailers are asked to provide turnover for sales from each state/territory in which the business operates. Turnover for the smaller businesses is allocated to the state of their head office or main outlet.

### **EXPLANATORY** NOTES continued

### DEFINITION OF TURNOVER

**17** Turnover includes retail sales; wholesale sales; takings from repairs, meals and hiring of goods (except for rent, leasing and hiring of land and buildings); commissions from agency activity (e.g. commissions received from collecting dry cleaning, selling lottery tickets, etc.); and net takings from gaming machines etc. From July 2000, turnover includes the goods and services tax.

**18** Turnover presented in the Retail Trade series includes net proceeds from licensed gambling activities undertaken in the Hotels and licensed clubs industry. The impact of net proceeds from gambling on movements in the Retail Trade series was discussed in *Feature article: Contribution of gambling to retail estimates* included in the December 2002 issue of this publication. The article concluded that net proceeds from gambling had not had a significant impact on quarterly movements for the series but net proceeds from gambling had increased over time, and users should be aware of this when interpreting the series. Since September 2004, an electronic release, *Contribution of Gambling to Retail Estimates* (cat. no. 8501.0.55.003), has been providing updated quarterly information, but this has been discontinued as of June 2007, as the result of a user review of this product.

**SEASONAL ADJUSTMENT 19** Seasonally adjusted estimates are derived by estimating and removing systematic calendar related effects from the original series. In the Retail trade series, these calendar related effects are known as seasonal (e.g. increased spending in December as a result of Christmas) and trading day influences (arising from the varying length of each month and the varying number of Sundays, Mondays, Tuesdays, etc. in each month). Each influence is estimated by separate seasonal and trading day factors which, when combined, are referred to as the combined adjustment factors.

**20** The seasonally adjusted estimates also have an allowance for an Easter proximity effect, which is caused when Easter falls late in March or early in April. This effect, when present, is combined with the seasonal and trading day factors to form the combined adjustment factors. There is also a similar allowance for the variable timing of Father's Day. See the Appendix of the July 2001 and August 2002 issues respectively of this publication for more information.

**21** The Retail series uses a concurrent seasonal adjustment methodology to derive the combined adjustment factors. This means that data from the current month are used in estimating seasonal and trading day factors for the current and previous months. For more information see *Information Paper: Introduction of Concurrent Seasonal Adjustment into the Retail Trade Series* (cat. no. 8514.0).

**22** Concurrent adjustment can result in revisions each month to estimates for earlier periods. However, in most instances, the only noticeable revisions will be to the combined adjustment factors for the current month, the previous month and the same month a year ago. The following table shows how the combined adjustment factor for these months, at the total Australian Retail and Hospitality/Services level, evolved under the concurrent seasonal adjustment methodology. The table presents two different estimates of the combined adjustment factors. The first row gives the combined adjustment factors estimated following the last annual reanalysis in August 2007 using data up to and including the June 2007 reference month. The second row gives the most recent combined adjustment factors estimated and used in this month's calculation of the concurrent seasonally adjusted series.

**23** The revision properties of the seasonally adjusted and trend estimates can be improved by the use of autoregressive integrated moving average (ARIMA) modelling. ARIMA modelling relies on the characteristics of the series being analysed to project future period data. The projected values are temporary, intermediate values, that are only used internally to improve the estimation of the seasonal factors. The projected data do not affect the original estimates and are discarded at the end of the seasonal adjustment process. The retail collection uses ARIMA modelling where appropriate for individual time series. The ARIMA model is assessed as part of the annual reanalysis and following the 2006 annual reanalysis 95% of Retail series use an ARIMA model. For more information on the details of ARIMA modelling see *Feature article: Use of ARIMA modelling to reduce revisions* in the October 2004 issue of *Australian Economic Indicators* (cat. no. 1350.0).

**24** The seasonal adjustment methodology is able to produce combined adjustment factors for future months. The latest factors for some future months are shown in the following table. While these factors represent the best current estimate, the actual factors used for estimating the seasonally adjusted estimates in these months will differ because they will incorporate subsequent months' data as they become available.

**25** The seasonal and trading day factors are reviewed annually at a more detailed level than possible in the monthly processing cycle. The annual reanalysis will not normally result in significant changes. For Retail Trade, the results of the latest review are shown in the July 2007 issue.

**26** In the seasonal adjustment process, both the seasonal and trading day factors evolve over time to reflect changes in spending and trading patterns. Examples of this evolution include the slow move in spending from December to January; and, increased trading activity on weekends and public holidays. The seasonally adjusted estimates still reflect the sampling and non-sampling errors to which the original estimates are subject.

**27** A "two-dimensional reconciliation" methodology has been used on the seasonally adjusted time series in this publication to force additivity - that is, to force the sum of fine-level (state by industry) estimates to be equal to the relevant state and industry totals, and Australian total. This methodology was first implemented in the November 2006 publication, and in publications prior to November the total for a state or industry did not necessarily equal the sum of the component series. The new methodology has been implemented for all timepoints back to the beginning of all series. For further details on the methodology employed, contact < time.series.analysis@abs.gov.au>.

TREND ESTIMATES

**28** The monthly trend estimates are derived by applying a 13-term Henderson moving

	average to the seasonally adjusted estimates (7-term for quarterly series). The Henderson moving average is symmetric, but as the end of a time series is approached, asymmetric forms of the moving average have to be applied. The asymmetric moving averages have been tailored to suit the particular characteristics of individual series and enable trend estimates for recent periods to be produced. Estimates of the trend will be improved at the current end of the time series as additional observations become available. This improvement is due to the combined effect of the concurrent seasonal adjustment methodology and the application of different asymmetric moving averages for the most recent six months (or three quarters). As a result of the improvement, most revisions to the trend estimates will be observed for the most recent six months (or three quarters).
	<b>29</b> Trend estimates are used to analyse the underlying behaviour of the series over time. As a result of the introduction of The New Tax System, a break in the monthly trend series has been inserted between June and July 2000. Care should therefore be taken if comparisons span this period. For more details refer to the Appendix in the December 2000 issue of this publication.

CHAIN VOLUME MEASURES	<b>31</b> The chain volume measures of retail turnover appearing in the quarterly issue of this publication are annually reweighted chain Laspeyres indexes referenced to current price values in a chosen reference year. The reference year is advanced each September issue and is currently 2005–06. Each year's data in the Retail chain volume series are based on the prices of the previous year, except for the quarters of the latest incomplete year. Data for the 2007–08 financial year will initially be based upon price data for the 2005–06 financial year. Comparability with previous years is achieved by linking (or chaining) the series together to form a continuous time series. While current price estimates reflect both price and volume changes, chain volume estimates measure changes in value after the direct effects of price changes have been eliminated and hence only reflect volume changes. Further information on the nature and concepts of chain volume measures is contained in the ABS publication <i>Information Paper: Introduction of Chain Volume Measures in the Australian National Accounts</i> (cat. no. 5248.0).
RELIABILITY OF ESTIMATES	<ul> <li>32 There are two types of error possible in estimates of retail turnover:</li> <li><i>Sampling error</i> which occurs because a sample, rather than the entire population, is surveyed. One measure of the likely difference resulting from not including all establishments in the survey is given by the standard error, see below. Sampling error may be larger for the first month of each quarter, when some of the businesses in the sample are replaced by other businesses so that the reporting load can be spread across retailers.</li> <li><i>Non sampling error</i> which arises from inaccuracies in collecting, recording and processing the data. The most significant of these errors are: misreporting of data items; deficiencies in coverage; non-response; and processing errors. Every effort is made to minimise reporting error by the careful design of questionnaires, intensive training and supervision of interviewers, and efficient data processing procedures.</li> </ul>
STANDARD ERRORS	<b>33</b> Seasonally adjusted and trend estimates and chain volume measures are also subject to sampling variability. For seasonally adjusted estimates, the standard errors are approximately the same as for the original estimates. For trend estimates, the standard errors are likely to be smaller. For chain volume measures, the standard errors may be up to 10% higher than those for the corresponding current price estimates because of

the sampling variability contained in the prices data used to deflate the current price estimates.

**34** Estimates, in original terms, that have an estimated relative standard error (RSE) between 10% and 25% are annotated with the symbol '^'. These estimates should be used with caution as they are subject to sampling variability too high for some purposes. Estimates with an RSE between 25% and 50% are annotated with the symbol '\*', indicating that the estimates should be used with caution as they are subject to sampling variability too high for most practical purposes. Estimates with an RSE greater than 50% are annotated with the symbol '\*\*' indicating that the sampling variability causes the estimates to be considered too unreliable for general use.

**35** To further assist users in assessing the reliability of estimates, key data series has been given a grading of A to E. Where:

- A represents a relative standard error on level of less than 2%. The published estimates are highly reliable for movement analysis.
- B represents a relative standard error on level between 2% and 5%, meaning the estimate is reliable for movement analysis purposes.
- C represents a relative standard error on level between 5% and 10%, meaning users are advised to exercise some caution in interpreting movements for such series.
- D represents a relative standard error on level between 10% and 15% meaning users are advised to exercise caution in interpreting movements for such series.
- E represents a relative standard error on level greater than 15% (mainly affects unpublished state by industry series).

**36** The table below provides an indicator of reliability for key retail turnover estimates.



EFFECT OF NEW SEASONALLY ADJUSTED ESTIMATES ON TREND ESTIMATES

**1** The most recent trend estimates published in this release are likely to be revised when next month's seasonally adjusted estimates become available. To assist readers of this publication in analysing retail trends, the approximate effect of the two possible scenarios on the previous trend estimates of the percentage change in total retail turnover for Australia are presented below. For more information see the trend estimates section of the Explanatory Notes.

- 1 The April seasonally adjusted estimate of retail turnover is 1.0% higher than the March estimate.
- 2 The April seasonally adjusted estimate of retail turnover is 1.0% lower than the March estimate.



**2** Under concurrent seasonal adjustment, the most recent seasonally adjusted and trend estimates are likely to be revised when original estimates for subsequent months become available. The trend revision is a combined result of the revision of the seasonally adjusted estimates and the revision derived from the use of asymmetric moving averages as future data become available (for more information, refer to paragraph 28 in the Explanatory Notes). ABS research shows that about 75% of the total revision to the trend estimate at the current end of the time series is due to the use of different asymmetric moving averages when the original estimate for the next time period becomes available. To assess the reliability of the trend estimate at the current end, the 'what-if' chart presents trend estimates under two different scenarios of the next time period. The chart shows only the impact due to the changes of the asymmetric moving averages and does not include the unknown impact of revision to seasonal factor estimates that would arise when the original estimate for the next time period becomes available.
