

APRIL KEY POINTS

TREND ESTIMATES

- The trend series for total domestic sales of Australian produced wine increased in April 2001 to 31.9 million litres. This represents a 0.3% increase on March 2001 and a 6.9% increase on April 2000.
- The trend estimate for white table wine decreased 0.4% on March 2001 but increased 4.8% on April 2000.
- The trend estimate for red and rosé wine increased in April 2001 by 0.3% and by 12.1% on April 2000.

SEASONALLY ADJUSTED ESTIMATES

- The seasonally adjusted estimate for total sales of Australian produced wine was 32.6 million litres, up 4.5% on March 2001.
- The seasonally adjusted estimate for white table wine rose 4.4% on March 2001, while the estimate for red/rosé wine increased by 8.3%.

ORIGINAL ESTIMATES

- In original terms, 29.9 million litres of Australian produced wine was sold domestically during April, down by 5.2% on March 2001 but up by 14.3% on April 2000.
- Total Australian wine exports for April exceeded domestic wine sales by 2.4 million litres, in contrast to March when domestic wine sales exceeded wine exports by 4.1 million litres.

TABLE WINE, GLASS
CONTAINER < 2 LITRES

The trend estimate for white table wine sales in glass containers less than 2 litres is 5.3% higher than in April 2000 and 15.6% higher than in April 1998. This series has declined for seven consecutive months, falling 4.8% over that period. Red and rosé in glass containers less than 2 litres rose 8.4% on April 2000. This series has declined for five consecutive months (falling 4.2% overall), following a 9.6% rise over the previous five months.






TABLE WINE, SOFT PACK CONTAINERS

The trend series for sales of white table wine in soft packs has fallen 2.0% since October 2000 but is 2.2% higher than it was in April 2000. Similarly, the trend series for sales of red/rosé table wine in soft packs has fallen since October 2000 (by 4.2%) but is 1.0% higher than it was in April 2000.




TOTAL WHITE AND RED/ROSÉ TABLE WINE

The trend series for total white table wine rose by 4.8% over the last twelve months. The trend estimate for total red/rosé wine has increased 12.1% since April 2000.




EXPORTS OF AUSTRALIAN PRODUCED WINE

Original data for April 2001 shows exports of 32.3 million litres of Australian produced wine valued at \$171.4 million. The volume and value of exports are higher than the previous month by 17.7% and 12.9% respectively. In comparison with April 2000, wine exports have increased both in quantity and value by 38.5%. The average value of Australian wine exported in April 2001 was \$5.30 per litre, the same as April 2000. Exports to Europe and the Former USSR have increased by 60.8% since April 2000.



WINE IMPORTS CLEARED FOR HOME CONSUMPTION

Original data for April shows that 0.7 million litres of wine was imported, down 33.9% on March 2001 and down by 38.8% on April 2000. The average value of wine cleared for home consumption in April was \$6.31 per litre, up from \$5.23 per litre in April 2000.



DISPOSALS OF AUSTRALIAN PRODUCED WINE AND WINE AVAILABLE FOR CONSUMPTION IN AUSTRALIA

Original data for the March quarter 2001 shows that wine available for consumption in Australia increased 0.5% on the same quarter in 2000. Domestic sales of Australian produced wine increased 3.7% while wine imports decreased 46.8%. Total disposals of Australian produced wine increased 10.0% over the same period in 2000 with exports rising by 17.8%.

EXPLANATORY NOTES

INTRODUCTION

SCOPE AND COVERAGE

1 The information shown in this publication for the domestic sales of Australian produced wine is obtained directly from winemakers by means of a mail collection. The brandy sales figures shown represent quantities on which excise duty was paid, i.e. the quantity of brandy released for sale. Statistics relating to import clearances and exports are based on information provided to the Australian Customs Service by importers, exporters and their agents.

- **2** The information on domestic sales of Australian produced wine is obtained from winemaking enterprises with sales of 250,000 litres or more in the previous financial year. These account for approximately 97% of total wine sales. All sales data are collected on an Australia-wide basis only and State figures are therefore not available.
- **3** Tables 1–3 include all sales by winemakers (within the scope of the collection) with the exception of exports, sales for ships' stores, sales of imported wine and brandy and inter-winery sales, the last exclusion being necessary to avoid duplication in the published figures. From July 1998 the definition for table wine in the glass container categories changed from '1 litre and under' to 'less than 2 litres'. This series has been retained as the contribution of the over 1 litre but under 2 litres containers (such as table wine in magnum sized bottles) is believed to have been less than 1%. There is an expectation this contribution will increase in the future. This has a consequential effect for the 'other containers' category which includes glass containers 2 litres and over from July 1998 (prior to this it was glass over 1 litre). This series will also be retained.
- **4** From July 2000, the category 'Flavoured wine' has been changed to 'Other wine products'. This change reflects the inclusion of de-alcoholised, low and reduced alcohol wines in the category. These wine types were previously included in 'Table wine'. While it is expected that the effect on the 'Table wine' series resulting from this change will be insignificant, care should be taken in comparing 'Flavoured wine' with 'Other wine products'.

IMPORTS AND EXPORTS

- **5** Figures relating to international trade in wine and brandy are presented in tables 4–6 to provide a basis for assessing the overall wine market. Imports cleared for home consumption comprise those goods entered for home consumption, together with goods cleared from Customs warehouses. Exports of Australian produce are defined as exports of goods, materials or articles which have been produced, manufactured or partly manufactured in Australia.
- **6** The value of exports is the free on board (f.o.b.) transactions value of the goods expressed in Australian dollars. The ABS converts foreign currency f.o.b. values to Australian dollars using the exchange rate prevailing on the date of departure shown on the export manifest.
- **7** The value of imports is the Australian Customs value. Goods are valued at the point of containerisation (in most cases) or the port of shipment, or at the customs frontier of the exporting country, whichever comes first.
- **8** For further information on the compilation of Trade Statistics refer to explanatory notes contained in *International Merchandise Trade, Australia* (Cat. no. 5422.0).

EXPLANATORY NOTES

SEASONALLY ADJUSTED AND TREND ESTIMATES

- **9** Seasonal adjustment is a means of removing the estimated effects of normal seasonal variation from the series so that the effects of other influences can be more clearly recognised. Seasonal adjustment does not remove from the series the effect of irregular influences (e.g. abnormal weather and industrial disputes).
- **10** The seasonally adjusted estimates in this publication have been produced using a concurrent methodology whereby the seasonal factors are revised each month to take into account the seasonality exhibited by the latest observation. A more detailed review is conducted annually.
- **11** The overall degree of revision to the seasonally adjusted estimates is expected to be less on average than would be the case with annual reanalysis only. However, the nature of the seasonal adjustment process is such that the magnitude of some revisions resulting from each adjustment may be quite significant, especially towards the end of the series. For this reason additional care should be exercised when interpreting movements in seasonally adjusted data for recent months.
- **12** The smoothing of seasonally adjusted series to create trend estimates is a means of reducing the impact of the irregular component of the series. The trend estimates of wine sales have been derived by applying a 13–term Henderson weighted moving average to the seasonally adjusted series.
