Western Australia has the largest land area (2,532,400 square kilometres) of any Australian state or territory. Its coastline of 12,500 km amounts to 34% of Australia's total coastline.

The State's capital, Perth, was founded on 12 August 1829 and the Greater Perth area contains over three quarters (78%) of Western Australia's total population.
