## REPAIL SALPS OF GOODS : AUSMRALIA <br> MONTH OF APRIL 1068 (PROVISIONAL)

A provisional estimate of the total value of retail sales in Australia (excluding motor vehicles, parts, petrol, etc.) for the month of April 1968 is shown in the table overleaf. This table also contains figures for earlier months and seasonally adjusted statistics.
2.

Provisional monthly estimates are obtained from a sub-sample of establishments used to provide quarterly estimates of the value of retail sales. The sub-sample is designed to provide an estimate lying within a relatively small range above or below the true figure so as to give an early indication of trend. Undue significance should not be attached to very small movements or to the exact magnitude of any movements show by these provisional estimates. These estimates are subsequently adjusted in accordance with preliminary and final quarterly estimates as they become aveilable.
3.

Both the original series and the seasonally adjusted series are shown in the table overleaf. In the seascnal adjustment, account has been taken of both normal seasonal factors and "trading-day" effects (arising from the varying numbers of Sundays, Mondays, Tuesdays, etc. in the month). However, no adjustment has been made for the effects of movement in the date of Easter. Details of the methods used in seasonally adjusting these and other series are given in "Seasonally Adjusted Indicators 1968" issued on 21 May 1968.

Further information relating to the basis on which the statistics of retail sales of goods are compiled is contained in Statistical Bulletin "Retail Sales of Goods" December quarter 1967 of 17 April 1968.
