
- The 2026 Census question images in this document are the final design for the 2024 Test.
- The ABS has not decided on the topics that will be recommended to the Australian Government for inclusion, change or removal. The ABS will develop a final list of topics to recommend to the Australian Government in mid-2024. Following the Government decision on the 2026 Census topics, an amendment will be made to the Census and Statistics Regulation 2016. This will be tabled in both houses of the Australian Parliament.
- The ABS has the authority to determine the questions that are used to collect data on the topics listed in the Census and Statistics Regulation 2016. The ABS will determine the final question design for topics following analysis of data from the 2024 Test.












- Removal of 'male' and 'female'
- Inclusion of 'boy' and 'girl' in the response categories
- The online form also adjusts response options based on age of respondent.

During cognitive testing, the ABS observed that while many participants understand the distinction between the concepts of sex and gender, these was less understanding of the distinction between these concepts and sexual orientation and variations of sex characteristics. These concepts were often conflated for another. This resulted in several comments regarding the repetitiveness of the questions. The majority of LGBTIQ+ participants were supportive of the inclusion of the question.

These changes are the inclusion of instructional text to guide respondents on what 'Another term' includes and removal of the free text field for 'Another term'. The majority of LGBTIQ+ participants were supportive of the change to this question.

During cognitive testing, the ABS observed that while many participants understand the distinction between the concepts of sex and gender, these was less understanding of the distinction between these concepts and sexual orientation and variations of sex characteristics. These concepts were often conflated for another. This resulted in several comments regarding the repetitiveness of the questions.

## Next steps

The ABS tested five variations of the question for Sexual orientation, however the question design for the 2024 Test is closely aligned with the question in the Standard, with small adjustments to

simplify response options. The ABS is confident that this version of the question will work better in the Census context than the previous tested versions.

There are some remaining concerns regarding respondents finding the placement of the question on the paper form confusing (this placement is better than others tested), and participant understanding or support for the question, with the ABS needing to consider if the latter will impact overall response rates.

The majority of LGBTIQ+ participants were supportive of the inclusion of this question.

During cognitive testing, the ABS observed that while many participants understand the distinction between the concepts of sex and gender, these was less understanding of the distinction between these concepts and sexual orientation and variations of sex characteristics. These concepts were often conflated for another. This resulted in several comments regarding the repetitiveness of the questions.

## Outcomes of preliminary testing

The ABS currently has concerns around the effectiveness of a question to collect Variations of sex characteristics.

In every round, there have been concerns from test participants about what the question on Variations of sex characteristics is referring to, how to answer the question and/or discomfort with being asked. The ABS LGBTIQ+ Expert Advisory Committee subgroup has convened after each round of testing to support updates.

Updating the question wording from "Was [the person] born with..." to "Has [the person] been told they were born with..." and spelling out the acronym 'DSD' in the question wording improved the performance of the question for some respondents, however this did not fully address concerns for the broader population.



The ABS LGBTIQ+ Expert Advisory Committee subgroup advised against further changes to simplify this question as it increases the risk of people answering incorrectly.

During cognitive testing, the ABS observed that while many participants understand the distinction between the concepts of sex and gender, these was less understanding of the distinction between these concepts and sexual orientation and variations of sex characteristics. These concepts were often conflated for another. This resulted in several comments regarding the repetitiveness of the questions.

## Next steps

The ABS will continue to engage with key stakeholders, including the ABS LGBTIQ+ Expert Advisory Committee, to seek guidance on the design and testing of potential content for the 2026 Census.

Should the Government decide to include the topic of Variations of sex characteristics in the 2026 Census, the ABS will analyse the outcomes of the Test in September 2024 and engage with key stakeholders prior to deciding on the final question design for the 2026 Census.





#### **Background**

- The Government decides on the topics collected in the Census. These are specified in the Census and Statistics Regulation 2016 and tabled in both houses of the Australian Parliament.
- The ABS, under authority of the *Census and Statistics Act 1905*, decides the questions that are asked to collect data on all topics prescribed in the Regulation.
- There is limited capacity to add new topics without removing others. Capacity is limited by the space on the paper form, the burden on households and the cost of processing additional information.
- The ABS undertakes public consultation to ensure the Census reflects contemporary society and emerging data needs.
- The ABS considers requests for new or changed topics as well as reviewing existing topics
  against a set of criteria. These criteria have been informed by the United Nations Principles
  and Recommendations for Population and Housing Censuses. The criteria are:
  - 1. The topic is of current national importance.
  - 2. There is a need for data at the national level, and either the local level or for small population groups.
  - 3. There is likely to be a continuing need for data on the topic following the Census.
  - 4. There are no other suitable alternative data sources or solutions that could meet the topic need.
  - 5. Data on the topic can be collected efficiently.
  - 6. A representative of the household would be willing and able to answer questions on the topic for each member of the household.

#### **2026 Census Content Development Process**

#### **Key Issue**

On 12 December 2023, the ABS published the outcomes from the second phase of public consultation on topics for the 2026 Census, including the content changes still under consideration for addition, change or removal.

#### **Talking Points**

- The ABS has shortlisted 5 new topics and 12 existing topics to proceed to the
  development and testing stage of the topic review process. These topics are
  across a range of themes (<u>Attachment A</u>). Seven new topics are no longer
  being considered for the 2026 Census (Attachment B).
- The content changes that are still under consideration for inclusion in the 2026 Census provide the greatest public benefit when considered against the cost and complexity of data collection.



- The Census and Statistics Regulation 2016 prescribes the topics in the Census.
- The ABS has the authority under the *Census and Statistics Act 1905* to determine the questions that are used to collect data on the topics prescribed in the Regulation.



- Any changes to content included in the ABS recommendation to Government will have undergone sufficient initial testing to provide confidence they can be successfully implemented in the 2026 Census.
- The ABS considers requests for new or changed topics as well as existing topics against a set of criteria. These criteria have been informed by the United Nations Principles and Recommendations for Population and Housing Censuses. These criteria are:
  - 1. The topic is of current national importance.
  - 2. There is a need for data at the national level, and either the local level or for small population groups.
  - 3. There is likely to be a continuing need for data on the topic following the Census.
  - 4. There are no other suitable alternative data sources or solutions that could meet the topic need.
  - 5. Data on the topic can be collected efficiently.
  - 6. A representative of the household would be willing and able to answer questions on the topic for each member of the household.



• The ABS engages with a wide range of stakeholders throughout the topic review process. This has included establishing the LGBTIQ+ Expert Advisory Committee and consulting the ABS Round Table on Aboriginal and Torres Strait Islander Statistics.


- Following Government decision, the Census and Statistics Regulation 2016 will be amended and tabled in both houses of the Australian Parliament.
- Outcomes and topics to be included in the 2026 Census will be published on the ABS website in late 2025.

Population Sex Update question to specifically collect sex recorded at birth and update response categories to improve data quality.






#### **Complaint to the Australian Human Rights Commission**

#### **Key Issue**

The ABS is working with its newly formed LGBTIQ+ Expert Advisory Committee to test new topics about the LGBTIQ+ community for potential inclusion in the 2026 Census. This follows the successful resolution in August 2023 of an Australian Human Rights Commission (AHRC) complaint lodged against the ABS in relation to the 2021 Census.

#### **Talking Points**

- The ABS has established an Expert Advisory Committee of representatives of LGBTIQ+ community organisations and other experts for the 2026 Census. The committee will provide advice on topics and questions for the 2026 Census; educational materials, and the processing, analysis and dissemination of data obtained in the 2026 Census.
- The Expert Advisory Committee has met twice on 28 September and 1 December 2023.
- Subgroups with particular expertise have been formed and are providing
  advice during Census content testing for the four topics being considered for
  inclusion in the 2026 Census. These are sex at birth, gender, sexual
  orientation, and variations of sex characteristics. Additional subgroups will be
  formed in 2024 to support planning for the collection, processing and
  dissemination of any new data collected.

• The ABS will continue to refine the shortlist of potential content changes during the development and testing stage, prior to making a recommendation to Government for their decision in mid-2024.

#### **2026 Census Content Development Process**

#### **Key Issue**

The second phase of public consultation on 2026 Census topics concluded on 8 September 2023. The ABS is currently assessing which topics will be shortlisted and undergo testing.

#### **Talking Points**

- The ABS has undertaken two phases of public consultation on topics to be included in the 2026 Census of Population and Housing.
- The ABS released the findings from the first phase of consultation on 27 July 2023. Twenty-eight topics were shortlisted for potential inclusion or change, and four topics identified for potential removal (Attachment A).
- The ABS sought feedback on the shortlisted topics for inclusion, change or removal during the second phase of public consultation.
- The ABS considers a range of factors when undertaking its assessment of
  potential topics. This includes the need for the data, the overall length of the
  form, whether alternative data is available and the ability and willingness of
  the public to answer accurately.
- In late 2023, the ABS will publish the outcomes of the second phase of public consultation, including the topics that have proceeded to testing.
- The ABS will make recommendations on 2026 Census topics to the Australian Government in mid-2024.

#### **Background**

- The Census and Statistics Regulation 2016 prescribes the topics in the Census.
- There is limited capacity to add new topics without removing others. Capacity is limited by the space on the paper form and the cost of processing additional information.
- While several topics need to be collected every Census (most notably key demographic information), the ABS undertakes public consultation to ensure the Census reflects contemporary society and emerging data needs.
- The consultation process starts early in the Census cycle. This enables the ABS to obtain input from stakeholders, undertake testing and receive Government approval in time to meet operational requirements, such as printing of paper forms.
- The ABS has introduced a two-phase consultation approach for the 2026 Census to replace
  the single phase of consultation used for the 2021 Census. This increases public awareness
  and involvement earlier in the consultation process and allows the public multiple
  opportunities to provide input.
- The ABS engages with a wide range of stakeholders throughout the topic review process.
   This has included establishing an LGBTIQ+ Expert Advisory Committee and consulting the ABS Round Table on Aboriginal and Torres Strait Islander Statistics.
- The ABS considers requests for new or changed topics as well as existing topics against a set of criteria. These criteria have been informed by the United Nations Principles and Recommendations for Population and Housing Censuses.





• The 2021 Census allowed respondents to answer the sex question with the options of male, female, and non-binary sex. The 2021 Census did not include questions on gender identity or sexual orientation. An article providing analysis on non-binary sex responses in the 2021 Census was released on 27 September 2022. This analysis concluded that data collected from the non-binary sex category was not meaningful (it conflated gender, sexual orientation and variations of sex characteristics).

#### **Executive summary**

- This brief provides information on the process for finalising the 2026 Census topics ahead of a briefing on Wednesday 21 February 2024. It also provides an update on the ABS's current 2026 Census content directions (the previous update was provided in December 2023 in MS23-000052).
- The 2026 Census content is determined by:
  - Government decision on Census topics, specified in the Census and Statistics Regulation 2016 and tabled in both houses of the Australian Parliament.
  - o ABS decisions, under authority of the *Census and Statistics Act 1905*, to determine the questions that are used to collect data on the topics prescribed in the Regulation.
- Consistent with previous Censuses, the finalisation of the questionnaire for the public 2024 Major Census Test (by 1 March 2024) occurs in advance of ABS recommendations to Government (around May 2024) and the Government decision on Census topics (mid-2024). Also, the Government decision on Census topics occurs before the 2024 Major Census Test is conducted (10 September 2024). This timing is driven by immovable operational deadlines for the Census Test (updating the Census online form) and for the 2026 Census main event (printing of Census paper forms), alongside the timeline required for Government decision and updating of the Census Regulation.

**Consultation:** Two rounds of public consultation. Ongoing engagement with key stakeholders, including the ABS Round Table on Aboriginal and Torres Strait Islander Statistics and the ABS LGBTIQ+ Expert Advisory Committee, to inform question design and testing activities. Engagement with Department of Treasury on the process for updating *Census and Statistics Regulation 2016*.

- The 2024 Major Census Test is a critical activity as it provides the last opportunity to test the Census questions, and the Census questionnaire, before print deadlines. This allows the ABS to confirm that new questions collect data of the expected quality, or to guide further refinement to questions and their placement on the form. Given the timing of the 2024 Major Census Test and Government decisions, it is important that the ABS includes all Census topics in this Test that may be included in the 2026 Census to ensure these are adequately tested.
- The ABS has been conducting cognitive and focus group testing of potential new Census topics. Testing
  of Sexual orientation and Variations of sex characteristics has highlighted challenges and there is
  uncertainty whether these topics can be collected successfully in the 2026 Census. The ABS may
  ultimately decide not to recommend these topics to Government for inclusion in the 2026 Census.
- Public communication and discussion of changes to Census content is unlikely to distinguish between
  the Census topic changes determined by Government and the Census question decisions determined
  by the ABS. This brief includes the current ABS considerations of question changes to give you an
  understanding of the whole package of change under consideration.

#### **Key points**

- The ABS has undertaken a significant and expanded consultation process as part of the 2026 Census topic review. For the first time this has included two phases of public consultation. The ABS has published information after each phase of public consultation on the submissions received and the shortlist of topics under consideration.
- Since the ABS' last communication on the topic review process, <u>2026 Census topic review: Phase two</u> <u>directions</u>, the ABS has continued to refine the shortlist of potential 2026 Census content changes following initial testing activities (see Table 1). <u>Attachment A</u> provides detail on the status of each topic shortlisted for change in December 2023.

- (d) For some topics, the scope and/or number of changes considered has reduced following initial development and testing activities. This includes reduced scope to updates that improve the quality of data collected, as opposed to collecting new data.

- In this shortlist, the ABS has prioritised progressing new or enhanced content that meets priority data needs and will ensure that the Census is inclusive of all Australians. Consideration has also been given to the need for data comparability between Censuses, the burden on households and the available time and resources. The changes proposed are in keeping with the ABS plans to again deliver the Census at a reduced cost per capita than the previous Census.
- The ABS intends to include the topics in this shortlist in the 2024 Major Census Test, occurring in September 2024. The ABS needs to determine the content changes proceeding to the 2024 Major Census Test by 1 March 2024 to allow sufficient time for the implementation of changes into a secure electronic form for the test.
- The ABS currently has some concerns around the effectiveness of questions to collect Sexual orientation and Variations of sex characteristics. The ABS is continuing to explore options to improve question performance, and whether communication and engagement activities can address shortfalls, however, may ultimately decide to not recommend the inclusion of these topics in the 2026 Census. Even if a topic is not recommended for the 2026 Census, data from the 2024 Major Census Test will be an invaluable resource to further the development of these topics for future Censuses and other ABS and Government collections.



#### **Executive summary**

- This brief provides an update on the 2026 Census topic review process, including changes that the ABS is no longer considering and potential content changes still under investigation.
- The ABS will make a recommendation on the 2026 Census topics to the Australian Government in mid-2024.

#### **Key points**

- The ABS has refined the shortlist of content changes being considered for the 2026 Census. This is
  based on submissions from the second phase of public consultation, a preliminary assessment of
  collection feasibility, and initial focus group and cognitive interview testing.
- The refined shortlist includes five new topics, 12 enhancements to existing topics and four topics still being considered for removal at <a href="Attachment A">Attachment A</a>. The topic changes which are no longer being considered for the 2026 Census are included in <a href="Attachment B">Attachment B</a>.

• Based on its investigations to date, the ABS anticipates that the 2026 Census could have the largest enhancement to content since 2006. This reflects limited content change between 2006 and 2021, the increased value being realised from Census data through data linkage, and the need for the Census to be inclusive of all Australians. The ABS and Government need to balance the public benefit of changes against the cost of collection, the impact on data comparability between Censuses and the burden on Australian households completing the Census. Due to this, there are still topics with strong public value that are unable to be included in the 2026 Census.



 If the topics of Gender, Sexual orientation and/or Variations of sex characteristics are included in the 2026 Census, the ABS will request additional funding to implement a targeted engagement and communications campaign.<sup>2</sup>

- On Tuesday 12 December 2023, the ABS will release the outcomes of the second phase of public
  consultation and review, including the content changes still under consideration for inclusion, change
  or removal, and the intention to recommend the decennial collection of number of children ever born.
- The ABS will continue to refine the shortlist of potential content changes during the development and testing phase, prior to making a recommendation to Government in mid-2024.

#### **Background**

- The ABS conducted a two-phase consultation process on the topics to be included in the 2026 Census to ensure the 2026 Census reflects contemporary society and emerging data needs. Phase one provided the ABS with an understanding of information needed, but not currently collected. Phase two involved consultation on topics being considered for inclusion, change or removal.
- Following the first phase of consultation, the ABS assessed the public value of all topic requests and shortlisted 12 new topics and identified potential changes to 16 existing topics. Four existing topics were identified for potential removal from the 2026 Census.
- The ABS <u>published these outcomes</u> on the ABS website on 27 July 2023, and invited feedback on shortlisted topics during the second phase of consultation. You were briefed on the outcome of the first phase of public consultation on 25 July 2023 (MS23-000022).

- The second phase of public consultation closed on 8 September 2023. A total of 197 submissions were received. The ABS has also engaged extensively with key government and non-government stakeholders to clarify data needs where required.<sup>4</sup>
- Topics were then assessed as to whether the Census is the most appropriate mode of collection. The ABS then refined the shortlist of topics to those with the strongest case for inclusion or change when balancing public value and feasibility.
- ABS will make a recommendation on 2026 Census topics to the Australian Government in mid-2024.
   Any changes to content included in this recommendation will have undergone sufficient initial testing to provide confidence they can be successfully implemented in the 2026 Census. Following Government decision, the Census and Statistics Regulation 2016 will be amended and tabled in both houses of the Australian Parliament.
- The ABS has the authority under the *Census and Statistics Act 1905* to determine the questions that are used to collect data on the topics prescribed in the Regulation. Some enhancements being considered for the 2026 Census do not require a change to the topic in the Regulation. The ABS will engage the Australian Government Solicitor to determine whether an enhancement requires a change to the Regulation prior to making the recommendation to Government.



# **Executive summary**

- On Thursday 27 July 2023, the Australian Bureau of Statistics (ABS) will publish "2026 Census topic review Phase one directions". This publication provides a summary of the feedback received during the first phase of consultation and a list of new topics being considered for inclusion in the 2026 Census. It also lists existing topics where change is being considered and topics being considered for removal.
- The ABS will conduct phase two of the 2026 Census Topic consultation from Thursday 27 July until Friday 8 September 2023.

# **Key points**

The ABS assessment during phase one of the topic consultation has identified there is strong public
value for the inclusion of 12 new topics and to make changes to 16 existing topics. Four existing topics
have been identified for potential removal from the 2026 Census. The shortlisted topics are detailed in

# Issues/sensitivities

- The demand for new topics is greater than can be accommodated in the Census, so new topics need to
  be prioritised and existing topics considered for removal. The addition of new topics is limited by both
  the cost of inclusion and the burden and privacy concerns of households. Data users, community
  groups and the public will be disappointed to see some topics not be assessed for further
  consideration.
- There are more shortlisted topics for phase two consultation than the ABS will have capacity to test or
  include in the 2026 Census. There is a risk that expectations of these topics being included in the 2026
  Census will be raised by this process.
- Not including topics will cause concern for some people. Conversely, the inclusion of topics or changes
  to existing topics may also raise concerns in relation to privacy, loss of comparability of data, or beliefs
  of what should or should not be on the Census.

## **Background**

- The ABS is conducting a two-phase consultation process for the 2026 Census. This process involves the
  public earlier than the 2021 consultation process did and aims to increase transparency and public
  awareness, and to encourage broader participation. The ABS has published details on the review
  process on the ABS website.
- Phase one of the 2026 Census topic consultation was open from 28 February to 28 April 2023. This consultation invited submissions on information the public would like the ABS to collect in the Census.
- During phase one, the ABS also reviewed other input including 2021 submissions, correspondence received by the Australian Statistician and Ministers, feedback from other recent ABS consultations and statistical standard reviews, and recommendations from parliamentary inquiries.

- Existing topics and proposed new topics were reviewed against the <u>assessment criteria</u> on public value.
  The public value criteria consider national importance, the need for data for local levels or small population groups, and a continuing need for the data. Topics with high public value were then <u>assessed</u> as to whether the information need could be met from existing data sources.
- The addition of any new content to the Census needs to be carefully considered to ensure that the public benefit of the data outweighs the cost to the Australian taxpayer of developing the questions, collecting the data and then processing it. The ABS also needs to consider the burden on Australian households of answering additional questions, and whether a longer Census form will decrease the quality of the data collected.
- Including a new topic on the Census is a complex process and even if a topic has high public value this does not mean the Census will be the most appropriate mode of collection. Some topics are highlighted as having feasibility considerations due to interplay with other topics, sensitivity of the information or the absence of evidence on how to collect this topic.

- Phase two consultation aims to ensure that stakeholders (including the public) are aware of the 2026
   Census topic process and current topic consideration. It seeks views on topic directions and the impact of changes.
- Awareness and understanding during phase two will be supported by an information kit for Members
  of Parliament, social media promotion, a media release, distribution of radio release audio grabs, live
  webinar and ABS media spokespeople. The call to action will be to visit the ABS website and
  consultation hub to access further information and make a submission.
- The ABS will contact parties that provided submissions in phase one who requested to be kept
  informed of the process and subscribers to the email distribution list. The ABS will also engage directly
  with stakeholders, including meeting with the ABS Round Table on Aboriginal and Torres Strait Islander
  Statistics and the forming an advisory committee on Sex, Gender, Variations of Sex Characteristics and
  Sexual Orientation.
- During phase two, the ABS will assess topics against the same assessment criteria to determine whether data on the topic can be collected efficiently and whether a representative of a household would be willing and able to answer questions on the topic for each member of the household.
- In late 2023, the ABS will release the outcomes of phase two, including the topics recommended for removal and topics that have proceeded to testing. Not all topics that are tested will be recommended to the Australian Government for inclusion in the 2026 Census.



# Purpose of meeting

- To provide the ABS' LGBTIQ+ EAC with an opportunity to advise the Assistant Minister, the Hon Dr Andrew Leigh MP in advance of Government consideration of topics for the 2026 Census.

# **Key points**

- The ABS established the LGBTIQ+ EAC for the 2026 Census to support the Census being conducted in an inclusive manner and support the consideration of potential topic changes important to the LGBTIQ+ community. The establishment of the EAC also satisfied commitments made by the ABS in the resolution of a complaint to the Australian Human Rights Commission (AHRC) in relation to the 2021 Census. The EAC is co-chaired by Bindi Kindermann, General Manager, People and Place Statistics at the ABS and SATE LGBTIQ+ Health Australia.
- The Committee has met three times since its establishment in September 2023. Committee members have also attended subgroups in their fields of expertise to discuss the results arising from cognitive testing and potential adjustments to questions in subsequent testing rounds. The ABS has benefitted from this expertise and has valued the engagement of EAC members in this evidence-based process. Members have also assisted the ABS with recruiting participants through their networks.
- Following public consultation, the ABS has assessed the topics of gender, sexual orientation
  and variations of sex characteristics as each having strong public value for inclusion in the
  Census. The ABS has conducted testing of questions to collect data on these topics, as well as
  testing changes to the sex question to collect 'sex recorded at birth'. The ABS has also tested
  changes to other questions that are of interest to the EAC including relationships in the
  household and the country of birth of parents.

- The ABS is currently assessing whether gender, sexual orientation and variations of sex characteristics topics will be recommended to the Australian Government for inclusion in the 2026 Census. ABS recommendations are expected to be made in May 2024.
- You have agreed to meet with the LGBTIQ+ Expert Advisory Committee in relation to your responsibilities with topics for the 2026 Census. This was also a commitment in the resolution of the AHRC complaint.

# **Issues/sensitivities**

- The ABS used the questions in its Standard for sex, gender, variations of sex characteristics and sexual orientation variables as the starting point for cognitive testing for the Census. The Standard was updated in 2021 after extensive research, testing and consultation with an expert reference group. The Standard currently specifies that the questions for sexual orientation and variations of sex characteristics are appropriate for self-reporting only (i.e. a respondent should not be asked to respond on behalf of others). The Census relies on self-reporting, with the vast majority of responses received on a household form that is completed by one member of the household.
- Testing of sexual orientation and variations of sex characteristics highlighted challenges and there is uncertainty whether these topics can be collected successfully in the 2026 Census. Participants reported difficulty in understanding the questions, the concepts and/or the response options.
- Working with the EAC, changes have been made to the question on sexual orientation to simplify the response options. The ABS is confident that this will work better in the Census context than the previous tested versions. The EAC have advised against simplification of the question on variations of sex characteristics, as any simplification is considered likely to lead to increased levels of false positives and/or false negatives.
- The Standard specifies that as a guide, the recommended age for asking the sexual orientation
  question in general demographic collections is 15 years and older. The ABS's cognitive testing
  for the Census has been testing the question for sexual orientation with participants aged
  15 years and older, but has not yet determined if this will be the age recommended. The EAC
  will be consulted as part of this review.

 There are some concerns from EAC members on other questions in the Census including household relationships, marital status and country of birth of parents. The ABS is testing changes to all of these questions to make these more inclusive, however there are views that the changes have not gone far enough. Decisions on question wording are made by the ABS.

# **Background**

S<u>2</u>2

- The ABS established the LGBTIQ+ Expert Advisory Committee for the 2026 Census in September 2023. Membership is comprised of organisations and individuals, with expert knowledge of LGBTIQ+ issues across such domains as legal and human rights, health and families, and research methodologies for LGBTIQ+ populations. The ABS has been open to expressions of interest in joining the Committee from people with relevant skills, experience and/or knowledge.
- The ABS is considering international experiences of the collection of these variables in a
  Census context and is engaging with international counterparts throughout the topic
  development process. Comparable countries collected the following topics in their last Census:
  - New Zealand, 2023 Census: sex at birth, gender, sexual orientation, variations of sex characteristics (via individual form)
  - o Scotland, 2022 Census: sex, trans status, sexual orientation (via household form)
  - o Canada, 2021 Census: sex at birth, gender (via household form)
  - England and Wales, 2021 Census; sex at birth, gender, sexual orientation (via household form)
  - o **United States**, 2020 Census: sex (via household form).
- The 2021 Census allowed respondents to answer the sex question with the options of male, female, and non-binary sex. The 2021 Census did not include questions on gender or sexual orientation. An article providing analysis on non-binary sex responses in the 2021 Census was released on 27 September 2022. This analysis concluded that data collected from the non-binary sex category was not meaningful (it conflated gender, sexual orientation, and variations of sex characteristics).
- The ABS has used a set of criteria, based on international guidelines, to assess potential new
  or changed topics at each stage of the review process. This process identifies the topics that
  will provide the most value to the Australian community, while ensuring the Census is easy to
  complete and not seen as being too intrusive.

# Terms of Reference: LGBTIQ+ Expert Advisory Committee for the 2026 Census

# Purpose and scope

The 2026 Census LGBTIQ+ Expert Advisory Committee (Committee) provides advice to the ABS on collection, compilation and release of data relating to sex, gender identity, variations of sex characteristics and sexual orientation in the 2026 Census.

The Committee's views will be sought on the following areas, in relation to the LGBTIQ+ people and the 2026 Census:

- development and testing of proposed new or changed content, including development of question wording
- community consultation
- testing of Census content, questions and procedures
- respectful, safe and accessible language
- instructions, supporting guidance and educational materials
- the processing and analysis of data
- the dissemination of data collected.

# Membership

Members will be invited to participate to provide coverage across: the legal and human rights of LGBTIQ+ people; the families of LGBTIQ+ people; the health and wellbeing of LGBTIQ+ people; research methodology into LGBTIQ+ populations; and intersectionality and diversity within the LGBTIQ+ community.

Members must have experience in research, policy, program delivery, service provision and/or advocacy on issues related to LGBTIQ+ people. Individual representatives may also be included to provide personal perspective and lived experience.

The ABS intends for the Committee to exist until the first release of 2026 Census data, currently scheduled for June 2027.

The ABS may review the membership and role of the Committee to ensure the group continues to provide appropriate representation across regions and sectors. Advisors and observers may be invited to join as required.

Members who are representing an organisation and are unable to attend a meeting may nominate a delegate from within their organisation who meets the membership criteria to attend on their behalf by advising the Secretariat.

# Role of members

# Members are expected to:

- advise the ABS as set out under the 'Purpose and Scope' heading above
- act as representatives for their community/networks and consult with community (if relevant)
- review meeting materials prior to meetings
- actively contribute to the Committee's work at meetings
- treat material provided to the Committee as confidential unless advised otherwise
- facilitate broader communication and engagement between the ABS and stakeholders as required
- respond to issues out of session if requested
- advise the ABS of any existing or potential conflicts of interest<sup>1</sup> which may impact their role as a member of the Committee
- not undertake any media or communications activity related to the Committee without ABS permission
- where relevant, sign a deed of undertaking which outlines individual responsibilities when accessing sensitive or embargoed data/content.

# Role of the ABS

ABS staff will participate in the Committee with the intent of working in partnership with the community on matters that are important to the community, in particular in making the 2026 Census as inclusive and as valuable to the LGBTIQ+ community as possible. Using the language of the APS Framework for Engagement and Participation, ABS staff will look to work with the Committee to 'Deliberate' and 'Collaborate' on important issues, not just 'Share' and 'Consult'.

# The ABS will:

- present to the Committee on agenda items and respond to questions and requests for further information
- complete assigned action items
- consider advice and input from the Committee, provide members with regular feedback on where and how their advice has been incorporated in decisions and communicate reasons in instances where advice has not
- provide secretariat functions including preparing meeting agendas, session briefs and meeting minutes
- provide members with regular feedback throughout the Census process and consult at key points, including how we best engage with LGBTIQ+ communities on progress.

<sup>&</sup>lt;sup>1</sup> A conflict of interest is defined as any material or personal interest which could be, or could be perceived to be, in conflict with a member's role as part of the Committee (for example, if a Committee member is elected to represent a political party or elected politician). The ABS and the Chair will review conflicts of interest as they arise and determine the appropriate course of action.

# Administrative Arrangements

### Co-chairs

The Committee will be co-chaired by a representative of the ABS and a representative from the group.

# **Committee activity**

- The Terms of Reference and membership will be reviewed as required to ensure its validity and will be updated accordingly.
- Meetings of the Committee will generally be conducted virtually using Microsoft Teams. If / when
  meetings of the Committee are held in person, the ABS will make travel arrangements and meet the
  costs associated with travel.
- The Committee will convene as required in line with key Census project milestones.

# **Subgroups**

- Subgroups may be established where required. Each will comprise members with specific expertise in the work stream or overarching expertise relevant to the topic.
- Members will be notified of the creation of a subgroup and the opportunity to be involved.
- Members of any subgroups may be members of the Committee or may be separately invited to contribute their expertise.



The Sex, Gender and Families Statistics team will contact relevant members in the first instance for approval to pass on their contact details. Committee members are under no obligation to approve this request.

## **Process**

The ABS undertook a two-phase public consultation process to inform our recommendation on topics for the 2026 Census:

- Phase one: 28 February to 28 April 2023 understanding what information the public would like the ABS to collect on the Census.
- Phase two: 27 July to 8 September 2023 consultation on topics being considered for inclusion, change or removal from the 2026 Census. This considered public input from phase one.

On 12 December 2023, the ABS published outcomes from the second phase of consultation, including the topics that progressed to the next stage of the review process. Proposed content changes are tested using focus groups, cognitive interviews and a large-scale test.

The ABS will review testing outcomes and develop a final list of topics to recommend to the Australian Government in mid-2024. This will include potential new topics, changes to existing topics and topics with a lower relative priority that could be removed. Following the Government decision on the 2026 Census topics, an amendment will be made to the Census and Statistics Regulation 2016. This will be tabled in both houses of the Australian Parliament.

The ABS has the authority to determine the questions that are used to collect data on the topics included in the Census. Any question changes to existing topics will be sufficiently tested. This will provide confidence ahead of implementing them in the 2026 Census.

Outcomes and topics for the 2026 Census will be published on the ABS website in late 2025.



# For topics



<u>Sex at birth</u> – ABS have advised they will recommend topic retention. ABS have also advised they are testing a change to the question wording to specifically collect sex recorded at birth and update response categories to improve data quality.

<u>Gender, Sexual Orientation and Variations of sex characteristics</u> – ABS have advised that these topics are being tested due to the strong need for data. The ABS will review testing outcomes of each topic individually before deciding if that topic will be recommended for inclusion in the 2026 Census.
